Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hope Haven, Inc. 403(b) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Hope Haven, Inc. 403(b) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

Note A – Description of Plan

The following description of the Hope Haven, Inc. (the Company) 403(b) Retirement Plan (hereinafter referred to as the Plan) is provided for general purposes only. Participants should refer to the Plan’s summary plan description and plan document for more complete information.

General

The Plan is a defined contribution plan established by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the sponsor and administrator of the Plan. American Trust Company is the custodian of the Plan. The custodian provides recordkeeping services for the Plan.

Eligibility

All employees are eligible to make contributions to the Plan upon hire if they work more than 20 hours per week. Employees become eligible to receive employer matching contributions when employees of the Company have completed one year of service, which is equal to 1,000 hours, and have attained age 21 or older.

Contributions

Contributions are deducted from the employees’ paychecks, up to 100 percent of pretax annual compensation, limited to \$23,000 for 2024 and \$22,500 for 2023, due to Internal Revenue Code (IRC) requirements. The Plan also allows participants who are 50 years of age or older to contribute up to \$30,500 for 2024 and \$30,000 for 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Matching amounts are contributed by the Company up to 100% of the salary reduction contribution not exceeding 8% of compensation.

Participant Accounts

Each participant’s account is credited with the participant’s salary reduction contributions, catch-up contributions, rollover contributions, and allocation of Company matching contributions, allocations and Plan earnings. Contributions are based on participant earnings, as defined in the Plan and investment earnings based on the selected investment option or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching contribution portion of their accounts is based on their accounts is based on years of continuous service as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from 1 to 5 years. The loans are secured by the vested balance in the participant's account and bear interest at prime plus 2%. Interest rates ranged from 4.25 to 10.50 percent for 2024 and 2023. Principal and interest is paid ratably through biweekly payroll deductions.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either in a lump sum amount equal to the value of the participant's vested interest in his or her account, within a reasonable amount of time.

Forfeitures

A forfeiture occurs at the end of the year when a participant terminates his or her employment before reaching six years of service. Forfeitures are used to reduce future employer contributions. Employer contributions were reduced by \$0 and \$56,661 in 2024 and 2023. Forfeited nonvested accounts totaled \$62,256 and \$11,526 as of December 31, 2024 and 2023, respectively.

Administration of Plan Assets

The Plan's assets are administered under contract with American Trust Company, the custodian. The custodian invests funds received from contributions, investments sales, interest, and dividend income and makes distribution payments to participants.

Administration Expenses

All reasonable Plan administrative expenses including those involved in retaining professional services may be paid from assets of the Plan. These expenses may be allocated to all Plan participants, or for expenses directly related to one participant, charged against that participant's account balance. The Company may, at its discretion, pay a portion or all of these expenses.

Note B – Summary of Significant Accounting Policies

Preparation of the Financial Statements

The Plan prepares its financial statements in accordance with the Department of Labor's rules and regulations on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from the estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing the information provided by the investment advisers, custodians and insurance company. See note E for discussion of fair value measurements. Participant notes are valued at amortized cost

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid. There were no requests for withdrawal that were received before December 31, 2024 and 2023 that were not paid out.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants within the required time.

Note C - Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by American Trust Company.

Note D – Related-Party Transactions and Party in Interest Transactions

Certain Plan investments are managed by American Trust Company. American Trust Company is the trustee and record-keeper for the Plan and, therefore, these transactions qualify as party in interest transactions; however, they are exempt from the prohibited transaction rules under ERISA. Administrative fees paid by the Plan to American Trust Company, People's Bank and Retirement, LLC amount to \$140,428 and \$118,291 for the years ended December 31, 2024 and 2023, respectively.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officers or employees receive compensation from the Plan.

Note E – Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets.
- quoted prices for identical or similar assets or liabilities in inactive markets.
- inputs other than quoted prices that are observable for the asset or liability.
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Fund: Valued at net asset value (NAV) of one dollar per share

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note F – Tax Status

The IRS has determined and informed the Company by a letter dated March 2, 2007, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the US Department of Revenue. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note G – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

As of December 31, 2024 and 2023, the Plan had investments of \$12,439,244 and \$10,661,367, which were concentrated in two funds.

Note A – Description of Plan

The following description of the Hope Haven, Inc. (the Company) 403(b) Retirement Plan (hereinafter referred to as the Plan) is provided for general purposes only. Participants should refer to the Plan’s summary plan description and plan document for more complete information.

General

The Plan is a defined contribution plan established by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the sponsor and administrator of the Plan. American Trust Company is the custodian of the Plan. The custodian provides recordkeeping services for the Plan.

Eligibility

All employees are eligible to make contributions to the Plan upon hire if they work more than 20 hours per week. Employees become eligible to receive employer matching contributions when employees of the Company have completed one year of service, which is equal to 1,000 hours, and have attained age 21 or older.

Contributions

Contributions are deducted from the employees’ paychecks, up to 100 percent of pretax annual compensation, limited to \$23,000 for 2024 and \$22,500 for 2023, due to Internal Revenue Code (IRC) requirements. The Plan also allows participants who are 50 years of age or older to contribute up to \$30,500 for 2024 and \$30,000 for 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Matching amounts are contributed by the Company up to 100% of the salary reduction contribution not exceeding 8% of compensation.

Participant Accounts

Each participant’s account is credited with the participant’s salary reduction contributions, catch-up contributions, rollover contributions, and allocation of Company matching contributions, allocations and Plan earnings. Contributions are based on participant earnings, as defined in the Plan and investment earnings based on the selected investment option or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching contribution portion of their accounts is based on their accounts is based on years of continuous service as follows:

Note A – Description of Plan (Continued)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from 1 to 5 years. The loans are secured by the vested balance in the participant's account and bear interest at prime plus 2%. Interest rates ranged from 4.25 to 10.50 percent for 2024 and 2023. Principal and interest is paid ratably through biweekly payroll deductions.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either in a lump sum amount equal to the value of the participant's vested interest in his or her account, within a reasonable amount of time.

Forfeitures

A forfeiture occurs at the end of the year when a participant terminates his or her employment before reaching six years of service. Forfeitures are used to reduce future employer contributions. Employer contributions were reduced by \$0 and \$56,661 in 2024 and 2023. Forfeited nonvested accounts totaled \$62,256 and \$11,526 as of December 31, 2024 and 2023, respectively.

Administration of Plan Assets

The Plan's assets are administered under contract with American Trust Company, the custodian. The custodian invests funds received from contributions, investments sales, interest, and dividend income and makes distribution payments to participants.

Administration Expenses

All reasonable Plan administrative expenses including those involved in retaining professional services may be paid from assets of the Plan. These expenses may be allocated to all Plan participants, or for expenses directly related to one participant, charged against that participant's account balance. The Company may, at its discretion, pay a portion or all of these expenses.

Note B – Summary of Significant Accounting Policies

Preparation of the Financial Statements

The Plan prepares its financial statements in accordance with the Department of Labor's rules and regulations on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from the estimates.

Note B – Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing the information provided by the investment advisers, custodians and insurance company. See note E for discussion of fair value measurements. Participant notes are valued at amortized cost

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid. There were no requests for withdrawal that were received before December 31, 2024 and 2023 that were not paid out.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants within the required time.

Note C - Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by American Trust Company.

Note D – Related-Party Transactions and Party in Interest Transactions

Certain Plan investments are managed by American Trust Company. American Trust Company is the trustee and record-keeper for the Plan and, therefore, these transactions qualify as party in interest transactions; however, they are exempt from the prohibited transaction rules under ERISA. Administrative fees paid by the Plan to American Trust Company, People's Bank and Retirement, LLC amount to \$140,428 and \$118,291 for the years ended December 31, 2024 and 2023, respectively.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officers or employees receive compensation from the Plan.

Note E – Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets.
- quoted prices for identical or similar assets or liabilities in inactive markets.
- inputs other than quoted prices that are observable for the asset or liability.
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Fund: Valued at net asset value (NAV) of one dollar per share

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note F – Tax Status

The IRS has determined and informed the Company by a letter dated March 2, 2007, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the US Department of Revenue. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note G – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

As of December 31, 2024 and 2023, the Plan had investments of \$12,439,244 and \$10,661,367, which were concentrated in two funds.
