Opinion

We have audited the financial statements of Mass General Brigham Long-Term Disability Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

1. Description of Plan

General

The Mass General Brigham Long-Term Disability Plan (the Plan) provides long-term disability benefits and includes the Massachusetts General Hospital Long-Term Disability Plan (MGH LTD Plan) and the MGH Professional Staff Plan (MGH Prof Staff Plan). Mass General Brigham Incorporated (the Company) is the Plan Sponsor. The Plan does not modify the individual provisions of the MGH LTD Plan or the MGH Prof Staff Plan; however, for financial statement purposes, the assets and obligations of each such plan are combined and reported in one set of financial statements.

A Master Trust (the Master Trust) was established under Section 501(c)(9) of the Internal Revenue Code (IRC) to fund the benefits of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, MGH Prof Staff Plan was removed from the Plan.

The following descriptions of the MGH LTD Plan and MGH Prof Staff Plan provide only general information regarding the provisions of these plans. Participants should refer to their respective plan agreements for more complete information.

The MGH LTD Plan is a contributory defined benefit health and welfare plan that provides long-term disability benefits to eligible employees of the Company and to eligible employees of the following affiliates of the Company: The General Hospital Corporation (GH), The MGH Institute of Health Professions, Inc., The Spaulding Rehabilitation Hospital Corporation, Mass General Brigham Home Care, Inc., Spaulding Hospital-Cambridge, Inc. and Mass General Brigham Health Plan Holding Company, Inc. (collectively, the MGH LTD Plan Participating Employers).

Effective January 1, 2024, the MGH LTD Plan was amended to include Brigham and Women's Hospital, Inc. (BWH), and Brigham and Women's Physicians Organization, Inc. (BWPO).

The MGH Prof Staff Plan is a health and welfare plan that provides long-term disability benefits primarily to professional staff members of the Company and to professional staff members of the following affiliates of the Company: GH, Massachusetts General Physicians Organization, Inc., BWH, BWPO, North Shore Medical Center, Inc., Mass General Brigham Medical Group Northern Massachusetts, Inc. (formerly known as North Shore Physicians Group, Inc.), The McLean Hospital Corporation, Massachusetts Eye and Ear Infirmary, Martha's Vineyard Hospital, Inc., Newton-Wellesley Hospital and Mass General Brigham Medical Group, Inc. (collectively, the MGH Prof Staff Plan Participating Employers).

Contributions

The MGH LTD Plan is principally funded by after-tax employee contributions to the Plan from the MGH LTD Plan Participating Employers' employees through a salary deduction program as well as MGH LTD Plan Participating Employer contributions.

Effective January 1, 2024, the MGH LTD Plan was amended to align benefits for all participants. As a result, the MGH LTD Plan is principally funded by MGH LTD Plan Participating Employer contributions with an option to employees to buy-up additional coverage.

Notes to Financial Statements

Benefits

Substantially all employees of MGH LTD Plan Participating Employers and MGH Prof Staff Plan Participating Employers are eligible for their respective plans at date of hire. Benefits paid under the Plan are based on a percentage of the participant's earnings. Participants who become disabled receive monthly disability payments for each month disability continues beyond the applicable benefit waiting period, but for not more than the applicable maximum benefit period, as defined. The Plan Sponsor maintains the right to modify the benefits.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the accompanying financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the actuarial present value of accumulated plan benefits as of the benefit information date, the changes in net assets available for the benefits during the reporting period, and, when applicable, the disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The assets of the Plan are invested in the Master Trust. The fair value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's interest in the Master Trust, plus actual contributions and investment income, less actual distributions and expenses (investment manager fees).

Fair values of investments in the Master Trust are determined by reference to published market quotations or through the use of various valuation approaches, including market, income and cost approaches. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Disability Benefits

The MGH LTD Plan's long-term disability benefit obligations represent the actuarial present value of those estimated future benefits that are attributed to employee service rendered to December 31. Long-term disability benefits include future benefits to be paid for (1) currently disabled employees and their eligible dependents and (2) active employees and their eligible dependents after disability from service with the applicable MGH LTD Plan Participating Employer. Prior to an active employee's full eligibility date, the disability benefit obligation is that portion of the benefit obligation that is attributed to that employee's theoretical account balance at that valuation date.

Notes to Financial Statements

The actuarial present value of the expected long-term disability claims is determined by a consulting actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawals or retirement) between the valuation date and the expected date of payment.

Payments of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Plan's expenses are paid either by the Plan (through the Master Trust) or by the Plan Sponsor, as provided by the Massachusetts General Hospital Long-Term Disability Wrap Plan Document. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in the Master Trust investment income presented in the accompanying statement of changes in net assets available for benefits.

3. Interest in Master Trust

The assets of the Plan are pooled and invested in the Master Trust. The assets of the Master Trust are invested in commingled funds managed by State Street Bank and Trust Company (State Street).

At December 31, 2024 and 2023, the Plan had a 100% interest in the net assets of the Master Trust.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (also referred to as exit price). Therefore, a fair value measurement should be determined based on the assumptions that market participants would use in pricing the asset or liability. In determining fair value, the use of various valuation approaches, including market, income and cost approaches, is permitted.

Fair Value Hierarchy

A fair value hierarchy has been established based on whether the inputs to valuation techniques are observable or unobservable. Observable inputs reflect market data obtained from independent sources, while unobservable inputs reflect the reporting entity's assumptions about the inputs market participants would use. The fair value hierarchy requires the reporting entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. In addition, for hierarchy classification purposes, the reporting entity should not look through the form of an investment to the nature of the underlying securities held by an investee.

The hierarchy is described below:

Level 1: Valuations using quoted prices in active markets for identical assets or liabilities. Valuations of these products does not require a significant degree of judgment.

Level 2: Valuations using observable inputs other than Level 1 prices, such as quoted prices in active markets for similar assets or liabilities; quoted prices for identical or similar assets or liabilities in markets that are not active; broker or dealer quotations; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3: Valuations using unobservable inputs that are supported by little or no market activity and are significant to the fair value of the assets or liabilities.

Valuation Techniques

All investments classified within Level 1 or Level 2 of the fair value hierarchy are valued using quoted market prices, broker or dealer quotations or other observable pricing sources.

5. Benefit Obligations

6. Administrative Contracts

The Plan is administered by UnumProvident which performs all eligibility claims processing and check-writing functions in exchange for an administrative fee.

7. Transactions with Parties-in-Interest

ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. As State Street is the trustee and the custodian of the Plan, the investment transactions qualify as party-in-interest transactions.

8. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor reserves the right to terminate or amend the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, rights of participants to benefits are limited to claims incurred up to the date of termination and any balance remaining after satisfaction of all obligations under the Plan to the participants shall be applied for their benefits.

9. Tax Status

The Master Trust established under the Plan to hold the Plan's assets is intended to be exempt pursuant to the appropriate section of the IRC. The Master Trust has obtained an exemption letter from the Internal Revenue Service (IRS) dated September 1, 1988, in which the IRS stated that the design of the Plan was in compliance with the applicable requirements of the IRC. The Plan Sponsor believes that the Plan and Master Trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Sponsor believes that the Master Trust was tax-exempt as of the financial statement date. Accordingly, no provision for income tax has been recorded in the accompanying financial statements.

Accounting guidance requires the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has concluded there are no uncertain positions taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Sponsor believes it is no longer subject to examinations for years prior to 2021.

10. Risks and Uncertainties

The Master Trust invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the Plan balance and the amounts reported in the statements of net assets available for benefits.

The actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to valuation tables and discount rates, which are subject to change. Due to the uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

11. Nonexempt Transactions

During 2024, the Company inadvertently failed to deposit \$845,968 of participant contributions within the required time frame as stated by the United States Department of Labor (DOL) regulations. The Company calculated lost interest and will transfer calculated amounts to the Trust to correct this failure in 2025.

12. Subsequent Events

The Plan has assessed the impact of subsequent events through October 1, 2025, which is the date the financial statements were available for issuance. There were no such events that required adjustment to or disclosure in the notes to the audited financial statements.
