NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A – DESCRIPTION OF PLAN

The following description of the Whitaker Construction Co., Inc. 401(k) Plan provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

- 1) General – The Plan is a defined contribution plan covering all full-time employees. Participating employers include Whitaker Holdings Inc., Whitaker Construction Inc., Whitaker Transportation, LLC, Das-Co of Idaho, Inc., Bighorn Traffic Services, LLC and Advanced Cable Technology, LLC (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). For eligibility purposes, employees who have a minimum of four months of service and are age eighteen or older are eligible to enter on the first day of the plan year or the first day of the seventh month of the plan year, coincident with or next following satisfaction of the eligibility requirements.

The Plan is administered by a benefits committee (the Committee). The Committee has the power to carry out provisions of the Plan, including the administration of the Plan, and to determine the appropriateness of the Plan's investment offerings, and monitoring performance.

- 2) Contributions – Each plan year, participants may contribute up to the lesser of 100% of compensation or \$23,000 and \$22,500 for the years ending December 31, 2024 and 2023, respectively. In addition, any Participant, age 50 or older is eligible to contribute an additional \$7,500 for the years ending December 31, 2024 and 2023. Contributions are subject to certain limitations. A Participant can designate whether their elective contributions are made as pre-tax Section 401(k) Deferrals, after-tax Roth Deferrals or a combination of both types of contributions. Participants can also contribute amounts representing distributions from other qualified plans (rollover). A

matching and/or profit sharing contribution may also be contributed at the option of the Company's Board of Directors. During 2024, the Company made discretionary matching contributions of 50% of the first 6% of eligible compensation that a participant contributed to the Plan. The Company's Board of Directors has determined not to make a profit sharing contribution to this Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated age-based fund until changed by the participant.

The Plan includes an automatic increase of 1% per year to the default enrollment deferral rate, up to 10%.

- 3) Participant Accounts – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, (b) Plan earnings and (c) charged with allocations of investment and administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- 4) Vesting – Participants are immediately vested in their voluntary and rollover contributions plus actual earnings thereon. Vesting in the Company profit sharing and matching contributions portion of their accounts plus earnings thereon is based on a schedule of 20% each year after 2 years of service. A participant is 100% vested after 6 years of credited service.
- 5) Investment Options – Upon enrollment in the Plan, a participant may direct their deferral and employer contributions into any of the various investment funds offered by the Plan. Participants may change their investment options daily.
- 6) Payment of Benefits – Participants may elect to receive either a lump-sum amount equal to the value of their vested interest or annual installments as defined in the Plan document upon retirement, termination of service, death or disability. A terminated employee with a balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 can still be

automatically paid out if their balance is rolled into a qualified Individual Retirement Account. Distributions may be made at the participant's election prior to termination upon attainment of age 59 ½ or hardship as defined in the Plan document.

- 7) Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. A participant is allowed to have a maximum of three notes. The notes are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions or electronic fund transfers from participant accounts over a period not to exceed five years, unless the proceeds of the note were used to acquire the participant's residence, in which case the Plan administrator may permit a longer repayment term up to a maximum of thirty years.
- 8) Forfeitures – As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$144,447 and \$52,177, respectively. These amounts will be used to offset future employer contributions or pay plan expenses. During the year ending December 31, 2024, forfeited non-vested accounts of \$6,381 were used to pay administrative expenses of the Plan and \$435 were used to reduce employer matching contributions.

NOTE B – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting – The financial statements are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America.

Contributions – Participant contributions and the related Company matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants – Notes receivable from participants are reported at their unpaid principal balances plus any accrued interest remaining unpaid. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent notes receivable are reclassified as distributions upon the terms of the Plan document.

Investment Valuation and Income Recognition – The Plan’s investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements.

Estimates – The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Administrative Expenses – The Plan’s expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net asset available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Payment of Benefits – Benefits are recorded when paid. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid, at December 31, 2024 and 2023.

NOTE C – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2- Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3- Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts – Valued at fair value based on the net asset value (NAV) of units as determined by the insurance company. The NAV is based on the observable market prices of the underlying assets within the account less

liabilities. The NAV for the underlying assets of the account is a readily determinable measure of their fair value and is the basis for current transactions.

NOTE D – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a traditional fully benefit responsive guaranteed investment contract (GIC) with Minnesota Life Insurance Company. Minnesota Life Insurance Company maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the GIC with Minnesota Life Insurance Company is fully benefit-responsive, contract value is the relevant measure for the GIC, as this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value as reported to the Plan by Minnesota Life Insurance Company represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contract at December 31, 2024 and 2023 was \$2,473,871 and \$1,975,167, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%. Such interest rates are reviewed on an annual basis for resetting.

Certain events might limit the ability of the Plan to transact at contract value with the issuer and these events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include the following: (1) discontinuance of the contract by the Plan Administrator (2) the Plan is no longer deemed to be a "qualified plan" under Section 401 of the Internal Revenue Code or other section of the Code allowing similar tax treatment, (3) the Plan is terminated, or (4) there is a change in the Plan or in the benefits to be provided and it is necessary to amend or modify this contract, and the Plan administrator does not assent to the amendment or modification. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

NOTE E – TAX STATUS

The Plan uses a pre-approved plan document provided by Minnesota Life Insurance Company, which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by The Standard Insurance Company (the custodian of the Plan).

NOTE I – PARTY-IN-INTEREST TRANSACTIONS

As described in Note B, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

NOTE K – TRANSFERS INTO THE PLAN

During the year ended December 31, 2024, the vested portion of certain participants in the Whitaker Construction ESOP were segregated as cash and transferred into the Plan. The amount of these transfers totaled \$432,575 during the year ended December 31, 2024.

NOTE L – PLAN AMENDMENT

During the year ended December 31, 2024, the Plan was amended to increase the maximum automatic escalation deferral rate to 10% from 6%.

NOTE M – SUBSEQUENT EVENTS

The Plan Sponsor has evaluated subsequent events through October 2, 2025, the date which the financial statements were available to be issued.

The Plan Sponsor has decided to transition the plan third-party administration and custodian services from The Standard to Voya. It is anticipated that this transition will take place on November 30, 2025.
