Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the International U.A.W. Staff Severance Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).


Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements


Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Misstatements are considered material if there is a substantial likelihood that, individually or in the

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.


Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matters - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplemental information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule,



other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the International U.A.W. Staff Severance Plan (the Plan) provides only general information. Participants should refer to the Plan Document, as amended, for a more complete description of the Plan's provisions.

General - The Plan is intended to qualify under Internal Revenue Code (IRC) Section 401(a), to contain a qualified cash or deferred arrangement, as defined in IRC Section 401(k). Effective January 1, 2001, the Plan was converted from a money purchase pension plan to a "profit-sharing plan", as such terms are used under the IRC. Participants are all permanent, salaried U.S. Staff members. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions - Each participant who is an employee may make voluntary contributions to this Plan, which are limited to 100% of salary up to annual amount set by the Internal Revenue Service (IRS). Catch-up contributions, Roth contributions, Roth-catch up contributions, bonus contributions, and rollover contributions may also be made. The employer shall contribute 4% of each participant's salary with respect to all pay periods after January 3, 2010. In addition, the employer shall contribute to the Plan, at regular intervals not less frequently than quarterly, at a rate of \$1.00 per hour, allocated on the basis of a 5-day/52-hour work week, qualified non-elective contributions, with respect to all pay periods beginning on or after June 1, 2010 for participants hired on or after June 2, 2008. All contributions are credited to individual participant accounts when received by Fidelity Management Trust Company.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of the employer's contributions and fund earnings and charged with an allocation of administrative expenses. Participants in the Plan have the option to direct how their individual accounts are invested with Fidelity Management Trust Company. The Plan's self-directed features are intended to comply with ERISA Section 404(c), and the regulations that apply under that law.

Vesting - Participants are immediately vested in employer and their contributions plus actual earnings thereon.

Administrative Expenses - Substantially all administrative expenses are paid by the employer.



NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Payment of Benefits - Upon termination of service, benefits may be paid either as lump sum, monthly annuity, or annual payments. In the case of death prior to termination of employment, the benefit is payable as a lump sum to the designated beneficiaries. Further restrictions apply to these payment methods, these restrictions are listed in the Plan Document.

Participant Loans Receivable - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, 50% of their balance, or the amount the participant has contributed to the fund. No more than two loans may be obtained in any calendar year and no more than five loans relating to a participant may be outstanding at any one time. The loans are secured by the balance in the participant's account and bear interest rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements have been prepared using the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are carried at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price).

Purchases and sales of investments are recognized on a trade-date basis. Interest income is recognized on the accrual basis. Dividend income is recognized on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Participant Loans Receivable - Participant loans receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant loan receivable is recorded as a benefit payment based on the terms of the Plan Document.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payment of Benefits - Benefits are recorded when paid or when a deemed distribution has occurred.

NOTE 3. TERMINATION OF THE PLAN

In the event of termination or partial termination of the Plan, the accrued benefits of all participants shall become fully vested and nonforfeitable and the plan administrator may continue the Plan and pay accrued benefits when due or distribute the assets of the Plan to all participants, former or retired participants, or their beneficiaries in proportion to their respective accrued benefits.

NOTE 4. TAX STATUS

The Plan is qualified pursuant to Section 401 (a) of the IRC and is, therefore, exempt from federal income taxes under the provisions of 501 (a). On September 17, 2014, the Plan received a favorable determination letter from the IRS and the plan administrator believes the Plan, as amended, continues to qualify and to operate in accordance with applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. As of December 31, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. At December 31, 2024, the Plan is no longer subject to income tax examinations for years prior to the fiscal year ended December 31, 2021.

NOTE 5. BANK CERTIFICATION OF CERTAIN DATA

Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosing under ERISA permits that a bank which holds the assets of a pension plan may certify to the accuracy and completeness of certain financial information and other disclosures required by ERISA. The following information included in the financial statements and supplemental schedule was obtained from data included in the 2024 and 2023 trustee reports that Fidelity Management Trust Company has certified to the best of its knowledge and belief to be accurate and complete.

NOTE 6. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

NOTE 6. FAIR VALUE MEASUREMENTS (CONTINUED)

Money market funds and registered investment companies: Value is determined based on the closing price reported in the active market in which the individual assets are traded.

Investments measured at net asset value - common collective trust: Value is determined based on the net asset value (NAV) of the value of the shares held by the Plan at year end as reported by the custodian of the trust. NAV is calculated based on the fair value of the underlying securities held by the trust on the date of the valuation.

NOTE 7. FAIR VALUE OF INVESTMENTS THAT CALCULATE NET ASSET VALUE

Authoritative guidance on fair value measurements permits the Plan to measure the fair value of an investment entity that does not have a readily determinable fair value based upon the NAV or its equivalent of the investment. This guidance does not apply if it is probable that the investment will be sold at a value different than NAV.

The Plan's investment in investment entities is subject to the terms of the respective private placement memoranda and governing agreements. Income or loss from investments in these investment entities is net of the Plan's proportionate share of fees and expenses incurred or charged by these investment entities. To diversify its investment risk, the Plan

looked for different investment vehicles where the return did not necessarily correlate to general market returns as what was previously invested.

The Plan's risk of loss in these entities is limited to its investment. The Plan may increase or decrease its level of investment in these entities at its discretion. The Plan has the ability to redeem its investment from these entities on a daily basis.

NOTE 8. TRANSFER OF ASSETS FROM OPEIU LOCAL 494 – U.A.W. EMPLOYEES 401(K) PLAN

During the year ended December 31, 2024, the Plan received assets totaling \$-0- from the OPEIU Local 494 – U.A.W. Employees 401(k) Plan. This transfer represented accounts of those active participants which are no longer eligible to participate in the OPEIU Local 494 – U.A.W. Employees 401(k) Plan but are eligible to participate in this Plan due to changes in their employment status with the International Union U.A.W.

NOTE 9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan invests in registered investment companies managed by Fidelity Management Trust company. Fidelity Management Trust Company is the trustee of the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan to Fidelity Management Trust Company were \$3,525 and \$2,225, respectively, for the years ended December 31, 2024 and 2023. In addition, the Plan paid investment consulting fees to another service provider. All of these party in interest transactions are exempt from the prohibited transaction rules of ERISA.



NOTE 11. SUBSEQUENT EVENTS

Subsequent events have been evaluated through September 22, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.
