#### NOTE A - PLAN DESCRIPTION

The following is a brief description of the PurposeBuilt Brands 401(k) Plan, previously the Weiman Products, LLC 401(k) Profit Sharing Plan, provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### **General**

The Plan is a profit-sharing plan with the opportunity to save for retirement on a tax-advantage basis covering substantially all employees of PurposeBuilt Brands (Plan Sponsor, or Company). The Plan is a qualified plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

##### **Participation and Contributions**

An employee is eligible to participate on the first day of the month following one month of employment and attainment of age 18. Participants may elect to defer up to 100% of their pre-tax or post-tax annual compensation through wage deferral, not to exceed the maximum amount allowed under the Internal Revenue Code (IRC). The Plan currently offers a variety of investment options for participants, which are all fully participant directed. Participants may change their investment options daily.

The Company may make a discretionary matching contribution equal to a uniform percentage or dollar amount of the elective deferrals each Plan year. Each year, the Company will determine the formula for the discretionary matching contribution. Participants are eligible to receive discretionary matching applied every pay period. Participants always share in the discretionary matching contribution regardless of the hours of service in the current year, and even if terminated during the year.

For the year ended December 31, 2024, the discretionary matching contribution is equal to 50% up to 6% of the participant's contributions for the year. Matching contributions are remitted to the Plan on a pay period basis with a true up at the end of the year. The discretionary matching contribution totaled \$760,670 for the year ended 2024.

The Company may also elect to make a discretionary profit-sharing contribution to the Plan. The profit-sharing contribution is allocated among eligible participants based on the participant's share of the total compensation of all eligible participants in the Plan. For the year ended December 31, 2024 profit-sharing contributions were \$0.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions, if any, and an allocation of the Company's contributions and Plan earnings (losses) and trust fees. Allocations are based on participant compensation or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting of Benefits**

Participants are immediately vested in their rollover and elective deferrals, including catch-up contributions. Effective February 1, 2022, vesting in the Company's discretionary contribution and earnings thereon vest under a graded vesting schedule, becoming 33% vested after one continuous year of service, 66% vested after two continuous years of service until 100% vested after three years of continuous service. For the period of January 2022, vesting in the Company's discretionary contributions and earnings thereon vest under a graded vesting schedule, becoming 20% vested after two continuous years of service until 100% vested after six years of continuous service.

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 and may have two outstanding loans at a time. Loan terms range from one to five years. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined semiannually by the record keeper. Interest rates range from 4.25% to 9.50% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

#### ***Benefits***

Upon retirement or disability, participants shall be entitled to receive, as benefits, the entire amount credited to their accounts as of that date. Upon death, a participant's designated beneficiary shall receive the balance in the account. Participants may also be eligible for hardship or in-service distributions in accordance with the Plan agreement.

Participants whose employment terminates for reasons other than retirement, disability or death shall be entitled to receive the vested portion of their account balances in a lump sum in accordance with Plan provisions.

#### ***Forfeiture Allocation***

At December 31, 2024 and 2023, forfeited non-vested Company matching accounts were \$76,200 and \$96,200, respectively. Forfeitures may be used to reduce future employer contributions or may be used to pay Plan expenses. For the year ended December 31, 2024, Company contributions were reduced by \$73,000 from forfeited non-vested Company matching accounts.

#### ***Administration***

Fidelity Investments is the directed trustee of the Plan. Fidelity Investments holds the Plan's assets and functions as the Plan's custodian.

#### ***Plan Termination***

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to certain collective bargaining agreements and the provisions of ERISA. In event of termination of the Plan, the account balances of all affected participants shall become fully vested and non-forfeitable.

### **NOTE B - SIGNIFICANT ACCOUNTING POLICIES**

The Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements are as follows:

#### ***Basis of Accounting***

The financial statements of the Plan are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### ***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are held by the custodian and are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Administrative Expenses***

The Plan pays certain administrative costs and are expensed when incurred. Other expenses are paid by the Plan Sponsor.

### **NOTE C - FAIR VALUE MEASUREMENTS**

There is a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds* - Valued based on quoted prices of the fund in active markets.

*Self-Directed Brokerage Account* - The self-directed brokerage account is an investment service provided by Fidelity that provides participants with an expanded number of investment options. Participants in the self-directed brokerage account can direct their assets into stock listed on the major United States exchanges, bonds and other fund income investments, exchange traded funds, and mutual funds from various fund companies. Any investments that trade on an active market (i.e., stock, government security, corporate debt instruments, etc.) are leveled within the fair value hierarchy as Level 1 instruments.

*Stable Value Fund* - Valued at net asset value (NAV) based on information reported by the investment advisor using the audited financial statements of the trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

*Money Market Funds* - Valued at NAV of \$1.00 per share held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE D - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to the participants' accounts shall become 100% vested and all unallocated amounts shall be allocated to the accounts of all participants.

#### NOTE E - INCOME TAX STATUS

The Plan has received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2014, stating that the written form of the underlying non-standardized prototype plan document is qualified under Section 401(a) of the IRC, and that any employer adopting this form of the plan will be considered to have a plan qualified under Section 401(a) of the IRC. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has since been amended, but the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE F - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Fidelity Investments is the record keeper of the Plan. Fidelity Investments is the directed trustee of the Plan. Fidelity Investments holds the Plan's assets and functions as the Plan's custodian. Certain Plan investments are managed by the custodian and, therefore, qualify as party-in-interest transactions.

Notes receivable from participants are also considered party-in-interest transactions.

#### NOTE G - INFORMATION CERTIFIED BY TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103 8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee has certified that the following data included in the financial statements and supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.

**NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE I - SUBSEQUENT EVENTS**

PurposeBuilt Brands acquired PF Harris Manufacturing effective August 1, 2024 as part of a stock acquisition. Effective January 1, 2025 the former PF Harris Manufacturing employees became eligible to participate in the PurposeBuilt Brands 401(k) plan. PF Harris Manufacturing had an active 401(k) plan, PF Harris Manufacturing 401(k) Plan with less than 100 employees. The PF Harris Manufacturing 401(k) Plan merged into the PurposeBuilt Brands 401(k) plan effective May 1, 2025.

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued and has determined that there were no other subsequent events that have occurred through the date of the report that would require recognition or disclosure in the financial statements.
