As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of SBA Defined Contribution Plan for Touchstone Bank and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 6, the governing body of SBA Defined Contribution Plan for Touchstone Bank approved a plan of liquidation on August 29, 2024. All assets were distributed on December 31, 2024. As a result, the Plan has changed its basis of accounting from the ongoing basis used in presenting the financial statements for the year ended December 31, 2023 to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of SBA Defined Contribution Plan for Touchstone Bank's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 – Plan Description

The following description of the SBA Defined Contribution Plan for Touchstone Bank (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was a defined contribution plan covering all employees of Touchstone Bank (the “Company”) who had completed at least one month of service, excluding intermittent task-specific employees, non-resident aliens, leased employees, self-employed individuals, and owner employees. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On August 29, 2024, the Board approved the Plan’s termination due to Plan Sponsor’s merger into First National Corporation effective September 30, 2024. See Note 6 regarding plan termination.

Contributions

Prior to plan termination, participants could contribute an amount of their compensation, as defined by the Plan document, subject to *Internal Revenue Code* (“IRC”) limitations. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans.

Newly hired participants were subject to automatic enrollment into the Plan at a 3% enrollment rate, unless the participant affirmatively elected otherwise. The automatic enrollment increased by 1% each year, up to a maximum of 6% of compensation. The Company matched 100% of the first 4% of eligible compensation. In addition, the Company could choose to make a discretionary contribution to the Plan. To qualify for discretionary contributions, employees were required to work at least 1,000 hours and be employed on the last day of the plan year. The Company did not make any discretionary contributions for the year ended December 31, 2024. Participants could direct the investment of their contributions, matching, and any discretionary contributions into various investment options offered by the Plan. Contributions were subject to certain limitations.

Participant Accounts

Prior to plan termination, each participant’s account was credited with a participant’s contribution and allocations of (a) the Company’s contributions, (b) Plan earnings, and (c) Plan expenses. Allocations were based on participant compensation or account balances, as defined by the Plan and performed on a daily basis unless otherwise stated. The benefit to which a participant is entitled was the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Prior to plan termination, vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon was based on years of continuous service in accordance with the following vesting schedule:

Upon plan termination, all participants became 100% vested in all accounts.

Notes Receivable from Participants

Prior to plan termination, Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account and bore interest rates at the prime rate plus 2% at the time the loan was made. Principal and interest were paid ratably through monthly payroll deductions.

Payment of Benefits

Prior to plan termination, on termination of service due to death, disability, or retirement, a participant could elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or roll over his or her distribution into an Individual Retirement Account ("IRA") or another qualified plan. In certain situations, participants could receive in-service hardship withdrawals.

Upon plan termination, participants could roll over their accounts into the First National Corporation 401(k) Plan, receive a lump-sum distribution, or roll over his or her distribution into an IRA or another qualified plan.

Forfeitures

Forfeited non-vested accounts totaled \$-0- and \$32,195 at December 31, 2024 and 2023, respectively. These accounts will be treated as additional employer contributions and allocated to Plan participants. Effective August 30, 2024, the Plan was amended to allow forfeitures to either pay Plan expenses or reduce employer contributions. During 2024, forfeitures of \$4,621 and \$30,959 were used to pay Plan expenses and reduce employer contributions, respectively. Due to plan termination, remaining forfeitures of \$5,408 were reallocated to participants on December 24, 2024.

Administration

The Plan Sponsor administers the Plan through an agreement with VBA Benefits Corporation. Voya Institutional Trust Company (Voya) acts as Trustee and manages the Plan assets as well as retains custody.

Administrative Expenses

Administrative expenses may be paid by the Plan or the Company. A portion of these expenses were paid by the Plan for the year ended December 31, 2024. Investment-related expenses are included in net appreciation in fair value of investments.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting used to determine the amounts at which investments are stated, from an ongoing Plan basis to the liquidation basis for periods after December 31, 2023. See Note 6 for discussion of Plan termination.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

Subsequent events have been evaluated through August 22, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The Plan’s investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2023. Due to plan liquidation, there are no investments held by the Plan at December 31, 2024. Classifications within the fair value hierarchy table is based on the lowest level of input that is significant to the fair value measurement.

Level 1 Fair Value Measurements

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end.

Level 2 Fair Value Measurements

The fair value of the common collective trust funds are based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e., interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted price for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

The common collective trust funds invest in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. While the underlying asset values are quoted prices, the net asset value (NAV) of a unit in these funds is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are reflected in the computation of the NAV and are realized by the participant upon withdrawal.

Note 4 – Investment Contract

Goldman Sachs Stable Value Collective Trust is a benefit-responsive investment contract with Goldman Sachs. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The average yields for the stable value collective trust are as follows:

The objective of the stable value collective trust is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit-responsive plan or participant payments. The percentage of contributions allocated to the stable value collective trust is determined by the participants.

Note 5 – Related Party Transactions

Prior to plan termination, certain administrative functions were performed by officers or employees of the Company. These employees were also Plan participants. No such officer or employee received compensation from the Plan.

VBA Benefits Corporation is the Plan's Administrator. Certain Plan investments were managed by Voya Institutional Trust Company, the Trustee and recordkeeper for the Plan, therefore, these transactions qualify as party-in-interest transactions. The Plan paid \$74,122 in administrative fees in 2024.

Note 6 – Plan Termination

On August 29, 2024, the Board approved the Plan's termination due to Plan Sponsor's merger into First National Corporation effective September 30, 2024. All participants became 100% vested on September 30, 2024. All assets were either distributed to participants as lump sums, rolled over into IRAs, or rolled over into the First National Corporation 401(k) Plan as of December 31, 2024.

Note 7 – Tax Status

The non-standardized pre-approved profit-sharing plan document sponsored by State Bankers Association obtained an opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan is designed in accordance with applicable sections of the *IRC*. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
