We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

December 31, 2024 and 2023

Plan Description

The following description of Western Beef Retail, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, covering all employees except for union employees and non-resident aliens of the Company. The Plan has a 3 month service requirement to begin salary deferrals for all employees with a minimum age of 21. Employees age 21 and older who have completed one year of service and are employed with the Company on the last day of the year, with a minimum of 1,000 hours with the Company, are eligible for discretionary Company matching contributions, profit sharing contributions, and non-elective contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During 2024, the Plan appointed Pentegra Retirement Services as the named 3(16) Plan Administrator.

Contributions

Each year, participants may authorize payroll deductions up to 90% of compensation as before-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

For 2024 and 2023, the Company elected to make a discretionary matching contribution of 2% of participants' eligible compensation. The Company made discretionary matching contributions in the amount of \$369,974 and \$402,075 for the 2024 and 2023, respectively. The Company did not make discretionary profit sharing contributions for 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's discretionary matching contribution, and allocations of (a) the Company's profit sharing contribution, (b) Plan earnings and losses, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

December 31, 2024 and 2023

Plan Description (continued)

Vesting

Participants are immediately vested in their contributions and Company profit sharing and matching contributions vest as follows:

Investment Options

A participant may direct contributions in any of the investment funds offered by the Plan. Participants may change their investment options at any time.

Payment of Benefits

Upon separation from service, participants may choose to have vested benefits paid in a lump-sum or in periodic payments, as defined by the Plan.

Participant Notes Receivable

Participants are permitted to borrow a minimum of \$1,000 up to a maximum equal to the lesser of 50 percent of their vested account balance or \$50,000, reduced by the highest outstanding note balance in their account during the previous 12 months, except for the amounts borrowed under the CARES Act, which are subject to higher limits. Loan terms may not exceed five years unless the principal of the loan is for the purchase of a primary residence, in which case it may not exceed beyond ten years from the date of the loan. Notes receivable are measured at their unpaid principal balance plus any received but unpaid interest. The note is secured by the balance in the participant's account and bears an interest rate at Prime plus 2%. Interest rates on the outstanding notes at December 31, 2024 ranged from 5.25% to 10.50%. The notes are repaid ratably through payroll deductions over a period of five year or less.

Summary of Significant Accounting Principles

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Notes to Financial Statements

December 31, 2024 and 2023

Summary of Significant Accounting Principles (continued)

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and Trustee. See Fair Value Measurements footnote for discussion of fair value measurements.

Net appreciation in fair value of investments is reflected in the statement of changes in net assets available for benefits and includes realized gains and losses on investments bought and sold and the change in appreciation from one period to the next.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the participant, as provided by the Plan agreement. Other expenses including management fees are borne by the Company.

Forfeited Accounts

Forfeited non-vested accounts are utilized to pay reasonable Plan expenses and remaining forfeitures will be used to reduce future Company contributions payable under the Plan. During 2024, participants forfeited approximately \$6,500. At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$9,900 and \$3,400, respectively. During 2024, the Company used approximately \$25,000 of forfeitures to reduce the Company contribution.

Notes to Financial Statements

December 31, 2024 and 2023

Fair Value Measurements

ASC 820 establishes a framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measure at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds/Money Market Accounts: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no significant transfers between levels 1, 2, and 3 investments during the years ended December 31, 2024 and 2023.

Fixed Interest Accounts

The Plan maintains fixed interest accounts with the Empower Insurance Annuity Company of America (the Custodian). The average yields for the years ended December 31, 2024 and 2023 were 1.56% and 1.34%, respectively, and are reviewed on a quarterly basis for resetting. The fixed interest account issuers are contractually obligated to repay the principal and the specified guaranteed interest rate to the Plan. Contract value represents contributions made under the contract, plus earnings less participant withdrawals. The contract value in the amount of \$406,324 and \$398,521 are presented in the statements of net assets available for benefits as of December 31, 2024 and 2023, respectively.

The Plan's ability to receive amounts due is dependent on the Custodian's ability to meet its financial obligations. The Custodian's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the Custodian. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C), pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulation for Reporting and Disclosure under ERISA. Accordingly, Empower Insurance Annuity Company of America and Empower Trust Company, both qualified institutions, have certified the following information included in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) as complete and accurate:

- Investments and notes receivable from participants as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments and dividends and interest as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024;
- Investment information included in the Notes to Financial Statements;
- All investment information included in the Supplemental Schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) – As of December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information included in the financial statements and ERISA-required supplemental schedule.

Parties-In-Interest

The Plan's investments in the insurance company guaranteed account are managed by Empower Insurance Annuity Company of America (EIAC), the Custodian of the Plan. Any purchases and sales of these funds are performed in the open market at contract value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under ERISA. Fees incurred by the Plan for investment management services are included in net depreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment.

EIAC provides certain administrative services to the Plan pursuant to a Master Plan Services Management Agreement (MSA) between the Company and EIAC. EIAC receives revenue from mutual fund service providers for services EIAC provides to the funds. This revenue is used to offset certain amounts owed to EIAC for its administrative services to the Plan.

Notes to Financial Statements

December 31, 2024 and 2023

Parties-In-Interest (continued)

If the revenue received by EIAC from such mutual fund service providers exceeds the amount owed under MSA, EIAC remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or Plan Sponsor may make a payment to EIAC for administrative expenses not covered by revenue sharing. For the year ended December 31, 2024, the Plan received \$49,101 of revenue sharing credits.

The notes receivable from participants as of December 31, 2024 and 2023, in the amounts of \$1,301,483 and \$1,223,450, respectively, are in party-in-interest transactions. The Plan invests in various funds of the Plan recordkeeper and Custodian. The fees for investment and management services paid by the Plan to the recordkeeper and Custodian were \$58,844 for the year ended December 31, 2024. The employees of the Company provide administrative services to the Plan. These employees are not paid by the Plan for their services.

Tax Status

The Plan has received a determination letter from the Internal Revenue Service dated June 30, 2020, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (Code). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan Administrator has analyzed the tax position taken by the Plan, and has concluded that as of December, 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions and terminate the Plan. In the event of termination or partial termination of the Plan, all amounts credited to a participants' account, including Company contributions, become fully vested.

Notes to Financial Statements

December 31, 2024 and 2023

Excess Contributions Refundable

As of December 31, 2024 and 2023, liabilities of \$18,136 and \$6,211, respectively, are recorded for amounts refundable by the Plan to participants for contributions greater than amounts allowed by the IRS, respectively.

Subsequent Events

The Plan evaluated subsequent events through September 24, 2025, the date the financial statements were issued.
