To the Plan Administrator  
Epilepsy Foundation of America 401(k) Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Epilepsy Foundation of America 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. **Note 1: Description of Plan**

The following description of Epilepsy Foundation of America 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution retirement plan established by Epilepsy Foundation of America (the Foundation) under a prototype plan sponsored by Empower Trust Company. The Plan covers substantially all employees who have attained the age of 21. At this time, the eligible employee may make voluntary deferral elections and receive the employer matching contributions. After a year of service, eligible employees will also be eligible to receive the non-elective safe harbor contribution, and if the employed on the last day of the Plan year, be eligible to receive the discretionary profit sharing contributions. The Plan qualifies under Section 401(k) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions: The Plan generally allows eligible employees to contribute an amount not to exceed the lesser of 100% of their compensation or an amount which, when added to other additions (exclusive of earnings) to the participant's account in any plan year, does not exceed the maximum limitation on annual additions to a participant's account under applicable provisions of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participant contributions are made through payroll deductions. Participants have the opportunity to change their investment combinations daily. Each participant designates the percentage of their contribution which is to be invested in one or more of the available investment fund options. In addition to the pre-tax contributions that an eligible employee can make, the Plan also provides an option for after-tax contributions to a Roth account. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers).

Employer Contributions: The Foundation has elected to operate the Plan as a safe harbor 401(k) plan, which makes the plan exempt from certain compliance testing requirements. The Foundation makes a safe harbor non-elective contribution of 3% of a participant's compensation. Employees are eligible for the non-elective contribution after 1 year and 1,000 hours of service. The Foundation also makes an employer matching contribution of 100% of the participant's deferral up to 3% of compensation. Employees are eligible for the employer match upon participation in the Plan. The Foundation may make additional discretionary contributions which will be allocated in accordance with the plan document provisions. Participants must be employed in any pay period and have earned 1 year and 1,000 hours of service to be eligible to receive discretionary contributions. For the years ended December 31, 2024 and 2023, there were discretionary profit sharing contributions of \$65,478 and \$59,354, respectively.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of the Foundation's contributions, Plan earnings and losses and administrative expenses. Plan earnings and losses are allocated based on the account balances of the participants. Administrative expenses are allocated based on participant account balances or specific participant transactions. The benefit to which a participant is entitled is that which can be provided from the participant's vested account balance. All Plan assets as of December 31, 2024 and 2023 have been allocated to participant accounts.

Vesting: Participants are immediately vested in all of their contributions and investment earnings thereon. Employer safe harbor and matching contributions and discretionary contributions are fully vested and non-forfeitable when such contributions are made to a Participant's account.

**Note 1: Description of Plan (Continued)**

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. The notes receivables are secured by the balances in the participant's account and bear interest at prevailing rates for similar loans as determined by the Plan administrator and are carried at their outstanding principal balance. Repayments are generally made through payroll deductions. A participant may have only two loans outstanding at any one time.

Payment of Benefits: Upon termination of employment due to death, disability, retirement, or other reasons, a participant may have their plan benefits distributed as a lump-sum payment equal to the participants account balance. Account balances that are equal to or less than \$1,000 will be distributed in a lump sum amount and account balances equal to or less than \$5,000 will be rolled into an IRA account, excluding rollover account balances. Participants are generally required to take minimum distributions upon reaching the age of 72 (73 if the participant reaches age 72 in 2023 or later). In-service withdrawals are permitted after a participant has attained 59½ years of age. Hardship withdrawals by a participant are permitted if specified criteria are met.

**Note 2: Summary of Significant Accounting Policies**

Following is a description of the significant accounting and reporting policies of the Plan:

Basis of Presentation: The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan trustees are responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings and monitor investment performance. Investments are reported at fair value except for fully-benefit responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for fully-benefit responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Contributions: Contributions from participants, including any related employer matching contributions, are recorded in the period the employer withholds payroll deductions from Plan participants. Employer discretionary contributions are recorded in the period when the contribution is approved by the Foundation's management and collectability is reasonably assured.

Payment of Benefits: Benefits are recorded when paid to participants.

Subsequent Events: In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through August 7, 2025, the date the financial statements were available to be issued. During the period January 1, 2025 through August 7, 2025, the Plan did not have any material recognizable subsequent events.

**Note 3: Fair Value Measurements**

Generally Accepted Accounting Principles (GAAP) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for Plan investments measured at fair value. There has been no change in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: The fair value of mutual funds is based on the daily closing price as reported by the fund. Mutual funds are required to publish their daily net asset values (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In determining the appropriate levels, the Plan performs a detailed analysis of the assets that are to be reported at fair value. The tables below present the assets measured at fair value on a recurring basis by level within the hierarchy as of December 31, 2024 and 2023:

**Note 4: Information Certified by the Plan Trustee**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, the Plan administrator has instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information certified as complete and accurate by Empower Annuity Insurance Company of America (Empower), the trustee of the Plan, except to compare such information to information included in the Plan’s financial statements and supplemental schedule.

Certain information reported in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was derived from information certified as complete and accurate by Empower.

**Note 5: Fully Benefit-Responsive Investment Contracts**

At December 31 2024 and 2023, the Plan had a fully-benefit responsive guaranteed investment contract (GIC) with the Empower Investment (EI) Fixed Account, totaling \$448,435 and \$537,715. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established in a contract between the Plan and the contract issuer, which will not fall below 0%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the Plan's ability to transact at contract value with Empower. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption under the Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that the possibility of any events that would limit the Plan's ability to transact at contract value with plan participants to be probable.

**Note 6: Notes Receivable from Participants**

As of December 31, 2024 and 2023, 9 and 8 participants, respectively, were indebted to the Plan in the total amount of \$115,696 and \$57,237, respectively, as the result of loans made to them by the Plan. The loans are evidenced by promissory notes bearing interest at various rates ranging from 4.25%-9.50% per annum, and are payable in installments, the latest of which is due in September 2029. The notes are fully secured by the participants' vested account balances.

**Note 7: Plan Termination**

The Foundation has the right under the Plan agreement to discontinue their contributions at any time and to terminate the Plan, subject to applicable statutory provisions. In the event of termination, all participants will become fully vested. The Foundation has not indicated any intention to terminate the Plan.

**Note 8: Income Tax Status**

The Internal Revenue Service has ruled, in a letter dated November 14, 2022, that the Non-Standardized Pre-Approved Profit Sharing Plan, as amended, established by Empower Retirement LLC, qualifies under applicable sections of the Internal Revenue Code. An employer who adopts this plan is generally considered to have a plan that is also qualified. The Plan's administrator and the Plan's sponsor believe that the Plan is designed and currently operating in compliance with the applicable requirements of the Internal Revenue Code. The Plan's federal tax returns are subject to examination by the Internal Revenue Service (IRS) generally for a period of three years after the returns are filed.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator does not believe that the Plan has any uncertain tax positions. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

#### Note 9: Parties-in-Interest

The Plan offers various investment options to participants which are managed by Empower, the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions. In addition, Raymond James, investment advisor, provides various services which qualify as party-in-interest transactions. During the years ended December 31, 2024 and 2023, the Plan paid administrative fees in the amount of \$40,689 and \$37,368, respectively, to Empower. Certain officers and employees of the Plan sponsor are administrators of the Plan acting as fiduciaries and are participants in the Plan. Effective November 2024, the Plan sponsor engaged PointOak Retirement Advisors, LLC (PointOak) as the investment advisors for the Plan. All services previously provided by Raymond James were transitioned to PointOak without disruption to plan participants or plan operations.

#### Note 10: Administrative Expenses

The Plan's expenses are paid by either the Plan or the Foundation, as provided by the Plan document. Expenses paid directly by the Foundation are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments. The Plan has a revenue sharing agreement with their trustee. The Plan received \$15,073 and \$13,603 of shared revenue during the years ended December 31, 2024 and 2023, respectively, which was offset against recordkeeper fees and included in other income in the statements of changes in net assets available for benefits.

#### Note 11: Reconciliation of Financial Statements to Form 5500

The financial statements of the Plan for the year ended December 31, 2024 differ from the amounts reported on Schedule H (Financial Information) of Form 5500 (Annual Return/Report of Employee Benefit Plan) filed with the Internal Revenue Service. The significant difference for the year ended December 31, 2024 is as follows:

**Note 12: Risks and Uncertainties**

Investment Risk: The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
