Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of Peterson Manufacturing Company and Affiliates 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

(1) Description of plan

The following description of Peterson Manufacturing Company and Affiliates 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

General - The Plan is a defined contribution plan sponsored by Peterson Manufacturing Company ("the Company") for the benefit of its employees who have three months of service and are age 18 or older. Employees may enter the Plan the first of the month after meeting eligibility requirements. Employees covered under a collective bargaining agreement, non-resident aliens and leased employees are excluded from participation. Mission Plastics of Arkansas Inc. and TransWorld Products Inc. are participating employers in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan is administered by an Administrative Committee (the "Committee"), which is a committee made up of members of management of the Company. The Committee has overall responsibility for the operation and administration of the Plan. The Committee, along with the investment advisor, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Change in service organizations - Effective December 29, 2023, the Plan changed to Fidelity Management Trust Company as recordkeeper and trustee of the Plan. The Plan Administrative Committee has adopted a Fidelity pre-approved profit sharing plan document. The IRS has determined that the pre-approved profit sharing plan is designed in accordance with applicable sections of the IRC and informed Fidelity of such in a letter dated June 30, 2020.

As of December 31, 2023, the majority of the Plan assets were held in a Fidelity conversion account, which was an interest-bearing cash account until the funds were traded into investments in January 2024. As of December 31, 2024, one investment in the Principal U.S. Property Separate Account remained at Principal Life Insurance Company, custodian, which was subject to a withdrawal restriction as further discussed in Note 4.

Plan change - Under the provisions of the SECURE 2.0 Act, effective January 1, 2024, the automatic force out distribution limit was increased from \$5,000 to \$7,000. The Plan implemented this change and will be amended for this provision by the time prescribed.

Contributions - Each year, participants may contribute up to 100% of annual compensation as pre-tax or Roth contributions, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions, as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan.

NOTES TO FINANCIAL STATEMENTS

(1) Description of plan (continued)

Contributions (continued) - The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation. The automatic deferral amount will increase by 2% per year up to a maximum of 10% of eligible compensation. The Company may make discretionary matching contributions to the Plan. Employees must have one year of service to be eligible for Company matching contributions. Entry for the Company match is semi-annual (June 1 and December 1). No Company matching contributions were made for the years ended December 31, 2024 and 2023. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

Participant investment account options - The Plan currently offers various mutual funds as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

Participant accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution (if any), (b) plan earnings (losses), and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants' contributions plus actual earnings are 100% vested immediately. Any employer contributions are subject to a 6-year graded vesting schedule.

Payment of benefits - Upon termination of service for any reason, if a participant's balance is less than \$7,000 (prior to January 1, 2024, \$5,000), their benefit equal to the value of the participant's vested interest in his or her account, will be distributed in a lump sum payment. For balances greater than \$7,000, a participant may elect to receive an amount equal to the value of their vested interest in his or her account in the form of a lump sum payment, rollover to another retirement plan or IRA, or continue to participate in the Plan investments.

(2) Summary of significant accounting policies

Basis of accounting - The financial statements of the Plan are prepared on the accrual method of accounting.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

(2) Summary of significant accounting policies (continued)

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment custodians. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions - Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Excess contributions payable - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

Payment of benefits - Benefits are recorded when paid.

Administrative expenses - Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Investment related expenses are included in net appreciation of fair value of investments.

(3) Information prepared and certified by the custodians and trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, and Principal Global Investors Trust Company, the custodians, held the Plan's investment assets and executed investment transactions from January 1, 2023 through December 29, 2023 and Fidelity Management Trust Company, the trustee, held the Plan's investment assets from December 29, 2023 to December 31, 2024. The custodians and trustee of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(4) **Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate account: Valued at the NAV of units of the separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

Interest bearing cash: Valued at amortized cost, which approximates fair value.

(b) Principal Life Insurance Company (“Principal”) has the ability to apply a contractual limitation that delays the payment of withdrawal requests (“Withdrawal Limitation”) and provides for payment on a pro rata basis as cash becomes available for distribution, as determined by Principal. On July 1, 2022, Principal applied the Withdrawal Limitation. The Withdrawal Limitation was in place through February 21, 2025 when Principal announced they would satisfy all outstanding requests.

(5) Related party transactions and party-in-interest transactions

Certain plan investments are shares of a pooled separate account managed by Principal and shares of mutual funds managed by Fidelity. Principal is the custodian of the Plan and Fidelity is the trustee of the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the custodian and trustee of \$21,024 and \$48,163 for the years ended December 31, 2024 and 2023, respectively, which was not covered by revenue sharing. The Plan paid certain expenses related to the Plan’s operations and investment activity to various service providers. These transactions are party-in-interest transactions. The Plan Sponsor pays directly any other fees related to the Plan’s operations.

(6) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in any employer contributions.

(8) Tax status

The Company adopted a Farmer & Betts pre-approved plan document that received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. The plan administrator believed that the Plan was designed, and operated, in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified.

Effective December 29, 2023, the Company adopted a Fidelity pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) **Risks, uncertainties and concentrations**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024, approximately 53% of the Plan's investments were invested in the Fidelity Freedom Blend 2025 Fund, Fidelity Freedom Blend 2035 Fund and the Fidelity Government Money Market Fund.

At December 31, 2023, approximately 99% of the Plan's assets were held in an interest bearing cash conversion account, awaiting allocation to investments at Fidelity Management Trust Company.

(10) **Delinquent participant contributions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. While the Company remitted all employee contributions to the Plan, contributions of \$41,762 and \$33,284 were not remitted within the required time period for the years ended December 31, 2024 and 2023. The Company corrected the 2023 delinquent participant contributions by remitting the delinquent participant contributions in January 2024 and lost earnings to the Plan in July 2024. The Company corrected the 2024 delinquent participant contributions by remitting lost earnings to the Plan in May 2025.

(11) **Subsequent events**

The Plan has evaluated subsequent events through August 29, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
