## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of CST Industries, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. # CST INDUSTRIES, INC. 401(k) PROFIT SHARING PLAN AND TRUST

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF THE PLAN

The following description of the CST Industries, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan covering all employees of CST Industries, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

On April 1, 2022, Empower Retirement LLC ("Empower Retirement") acquired the retirement business of Prudential Financial, Inc. Following an initial transition period in 2022, Empower Retirement became the sole administrator of the Plan. On October 3, 2022, Prudential Retirement Insurance and Annuity Company was renamed Empower Annuity Insurance Company ("Empower"). Effective March 31, 2023, Prudential Bank & Trust ("Prudential"), FSB was merged into Empower Trust Company.

Recordkeeping services were transitioned to the Empower Retirement Recordkeeping Services platform effective March 2, 2024. Effective March 2, 2024, Empower Annuity Insurance Company and Empower Trust Company (collectively, "Empower"), serves as the custodians of the Plan. Empower Trust Company is the trustee of the Plan. Empower Retirement serves as the Plan's recordkeeper.

**Eligibility** – An employee must complete one month of service and reach age 21 to be eligible for the Plan. The employees may enroll in the Plan beginning on the first day of January, April, July or October that coincides with or immediately follows the date the eligibility requirements are met. The adoption agreement excludes union employees, leased employees and residents of Puerto Rico from the Plan.

**Contributions** – Participants may elect to contribute up to 50% of pretax annual compensation, as defined in the Plan and subject to certain Internal Revenue Code limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. New employees are automatically enrolled in the Plan, and contribute 3% of their eligible wages, unless the employee opts out of participation, or chooses a different deferral rate. Each successive year on the 1<sup>st</sup> day of June, the deferral will increase by 1%, to a maximum amount of 6%. Additionally, participants aged 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions, as defined in the Plan.

The Company may make a discretionary matching contribution. In 2024, a match was contributed every payroll at the rate of 50% up to 6% contributed by the employee.

Additionally, the Company may opt to make discretionary profit-sharing contributions. A participant is eligible for the profit-sharing contribution if the participant is 21, worked 1,000 hours during the year, and is employed on the last day of the Plan year (except in instances of death, disability, or retirement at or after normal retirement age, as defined in the Plan). An employee must have 3 months of service to be eligible for the profit-sharing contribution. There was no profit-sharing contribution in 2024.

**Participant Accounts** – Each participant's account is credited with the participant's and Company's contributions, and allocations of Plan earnings, and is charged with the participant's withdrawals and distributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options** – The Plan offers a variety of mutual funds, pooled separate accounts, and an insurance company general account as investment options for participants.

**Vesting** – Participants' contributions and rollover contributions are fully vested at all times. Qualified non-elective contributions are also fully vested at all times. Other employer contributions vest 33% after one year of service, an additional 34% after two years of service and are fully vested after the third year. In the event of permanent disability, death, reaching normal retirement age, or termination of the Plan, the Company contributions will become fully vested.

**Forfeitures** – At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$128,108 and \$122,396, respectively. These accounts may be used to reduce future employer contributions and to pay Plan expenses. During the 2024 Plan year, approximately \$13,600 in forfeitures were utilized to pay Plan expenses and \$28,000 was used to reduce employer contributions.

**Payment of Benefits** – Distributions of a participant's vested balance may occur upon normal retirement, termination of employment, death, or permanent and total disability in the form of a total lump sum or installment payments. Participant balances under \$1,000 may be automatically distributed. If a participant's account balance is between \$1,000 and \$7,000, the balance will be automatically rolled over to an IRA, unless a different election is made.

**In-Service Withdrawals** – Certain participants may make withdrawals prior to termination of employment.

- Hardship withdrawals are available from participant's elective deferral accounts.
- Participants who have obtained the age of 59 ½ may elect to receive a distribution of all or any portion of their vested account balances in a single lump sum payment limited to one request each Plan year.
- Participants may withdraw amounts that are designated as rollover contributions at any time.

**Notes Receivable from Participants** – Participants are permitted to borrow against their individual account balances (salary deferral portion, only) a minimum of \$1,000 up to the lesser of \$50,000 or 50% of the participant's vested account balance. Loans are secured by the participant's vested account balance. Interest rates on the loans are set at 1% plus the prime rate, as determined by the *Wall Street Journal*. Loan terms are in accordance with limitations set forth by the Internal Revenue Service, and may not exceed five years, unless the loan is to purchase a primary residence. Loan repayments are made ratably through payroll deductions.

**Administrative Expenses** – Administrative expenses incurred by the Plan may be paid by the Plan or by the Company. During 2024, the Plan paid administrative expenses of \$143,239.

**Termination of the Plan** – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, all remaining Plan assets shall be allocated to the participants as described in the full text of the Plan.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully-benefit responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions** – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

**Investment Valuation and Income Recognition** – The Plan's investments in mutual funds and pooled separate accounts are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date; interest is accrued when earned.

The Plan invests in an insurance company general account through the Empower Guaranteed Income Fund, which is fully benefit-responsive. Empower Life Insurance and Annuity Company determined that contract value is an appropriate determination of fair value for the Guaranteed Income Fund.

Management fees and operating expenses charged to the Plan for investments in the mutual funds and the pooled separate accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distribution based upon the terms of the Plan document. No allowance for doubtful account is considered necessary.

**Payment of Benefits** – Benefit payments are reported in the year paid.

**Date of Management's Review** – Subsequent events have been evaluated through October 3, 2025, which is the date the financial statements were available to be issued, and there were no material events requiring recognition or disclosure.

### 3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The hierarchy consists of three broad levels, described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds – Valued at the published net asset value (“NAV”) of shares held by the plan at year end.

Pooled Separate Accounts – The investment advisors calculate a unit value (similar to a NAV) of a separate account. It is the sum of the market value of the underlying investments as determined by quoted market prices, less operating expenses accrued but not deducted, if any.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) Certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits. These investments are valued daily, may be redeemed daily without restrictions, and with no notice requirements. Additionally, there are no unfunded commitments.

#### 4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances, and the amounts reported in the financial statements.

## **5. INFORMATION CERTIFIED BY THE CUSTODIANS**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Prudential and Empower, the custodians of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedules are complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value and contract value
- Notes receivable from participants and related interest income
- Net appreciation in fair value of investments
- Interest and dividends
- Other income
- Schedules of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

## **6. INSURANCE COMPANY GENERAL ACCOUNT**

The Plan has entered into a group annuity contract issued by Empower Retirement Insurance and Annuity Company, which is a fully benefit-responsive investment. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their account balance at contract value, which approximates fair value. Contract value is the sum of amounts invested, less withdrawals, plus interest computed at the guaranteed interest rate. These contracts do not hold any specific assets.

Interest is credited on contract balances using a single "portfolio rate" approach. Under this methodology, a single interest crediting rate is applied to all contributions made regardless of the timing of those contributions. Interest crediting rates are reviewed on a semi-annual basis for resetting.

When establishing interest crediting rates, Empower considers many factors, including current economic and market conditions, the general interest rate environment and both the expected and actual experience of a reference portfolio within the issuer's general account. These rates are established without the use of a specific formula. The minimum crediting rate under the contract is 1.50%.

## **7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments include pooled separate accounts, mutual funds, and an insurance company general account managed by the custodians of the Plan, as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

The Plan pays certain fees to Empower and Empower Retirement to administer the Plan. Audit fees are also paid by the Plan. These transactions qualify as party-in-interest.

Notes receivable from participants are party-in-interest transactions.

## **8. TAX STATUS**

The Company adopted a Non-Standardized Pre-Approved Profit-Sharing Plan with CODA which received a favorable opinion letter from the IRS on September 16, 2022, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions.

**9. PROHIBITED TRANSACTIONS**

During the year ended December 31, 2020, employee deferrals and loan payments of \$23,028 were withheld from one payroll and not remitted on a timely basis (as defined by the DOL) by the Plan Sponsor. The Plan Sponsor subsequently remitted all such deferrals to the trust, has filed and paid the appropriate excise tax, and contributed lost earnings to the affected participants. These transactions were prohibited according to the provisions of the DOL.

During the year ended December 31, 2019, employee deferrals and loan payments of \$90,325 were withheld from payrolls and not remitted on a timely basis (as defined by the DOL) by the Plan Sponsor. The Plan Sponsor subsequently remitted all such deferrals to the trust, has filed and paid the appropriate excise tax, and contributed lost earnings to the affected participants. These transactions were prohibited according to the provisions of the DOL.
