### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Experity 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Experity 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Experity 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan originally effective July 1, 2012. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective July 27, 2023. The Plan provides participants tax-deferred savings under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility**

Employees of Experity, Inc., Teleradiology Specialists, P.L.L.C. and OnePacs, LLC (the Companies) are eligible to participate in the deferral component of the Plan upon reaching age 21 and completing 90 days of service. If these requirements are not met, employees are eligible to participate if 1,000 hours of service are completed. Employees are eligible to participate in the Companies contribution components of the Plan upon reaching age 21 and completing one year of service. Effective July 1, 2022, employees are eligible to participate in the Companies' safe harbor contribution component of the Plan upon reaching age 21 and completing 90 days of service. Eligible employees may start to participate on the first day of the month following the date they become eligible.

**Contributions**

Participants may elect to contribute to the Plan a percentage of their eligible compensation up to a maximum amount as defined by the IRC. Should certain participants contribute more than allowable by the Plan; the excess contributions are timely refunded after year-end to the appropriate participants. The Plan allows participants to make after-tax Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollover distributions from other qualified retirement plans.

The Plan provides for the Companies to make safe harbor match contributions annually. For the years ended December 31, 2024 and 2023, the safe harbor match contribution is a contribution equal to 100% of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the participant's elective deferrals that exceed 3% up to a maximum of 5% of the participant's compensation. Employer safe harbor match contribution made in 2024 totaled \$1,792,214. Employer match and profit sharing contributions to the Plan are at the discretion of the Companies' Board of Directors; however, the total contributions may not exceed the maximum allowable by the IRC. The matching percentage will be determined each year and applied up to 4% of the participant's eligible compensation. The Companies did not make any discretionary match contribution or profit sharing contribution in 2024.

**Participant Accounts**

Each participant's account is credited with the participant's voluntary salary deferral contributions, the Companies' safe harbor match and discretionary Employer match contributions (if applicable), and an allocation of: (a) the Companies' profit sharing contributions (if applicable), (b) the Plan's earnings or losses, (c) forfeitures and is reduced for certain administrative expenses paid by the Plan. The Companies' profit sharing contributions and forfeitures are allocated based on the participant's eligible compensation. Plan earnings or losses are allocated based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately 100% vested in their voluntary tax-deferred and Roth contributions, Employer safe harbor match contributions, and earnings thereon. Participants are vested in the discretionary Employer matching and profit sharing contributions based on years of service. A participant becomes vested in the discretionary Employer matching and profit sharing contributions according to the following schedule:

6 Years or More	100

A participant must work at least 1,000 hours during a Plan year to increase the vested portion of the Companies' contributions. A participant is also 100% vested if termination is a result of death, disability, or retirement.

**Investment Options**

Participants must direct all contributions to selected investment models as made available and determined by the Plan administrator. Participants have the option to transfer monies between models and change allocations of their investment at any time.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the vested balance of the participant's account or \$50,000. Note terms cannot exceed five years. The notes are secured by the balance in the participant's account and bear interest rate ranging from 4.25% to 9.50% at December 31, 2024 and 2023. Interest is the current prime rate plus 1% at the time the note is initiated. Principal and interest are paid through payroll deductions. If the participant terminates employment, the balance of the outstanding note will become due and payable immediately. In the event the note is not repaid, it will be treated as a taxable distribution to the participant.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement, or termination, a participant may elect to receive a lump sum amount equal to the value of his/her account. Balances of less than \$5,000 will be distributed to the participant. If the balance is more than \$5,000, an election to receive the benefit must be made. Upon reaching 59½ years of age, a participant with a fully vested account may receive an in-service distribution prior to separation from service from all accounts except for the participant's voluntary tax-deferred and Roth contribution accounts. Hardship withdrawals are not permitted.

**Forfeited Accounts**

Forfeitures from less than 100% vested accounts are used to pay any administrative expenses or to reduce Companies' contributions. Excess forfeitures are used to provide additional Employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$110,764 and \$107,396, respectively. There were no forfeitures used to pay administrative expenses in 2024. There were no forfeitures allocated as discretionary matching or profit sharing contributions in 2024. There were \$9,391 of forfeitures used to reduce Companies' contributions in 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the Plan documents.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Administrative Expenses**

The Plan's expenses are paid either by the Plan or the Companies, as provided by the Plan document. Expenses paid directly by the Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net depreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

**Subsequent Events**

The Plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Charles Schwab Trust Bank, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access;

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets and liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Common Collective Fund* – Valued at the net asset value (NAV) of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in various combinations of investment funds. Investment funds are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**NOTE 7 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter, dated June 30, 2020, received from the Internal Revenue Service (IRS) on the volume submitter plan indicating that the Plan is qualified under Section 401 of the IRC and is, therefore, not subject to tax under current income tax law. The volume submitter plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Mutual funds and a common collective fund held by the Plan are managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the qualified institution as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net depreciation in fair value of investments. These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

Certain administrative functions are performed by officers or employees of the Companies for which they receive no compensation from the Plan.
