Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Magellan International School Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

NOTE A - DESCRIPTION OF PLAN

The Magellan International School Retirement Plan (the Plan) became effective September 1, 2017. The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a standardized 401(k) defined contribution plan, which covers all eligible employees of The Magellan International School (the Organization). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). John Hancock Life Insurance Company (the Custodian) is the Plan's custodian and record keeper; and the Plan is administered by the Organization.

Eligibility

All employees older than 21 years of age and who have served 3 months are eligible to participate in the Plan. Employees eligible to participate in the Plan may enroll on the first day of the month coinciding with or next following the date they satisfy the eligibility requirements.

Participant Investment Options

Participants are allowed to invest in a variety of investment choices as more fully described in the Plan's literature.

Contributions

As defined by the Plan, participating employees are allowed to contribute a percentage of their pretax earnings up to \$23,000 in 2024. The Plan provisions feature an opt-in arrangement to participate in the Plan. Investments are selected by the participant. Participants who are age 50 or older may elect to defer additional amounts (called catch-up contributions) to the Plan. The maximum catch-up contribution allowed is \$7,500 in 2024.

Distributions to participants from other qualified trusts, retirement accounts, or bonds may be applied as rollover contributions.

Matching contributions may be made by the Organization at their discretion. During 2024, the Organization made matching contributions of \$92,405.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Organization's matching contribution, and any earnings on their individual selected investments. Earnings, gains, and losses are allocated to each participant's account in proportion to the ratio of the participant's investment in each fund to all participants' total investment in each fund at the end of the quarter. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in their contributions plus earnings thereon. Participants are vested in employer matching contributions as follows:

<u>Years of Vesting Service</u>	<u>Vesting Percentage</u>
0-1 year	0%
1-2 years	33%
2-3 years	66%
3-4 years	100%

That portion, if any, of a terminated participant's matching contribution account which is not vested in the employer contribution account will be forfeited.

Payment of Benefits

Under the terms of the Plan, participants are eligible for benefit payments upon actual retirement on or after the participant's normal retirement date. The Plan also provides for distributions to participants, or their beneficiaries, upon death, disability, and termination of employment.

Participant Hardship Withdrawals

Under certain conditions of financial hardship, a participant may withdraw all or any portion of their contributions during employment. Financial hardship expenses include deductible medical expenses, funds for the purchase of a principal residence, tuition and related educational expenses for a participant, spouse or dependents, funds to prevent eviction or mortgage foreclosure on a principal residence, payments for burial or funeral expenses for a participant's deceased parent, spouse, children or other dependents, and expenses for the repair of damage to a participant's principal residence that would qualify for the casualty deduction for tax purposes.

Forfeited Accounts

Forfeited non-vested accounts may be applied to offset administrative expenses or employer contributions for the plan year. \$8,445 worth of forfeitures were used to reduce employer matching contributions during the year ended December 31, 2024. As of December 31, 2024 and 2023, \$0 and \$0 in forfeitures, respectively, were available to be used.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Administrative Expenses

With the exception of certain professional services contracted for by the Organization, the Plan's administrative expenses are paid out of plan assets as provided by the plan document.

Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Valuation of Investments

Investments in mutual funds are stated at current fair value based on trades executed at the published net asset value daily, or the public offering price for accounts trading under rights of accumulation.

Investment Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Investments are directed by participants.

Fair Value Measurements

The Plan follows Accounting Standards Codification (ASC) 820, issued by the Financial Accounting Standards Board (FASB). That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds and Money Market Funds - Mutual funds and money market funds are valued at published net asset value (NAV) of shares held at the end of the year.

As the investments measured at fair value in the Plan are held in funds which are valued at net asset value on a daily basis in active markets, they are considered Level 1 investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Tax Status

The Plan adopted a non-standardized form of a volume submitter plan that has received an opinion letter from the Internal Revenue Service as to the volume submitter plan's qualified status. The volume submitter plan opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Tax Status - Continued

The Plan has adopted FASB ASC 740-10, *Accounting for Uncertainty in Income Tax*. That standard prescribes a minimum recognition threshold and measurement methodology that a tax position taken or expected to be taken in a tax return is required to meet before being recognized in financial statements. It also provides guidance for de-recognition, classification, interest and penalties, accounting in interim periods, disclosure, and transition.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from these estimates.

Subsequent Events

Management of the Plan has evaluated subsequent events for disclosure through the date of the Independent Auditors' Report, the date the financial statements were available to be issued.

NOTE C - CERTIFIED FINANCIAL INFORMATION (UNAUDITED)

As permitted by the rules and regulations of the Department of Labor with respect to reporting and disclosure under ERISA, John Hancock Life Insurance Company has certified to the Plan Administrator that the investments (stated at fair value or contract value), together with all other transactions which affect those assets, are complete and accurate.
