Independent Auditor's Report

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of AVI Foodsystems, Inc. 401(k) Retirement Savings Plan A, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. #### NOTE A - DESCRIPTION OF PLAN

The following brief description of the AVI Foodsystems, Inc. 401(k) Plan A (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General:

The Plan is a defined contribution plan covering all employees of AVI Foodsystems, Inc. (Company), who are subject to union collective bargaining agreements. Eligibility requirements are set forth in each respective bargaining agreement. The Plan is administered by the Company and Principal Life Insurance Company (custodian or Principal) serves as the Plan's custodian and recordkeeper. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

##### Contributions:

Each year participants may contribute 1% to 20% of pretax annual compensation subject to limitations imposed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make rollover contributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The employer contribution for a participant shall be determined as stated in each respective bargaining agreement. A Company matching contribution shall be made for a participant only if he or she is eligible to receive such a matching contribution as outlined in the respective bargaining agreement. The matching contributions are invested according to the participants' investment elections. Contributions are subject to certain limitations as defined by the Plan. The Company's total matching contribution was \$318,500 in 2024.

##### Participant Accounts:

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions and any applicable allocations of the Company's contributions and investment earnings or losses, net of fees. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Investments:

Participants direct the investment of their contributions (including matching contributions) and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily, subject to certain restrictions on transfer frequency for certain investments. The Plan offers various pooled separate accounts, mutual funds, guaranteed interest accounts, and a common collective trust as investment options for participants.

Vesting:

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Participants are vested in the Company's contributions plus actual earnings thereon as follows:

Payment of Benefits:

For termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual installments over a period no longer than the maximum amount allowed by law or an annuity contract. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution if permitted criteria are achieved.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

Forfeitures:

Non-vested portions of terminated participants' accounts, as defined by the Plan, represent forfeitures. The Plan document permits the use of forfeitures to pay administrative expenses under the Plan which would otherwise be paid by the Company or to reduce Company contributions. Forfeited nonvested accounts totaled \$0 for the years ended December 31, 2024 and 2023, respectively. Forfeitures by participants who withdrew before becoming fully vested were \$4,571 in 2024 and were used to reduce Company contributions during the year.

Transfers:

Along with the Plan, the Company sponsors a 401(k) plan, AVI Foodsystems, Inc. 401(k) Retirement Savings Plan, for substantially all other non-union employees. If employees change their status during the year, their plan eligibility would change and they may request to transfer their account balances to the affiliated plan, and vice versa. For the year ended December 31, 2024, transfers to and from the Plan reported in the statement of changes in net assets available for benefits were \$11,710 and \$85,834, respectively.

Participant Loans:

The Plan does not permit the issuance of loans to participants.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition:

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on the investments bought and sold, as well as held during the year.

Payment of Benefits:

Benefit payments to participants are recorded when paid. There were no participants who elected to withdraw from the Plan but had not yet been paid at December 31, 2024 and 2023.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

##### Administrative Expenses:

Administrative expenses of the Plan not paid by the Company may be paid out of the assets of the Plan provided such payments are consistent with ERISA. A portion of administrative expenses were paid by the Plan in 2024. Management fees and operating expenses charged to the Plan for investment management services are deducted from income earned on a monthly basis and are not separately reflected. Consequently, such management fees and operating expenses are reflected as a reduction of investment return for such investments.

##### Subsequent Events:

The plan administrator has evaluated all activity of the Plan through September 12, 2025, the date the financial statements were available to be issued, and concluded that no subsequent events have occurred that would require recognition or disclosure in the financial statements or notes.

#### NOTE C - INFORMATION CERTIFIED BY THE CUSTODIAN

In accordance with section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator has elected to restrict the scope of the auditor's examination with regard to statements or information prepared and certified by Principal Life Insurance Company, the custodian of the Plan. We have been informed by the plan administrator that the custodian holds the Plan's investment assets and executes investment transactions. The custodian has certified as to the completeness and accuracy of the investments it holds and changes in net assets arising from said investment activity as of December 31, 2024 and 2023, and for the year ended December 31, 2024, and the schedule of assets (held at end of year) as of December 31, 2024.

#### NOTE D - INVESTMENTS AND FAIR VALUE MEASUREMENTS

FASB ASC 820 requires the Plan to classify its assets and liabilities based on valuation methods using three levels. Level 1 inputs are based on quoted prices in active markets for identical investments. Level 2 inputs are based on quoted prices in active markets for similar investments and quoted prices in inactive markets. Level 3 inputs are based on significant unobservable inputs that reflect the Plan's determination of assumptions that market participants might reasonably use in valuing the investments. The valuation levels are not necessarily an indication of risk or liquidity associated with the underlying investments.

#### NOTE D - INVESTMENTS AND FAIR VALUE MEASUREMENTS (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used attempt to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts* – The fair value of pooled separate accounts is measured using the net asset value (NAV) per unit, based on the fair value of the underlying assets, as a practical expedient. The investments underlying the Plan's pooled separate accounts primarily include domestic and international equities and domestic fixed income securities.

*Common Collective Trust* – The fair value of the common collective trust is measured using the net asset value (NAV) per unit, based on the fair value of the underlying assets. The investments underlying the Plan's common collective trust include stable value investment contracts issued by life insurance companies, banks and other financial institutions.

*Mutual Funds* – The fair value of the mutual funds is based on quoted net asset values of the shares held by the Plan at year end.

*Guaranteed Interest Accounts* – The Plan's investments include various non-benefit responsive Guaranteed Interest Accounts (GIA) with Principal Life Insurance Company. These GIA's cannot be sold to a third-party; however, funds can be withdrawn prior to maturity. The fair value is the discontinuance value which is the amount the Plan participant would receive if they transfer or withdraw their funds prior to maturity. The fair value is computed using a combination of the current interest rates based on remaining investment terms at the reporting date as well as the interest rate on the account. If the applicable interest rate is greater than the interest rate on the account, the fair value is the contract value reduced by a percentage. This percentage is equal to the difference between the applicable interest rate and the interest rate on the account, multiplied by the years (including fractional years) until the maturity date. If the applicable interest rate is equal to or less than the interest rate on the account, the fair value is equal to the contract value.

Plan management works with the custodian to establish fair value of Level 3 investments. Determination of fair value includes consideration of the specified terms of each contract, the quality of the issuer, liquidity needs of the fund and relevant market information for similar instruments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. The Plan independently computed the fair value of the GIA using a discounted cash flow model which produced a fair value approximately the same as the discontinuance method utilized by Principal.

Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) Invests in common stocks of foreign and domestic entities, other Principal separate accounts and fixed income funds. The investment policy is to seek long-term capital growth with some current income.
- (b) Invests primarily in securities that are AAA rated or issued by the US government, its agencies or instrumentalities. Investments are focused on perceived undervalued securities that fund management believes represent good long-term investment opportunities.

- (d) Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at net asset value without any redemption notice. The 30 day holding period for certain investments applies to participant directed transfers out of the indicated investments, which permit only one transfer per 30 day period. Once the number of allowed transfers out is met, participants are not allowed to transfer back into this investment option until the holding period lapses. Contributions into the investment option are not impacted.

#### NOTE F - GUARANTEED INTEREST ACCOUNTS WITH INSURANCE COMPANY

The Plan's investments include various non-benefit responsive GIA's with Principal. These GIA's are valued at fair value. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and is charged for participant withdrawals. Participants may ordinarily direct the withdrawal or transfer of all of or a portion of their investment at contract value, however, there is a possible market value adjustment for transfers to other investment options from the guaranteed accounts. The GIA's permit withdrawal at contract value for a benefit event, such as termination, death, disability or retirement. However, there is a market value adjustment, which is also called a surrender charge, when funds are withdrawn prior to maturity or for a non-benefit event, such as withdrawal from the account for a change in investment option.

#### NOTE G - INCOME TAXES

In a letter dated June 30, 2020, the Internal Revenue Service has informed the Plan that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

#### NOTE H - EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are a share of pooled separate accounts, GIA's, and common collective trusts managed by Principal Life Insurance Company. Principal Life Insurance Company is the custodian and recordkeeper, as defined by the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid for investment management services are included as a reduction of the return earned on each fund.

#### NOTE I - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their entire account balances maintained under the Plan.

#### NOTE J - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
