- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) and Schedule of Delinquent Participant Contributions as of December 31, 2024 and for the year then ended, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A | DESCRIPTION OF PLAN

The following description of the Every Child's Hope 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan, which was adopted on January 1, 2003, by Evangelical Children's Home (the "Organization"), is a defined contribution 401(k) profit sharing plan covering all eligible employees of the Organization. All employees with exception of leased employees, non-resident aliens and residents of Puerto Rico are eligible to make salary reduction contributions. An employee will become eligible and automatically enrolled for employer based contributions after meeting the Plan's eligibility requirements of age 21 according to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

The Plan was most recently amended and restated in accordance with IRS Notice 2017-37 effective February 1, 2023 to adopt a non-standardized pre-approved plan with Standard Retirement Services, Inc. Effective with this amendment, the Plan was renamed from Evangelical Children's Home's 401(k) Profit Sharing Plan to Every Child's Hope 401(k) Plan. The Plan was also amended to eliminate service requirements for employer based contributions of 1 year of service and increase such contributions for each Plan year equal to 100% of the salary reduction amount he or she contributes to the Plan that does not exceed 4% of his or her compensation received during that Plan year. Effective with this amendment the discretionary profit sharing contribution was eliminated, accounts attributable to employer matching contributions are determined under the new vesting schedule.

Contributions

In 2024, participants may contribute up to an annual maximum of \$23,000 of pre-tax or after tax annual compensation as defined by the Plan and up to an annual maximum of \$22,500 in 2023. Participants who have attained age 50 before the end of the Plan year are eligible to make catchup contributions of \$7,500 for 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Employees are automatically enrolled in the Plan at a pre-tax basis at 3% of eligible compensation as of the enrollment date.

Each participant who has satisfied the eligibility requirement according to the Plan of age 21, shall be entitled to receive employer based matching contributions for each Plan year equal to 100% of the salary reduction amount he or she contributes to the Plan that does not exceed 4% of his or her compensation received during that Plan year. However, catchup contributions are not matched.

Participant Accounts

Each participant's account is credited with the participant's contribution, including amounts rolled over from qualified plans, and the Organization's matching contributions, and an allocation of the Plan's earnings net of any plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary and rollover contributions, plus actual earnings thereon.

Prior to February 1, 2023, vesting in the Organization’s base contribution portion of their accounts was based on years of continuous service as outlined below:

Effective February 1, 2023, the vesting schedule was changed as follows:

In addition, participants are 100% vested upon reaching the normal retirement age of 65. In the event of death or disability while employed, a participant becomes 100% vested.

Forfeited Accounts

Participants who terminate their employment and are less than 100% vested in their employer account will forfeit the non-vested portion. Forfeitures which occur during a Plan year shall be applied first to restore the forfeited portion of account balances of re-employed participants. Prior to February 1, 2023, any remaining forfeitures are allocated to the accounts of participants active in the Plan in the ratio of the participant’s compensation to the total compensation of all eligible participants for the year. Effective February 1, 2023, forfeitures can be used to pay Plan expenses or used to reduce employer contributions. Forfeitures of \$14,000 and \$26,043 were used to reduce employer contributions during 2024 and 2023, respectively. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$13,175 and \$283, respectively.

Notes Receivable from Participants

The Plan document includes provisions authorizing loans to active eligible participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 reduced by the highest outstanding balance of any prior loans from the Plan during the prior one-year period or 50% of the participant's vested account balance. Participants may not initiate more than two loans in one calendar year consisting of one regular loan and one for a primary residence. All loans are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator.

NOTES TO FINANCIAL STATEMENTS

Prior to February 1, 2023, loans were available to participants through Mutual of America. Plan loans were not considered Plan assets. Loans were issued directly from the funds owned by Mutual of America and loan proceeds were not removed from the participant's account balance. However, an amount equal to the principal balance of the loan plus 20% was transferred within the participant's individual account into the Mutual of America Interest Accumulation Account and held as collateral and restricted for participant use until the loan was repaid. As loan payments were made by the participant to the Custodian, the amount required to be held in the Interest Accumulation Account was reduced by the principal amount paid. A corresponding adjustment to the 20% additional amount was also made upon receipt of each payment.

Effective February 1, 2023, loans are available to participants through their own fund accounts and are considered Plan assets. The participant's vested account balance under the Plan is pledged as collateral for the loan.

Participant Hardship Withdrawals

Participants may withdraw from the Plan that portion of their account resulting from salary deferrals and vested employer contributions in the event of undue financial hardship. The maximum hardship withdrawal is the total of a participant's 100% vested balance. Any amounts due to a hardship must be distributed in a single sum.

Payment of Benefits

Upon termination of service due to death, disability, early retirement (age 55), retirement (65), or other reasons, a participant may elect to receive an amount equal to the value of the participants' vested interest in his or her account. Upon death or disability of a participant while employed, the account balance becomes fully vested. The Plan also allows for in-service distributions at age 59 ½.

On termination of service, if the total vested account balance does not exceed \$5,000, the participant's vested account balance may be distributed automatically in a lump sum. If the total vested account balance equals or exceeds \$5,000, participants may elect to receive a lump sum equal to the value of their vested account balance, as described under the Plan document. As an alternative to a cash distribution, the participant may have the payment paid as a "direct rollover" to an IRA or another qualified plan.

Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their employer contributions.

NOTE B | SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan prepares its financial statements on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Valuation of Investments and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on their ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Expenses

Expenses are paid by the Organization and the participants. Expenses paid by the Organization are excluded from the financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

Plan Tax Status

The Plan sponsor adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subjected to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 15, 2025, the date the financial statements were available to be issued.

NOTE C | CERTIFICATION OF INVESTMENT INFORMATION

Mutual of America Life Insurance Company, the custodian for the Plan from January 1, 2023 to January 31, 2023, and Reliance Trust Company, the custodian for the Plan from February 1, 2023 to December 31, 2024, have certified that all information provided and included in the accompanying financial statements as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, and supplemental schedules. Accordingly, this information was not audited. The following is a summary of information which is furnished by the custodians.

NOTE D | FAIR VALUE MEASUREMENT

FASB *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The Plan did not have any investments meeting this valuation measurement criteria.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-ended mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Cash reserve funds are valued at amortized costs, which approximates fair value.

NOTE E | FULLY BENEFIT RESPONSIVE INVESTMENT CONTRACT

The Plan holds a group annuity investment contract that meets fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for the fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of the guaranteed interest account at December 31, 2024 and 2023, was \$519,057 and \$505,591, respectively.

The guaranteed interest account is designed to accrue interest based on a crediting rate established by the contract issuer. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan (1%). The crediting rate is reviewed on the quarterly basis for resetting and was 2.09% and 1.59% at December 31, 2024 and 2023, respectively. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Additionally, certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include (1) the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code, (2) premature termination of the contract, (3) plan termination or merger, (4) changes to the Plan's prohibition on competing investment options, (5) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary).

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreements without the consent of the issuer.

NOTE F | RELATED PARTY TRANSACTIONS AND PARTIES-IN-INTEREST

The Plan incurs expenses related to general administration and record keeping. Some of these expenses are charged to participant accounts while certain accounting and auditing fees related to the Plan may be paid by the plan sponsor. Expenses that are paid by the plan sponsor are not included in these financial statements. During 2024 and 2023, approximately \$16,200 and \$16,275 of administrative expense were paid by the plan sponsor on behalf of the Plan. These transactions qualify as party-in-interest transactions as defined by ERISA.

Standard Retirement Services, Inc., the third-party administrator of the Plan, manage certain Plan investments. Therefore, these transactions qualify as party-in-interest transactions and are denoted as such on the supplemental schedule of assets (held at end of year).

NOTE G | RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE H | PROHIBITED OR NON-EXEMPT TRANSACTIONS

The Plan Sponsor failed to remit participant contributions on a timely basis in the amount of \$220 for the year ended December 31, 2024. The Plan Sponsor corrected these amounts in 2024 and are working to correct any interest on the contributions owed.
