(1) Description of Plan

The following description of the Towne Park (the Company) 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan permitting employee contributions for all eligible employees of the Company who have attained age twenty-one or older and who have completed three months of service for employee contributions. A participant is eligible for employer contributions after one year of service. All of the employees of the Company are eligible to participate in the Plan except for nonresident aliens, leased employees, residents of Puerto Rico, employees covered by a collective bargaining agreement and intern and student program employees. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees is responsible for the oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

The Plan provides that eligible employees may elect to make pre-tax contributions through regular payroll deductions of an amount up to 100% of their eligible compensation, as defined in the Plan. Participants' pre-tax contributions are limited to the maximum amount allowable under the Internal Revenue Code (IRC). Qualified distributions from other retirement plans can be contributed to and retained by the Plan as rollover contributions. Participants may also make after-tax Roth contributions. Participants who have attained age 50 before the end of the Plan year may make additional catch up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an employer matching contribution, which was calculated based on 50% of participant contributions up to 4% of compensation. The Company may also make discretionary non-elective contributions. No such contribution was made for the year ended December 31, 2024.

Participant Accounts

Individual accounts are maintained for each participant. Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contribution, the Company's contribution and allocations of (a) the Company's discretionary contribution, if any, and (b) Plan earnings net of expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(1) Description of Plan, Continued

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and non-elective contributions is based on years of service. A participant is 100% vested after three years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are permitted to have a maximum of one loan outstanding at any given time. Loan terms range from 1 to 5 years, or longer if the proceeds are used for the purchase of the participant's primary residence. The loans are secured by the balance in the participants' accounts. All loans shall bear interest at rates comparable to those offered by financial institutions at time of note origination (ranging from 4.25% to 9.50% at December 31, 2024). The interest rate will remain fixed for the duration of the loan. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Payments of benefits are generally in the form of lump-sum distributions. Upon attaining the normal retirement age (age 65), death, or permanent disability, a participant is entitled to 100% of his or her account balance. If employment is terminated for reasons other than normal retirement, death, or permanent disability, a participant is entitled to his or her vested account balance. The Plan allows for distributions in the event of financial hardship, subject to certain restrictions of the Plan.

Forfeited Amounts

The forfeited, nonvested portion of the participants' account balances are generally used to reduce future Company contributions or administrative fees. At December 31, 2024 and 2023, forfeited non-vested accounts total \$70,390 and \$87,745, respectively. During 2024, \$111,134 of forfeitures were used to reduce employer matching contributions and administrative fees.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information provided by the recordkeeper. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses related to the administration of the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and processing of distributions are charged directly to the affected participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued.

Effective July 1, 2025, employees of United Parking Partners became eligible to participate in the Plan. The Unified Parking Partners 401k Plan is expected to be merged into the Plan in October 2025.

(3) Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year), including investments at fair value and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from the information certified as complete and accurate by Fidelity Management Trust Company (Fidelity), a qualified institution.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the NAV of units of a common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

(5) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

(6) Tax Status

The Plan uses a prototype document sponsored by Fidelity Management & Research Company. Fidelity Management & Research Company received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the prototype document and related trust are designed in accordance with applicable provisions of the IRC and, is therefore, exempt from federal income taxes. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Related Party Transactions and Party-In-Interest Transactions

Administrative expenses paid by the Plan related to activity and asset based transactions amounted to \$200,055 for 2024. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(9) Non-Exempt Transactions

During 2024, 2023, and 2019, participant deferrals and loan repayments totaling \$11,578, \$967 and \$9,441, respectively, were remitted to the Plan outside the required time frame as required by the DOL. The DOL considers delinquent contributions to be prohibited transactions and they are to be disclosed as a supplemental schedule to the financial statements. The Company corrected \$7,198 of these prohibited transactions during 2024. Management is in the process of making the remaining necessary earnings corrections to the Plan for these periods.

(10) Corrective Distributions

The Plan has recorded a liability as of December 31, 2024 and 2023 on the statement of net assets available for benefits related to non-discrimination testing failures. The corrective distributions required to comply with the testing failures were made in each subsequent plan year.
