Note 1. Description of Plan

The following description of The 401(k) Savings Plan for the Employees of Credit Industriel et Commercial (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1993 and amended and restated effective January 1, 2024. The Plan is a defined contribution plan, for the benefit of the employees of Crédit Industriel et Commercial and its affiliated employers (Company or Plan Sponsor), as defined. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Plan is administered by the CIC Pension Committee (Committee). The Committee has overall responsibility for the operation and the administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan was amended, effective January 1, 2024 to allow participants to make Roth contributions and to allow ROTH rollovers into the Plan.

Eligibility

All employees are eligible to participate in the Plan except for the following ineligible classes of employees: 1) leased employees; and 2) employees who are non-resident aliens who do not receive earned income from sources within the United States or are residents of Puerto Rico. An employee must also complete at least three months of employment and attain the age of 21 to become eligible to participate in the Plan. An eligible employee who has satisfied the eligibility requirements can become a participant in the Plan on the first day of the month coinciding or after meeting the eligibility criteria.

Contributions

Participants may elect to contribute up to 75% of their compensation, as defined, as Pre-tax Roth deferral contributions not to exceed statutory limitations permitted by the Internal Revenue Code (IRC). Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing eligible rollovers from other qualified plans. Participants may change their contribution percentages each pay period.

The Company is required to make matching contributions on a pay-period basis equal to 50% of the participant's pre-tax deferral contributions (excluding catch-up contributions) that do not exceed 6% of their compensation, as defined.

Additional discretionary true-up matching and qualified matching contributions may be made at the option of the Company's management. For the year ended December 31, 2024, the Company elected to make true-up matching contributions of \$105,503.

Participant Accounts

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a money market fund as investment options for participants. Each participant account is credited with the participant's contributions and allocations of (a) the Company's contributions, and (b) Plan earnings (losses), and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, or account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company’s matching contributions, discretionary true-up matching and qualified matching contributions, plus actual earnings thereon is as follows:

Benefits Paid to Participants

A participant’s vested interest in the Plan’s assets are distributable generally upon termination, normal retirement age (65), early retirement which is the later of age (55) or 10 years of vested service, disability, or death. Participants may withdraw from their individual accounts pursuant to specific guidelines as set forth in the plan document.

Forfeitures

The portion of a participant’s balance which is not vested upon termination of employment is forfeited and remains in the Plan. Forfeited non-vested accounts are used to reduce future Company contributions and to pay Plan expenses. Forfeitures from participants was \$20,342 for the year ended December 31, 2024. The available balance of forfeitures for both years ended December 31, 2024 and 2023 was \$0.

Administrative Expenses

Qualified administrative expenses are paid by the Plan. All other administrative expenses of the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits Paid to Participants

Benefit payments to participants are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 1, 2025, the date the financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.

Note 3. Information Certified by the Plan's Trustee

The following is a summary of the investment information regarding the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared or derived from information provided by T. Rowe Price Trust Company, the trustee of the Plan, and furnished to the Plan administrator. The plan administrator has obtained a certification from the trustee that such information is complete and accurate.

Note 4. Fair Value Measurements

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB 820 are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Significant unobservable inputs, including the Company's own assumptions in determining the fair value of investments.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023:

Money market fund: Valued at cost plus accrued interest, which approximates fair value.

Mutual funds: Mutual funds are stated at fair value based on quoted prices in an active market for each share held by the Plan.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related Party Transactions

Certain plan investments were shares of mutual funds managed by T. Rowe Price Trust Company (T. Rowe) and therefore, these transactions qualify as party-in-interest transactions. Fees paid to T. Rowe by the Plan amounted to \$330 for the year ended December 31, 2024. Services rendered by the Plan's investment advisor, Newport Capital Group LLC (Newport), qualify as party-in-interest transactions. Fees paid to Newport totaled \$72,552, for the year ended December 31, 2024.

T. Rowe provides the Plan with an administrative budget of \$59,000 per year (\$14,750 per quarter), which is established as an account and can be used by the Plan to pay certain administrative expenses, as directed by the Plan Sponsor. Any amounts credited to the administrative budget and not used in the year are credited to the participants as determined by the plan administrator. For the year ended December 31, 2024, \$59,000 was provided and credited to the administrative budget and is included in other income on the statement of changes in net assets available for benefits.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

On August 19, 2020, the Internal Revenue Service (IRS) stated that the prototype plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in mutual funds and a money market fund. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
