## **Note 1. Description of Plan**

### ***General***

The following brief description of the Dibble & Associates Consulting Engineers, Inc. 401(k) Profit Sharing Plan (Plan) is provided for general information purposes only. Participants should refer to the plan document for a complete description of the Plan's provisions.

The Plan was established on January 1, 1995 and amended and restated effective January 1, 2021. The Plan is a multiple-employer, defined contribution plan covering all eligible employees of Dibble & Associates Consulting Engineers, Inc. and Dibble, CM, LLC (collectively, Company or Plan Administrator) who are 21 years of age or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

### ***Contributions***

Each year, participants may contribute 90% of their pretax compensation to the Plan. Participants may also contribute after tax compensation to the Plan in the form of Roth contributions. Contributions are subject to limitations prescribed by the Internal Revenue Service. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching and discretionary profit-sharing contributions to the Plan. For the years ended December 31, 2024 and 2023, the Company matched 100% of deferrals up to 2.5% of a participant's compensation. During 2024 and 2023, the Company made matching contributions of approximately \$423,000 and \$355,000, respectively. Additionally, during 2024 and 2023, the Company made discretionary profit-sharing contributions of approximately \$29,200 and \$29,200, respectively, which were all allocated through forfeitures. Contributions are subject to certain limitations.

The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan currently offers various mutual funds as investment options for participants.

### ***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and the Company's matching contribution, as well as allocations of the Company's profit-sharing contribution and plan earnings and losses. Participants may be charged with an allocation of administrative expenses that are paid by both the Plan and participant. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

***Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in Company matching and Company profit-sharing contributions, plus actual earnings thereon, is based on years of credited service, as defined, with the Company, in accordance with the following schedule:

***Notes Receivable From Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, limited to two outstanding loans at a given time. The loans are secured by the balance in the participant's account. The loan interest rate is set at the prime rate, as defined. Loans must be repaid over a period not extending beyond five years from the date of the loan, unless such loan is used to purchase a principal residence. The maximum loan term for a principal residence loan is 20 years. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

On termination of service, including due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in their account in a lump sum distribution, or in annual installments, as defined.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$34,300 and \$29,200, respectively. Forfeited nonvested accounts may be used to reduce Company contributions, allocated as Company contributions, or used to pay reasonable expenses of the Plan. During 2024 and 2023, approximately \$34,300 and \$29,200, respectively, of forfeitures were allocated as Company discretionary profit-sharing contributions among eligible participants.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements of the Plan have been prepared on the accrual basis.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets and the reported amounts of additions to and deductions from net assets. Accordingly, actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

***Notes Receivable From Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Payments of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Administrative expenses, including but not limited to bank charges, investment fees, commissions, accounting and auditing fees, and similar charges may be paid by the Company. If not paid by the Company, then such charges will be paid by the Plan. Expenses related to specific participant transactions (*i.e.*, distribution request, etc.) may be charged directly against the appropriate participant's account.

**Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company, a qualified institution, has certified the following investment information included in the accompanying statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are in mutual funds managed by Capital Bank and Trust Company and American Funds. Capital Bank and Trust Company is the custodian, as defined by the Plan, and American Funds is the record-keeper, and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments. As described in Note 2, expenses for benefits paid to participants are charged directly to the participant's account. Additionally, the Plan uses other service providers for professional services, and transactions with these providers qualify as party-in-interest transactions.

**Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and significant to the fair value of the assets or liabilities

***Recurring Measurements***

The following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**Note 7. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by CCH Incorporated DBA FTWILLIAM.COM. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Risks and Uncertainties**

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate fluctuation, market fluctuation, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits and changes in net assets available for benefits.
