## **INDEPENDENT AUDITORS' REPORT**

To the Participants and Administrator of the Lafayette 148, Inc. 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Lafayette 148, Inc. Employee Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lafayette 148, Inc. Employee Benefit Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all

material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Lafayette 148, Inc. Employee Benefit Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. **1. DESCRIPTION OF THE PLAN**

The following description of the Lafayette 148, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a multiple-employer defined contribution plan established for the benefit of the employees of Lafayette 148, Inc. (referred to as the “Company”). The Plan covers all employees of the Company who have reached the age of 21 or older and have completed three months of service. The Plan was created under Section 401(k) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions**

The Plan is funded through contributions under compensation reduction agreements.

Each year, the participants may elect to contribute up to 60% of their compensation to the Plan, subject to certain limitations imposed by the Internal Revenue Code. The annual limitation for the year ended December 31, 2024 was \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions not to exceed \$7,500 for 2024. The amount of the Company’s contributions to the Plan is subject to the limitations imposed by law on the maximum amount which can be contributed. The Company’s matching contribution is equal to 50% of the participants’ first 6% of their compensation contribution. The Company’s contributions, net of forfeited accounts, for the year ended December 31, 2024 were \$269,840.

**Participant Accounts**

Each participant’s account is credited with their contributions and the allocation of the Company’s matching contributions and Plan earnings (losses). Allocations are based on the participant’s earnings or account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Participants' Investment Options**

Participants must direct their salary deferral contributions and the Company's matching contributions, if any, to selected investments made available and determined by the Plan Administrator. Participants may change their investment options at any time throughout the year via internet access to Fidelity Workplace Services LLC.

**Vesting**

Employee contributions to the Plan are fully vested upon receipt by the Plan. Vesting in the Company's matching contribution portion of their accounts is determined under the following schedule and is based on vesting years of service.

**Notes Receivable from Participants**

Participants may borrow from their fund account a minimum loan of \$1,000 up to a maximum of the lesser of one-half their vested account balance or \$50,000 reduced by the highest outstanding loan balance in their account during the prior twelve-month period. Up to 50% of a participant's vested account balance may be used as collateral for any loan. Only one loan may be outstanding at any given time. Loans shall bear a reasonable rate of interest as determined by the Plan Administrator based on the prevailing interest rates charged by persons in the business of lending money. The interest rate shall remain fixed throughout the duration of the loan. All loans must be repaid through after-tax payroll deductions on at least a quarterly basis over a five-year period unless it is for the purchase of a principal residence, in which case the loan repayment period may not extend beyond 10 years. Loan interest received by the Plan for the year ended December 31, 2024 was \$22,190. Loans outstanding, presented as notes receivable from participants in the accompanying statements of net assets available for benefits, was \$302,874 and \$300,773 as of December 31, 2024 and 2023, respectively.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a minimum required distribution until all assets in a participant's account are distributed. Generally, if a participant terminates his or her employment with the Company, they can elect to receive a distribution of their vested balance in the Plan.

**Forfeited Accounts**

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$75,998 and \$59,149 respectively. During the year ended December 31, 2024, employer contributions were not reduced using forfeited credits.

**Plan Termination or Merger**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants would become fully vested with all rights to any amounts in their respective account.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Although these estimates are based on management's knowledge of current events and actions it may undertake in the future, they may ultimately differ from actual results.

**Participant Notes Receivable**

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest, if any. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value based on the quoted market closing prices at the end of the last business day of the Plan year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes gains and losses on investments bought and sold as well as held during the year.

Benefits are recorded when paid.

**Related Party Transactions**

The Company pays certain administrative expenses of the Plan, which consist of audit fees and Plan maintenance fees. Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company (“Fidelity”), the trustee as defined by the Plan. Fidelity is a party-in-interest. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**Administrative Expenses**

Administrative expenses, such as the trustee’s custodial and administrative fees, are paid by the Plan. Accounting and auditing fees are paid by the Company. Administrative expenses for loans, distributions and withdrawals are paid by the participants.

**Risks and Uncertainties**

The Plan provides for various investment options in a number of mutual funds. Such investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with such investments and the level of uncertainty related to changes in the values of such investments, it is at least reasonably possible that changes in the values of the Plan’s investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

**4. INFORMATION PREPARED AND CERTIFIED BY PLAN TRUSTEE**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA as applicable to certain investments. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Fidelity, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedule. The information certified includes total investments of \$45,435,412 and \$38,345,541 and total participant notes receivable of \$302,874 and \$300,773 at December 31, 2024 and 2023, respectively, and the related investment income of \$7,135,388 and interest income of \$22,190 on notes receivable from participants for the year ended December 31, 2024.

**5. INCOME TAXES**

The Internal Revenue Service (the "IRS") has determined and informed the Company by a letter dated March 1997, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the "IRC"). The Plan adopted certain provisions of the Economic Growth and Tax Reconciliation Act of 2001, effective January 1, 2002 as good faith compliance with requirements of the Act.

Accounting principles generally accepted in the United States of America requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained up examination by the IRS. The Plan does not have any uncertain tax positions.

The Plan is subject to routine audits by the tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

**6. FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, defines fair value as the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity.

FASB ASC 820 specifies a hierarchy of valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (observable inputs). In accordance with FASB ASC 820, the following summarizes the fair value hierarchy:

- Level 1 Inputs: Unadjusted quoted market prices for identical assets and liabilities in an active market that the Plan has the ability to access.
- Level 2 Inputs: Inputs other than the quoted prices in level 1, that are observable either directly or indirectly.
- Level 3 Inputs: Inputs, based on prices or valuation techniques that are both unobservable and significant to the overall fair value measurements.

FASB ASC 820 requires the use of observable market data, when available, in making fair value measurements. When inputs used to measure fair value fall within different levels of the hierarchy, the level within which the fair value measurement is categorized is based on the lowest level input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their net asset value and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
