We have performed audits of the accompanying financial statements of Acro Industries, Inc. 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1: DESCRIPTION OF THE PLAN

The following description of Acro Industries, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of Acro Industries, Inc. (the Company) who have three months of service for 401(k) deferrals. For employer matching contributions or employer discretionary contributions, employees must complete three months of service and attain the age of 20. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan became effective on July 1, 1989.

Employee Contributions - Each year, participants of the Plan may elect to contribute up to a maximum amount as determined by section 401(k) of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Employer Contributions - Profit sharing amounts may be contributed at the option of the Company. For the years ended December 31, 2024 and 2023, the Company did not contribute to the Plan.

Participants' Accounts - Each participant's account is credited with the participant's voluntary contribution, the Company's matching contributions, and Plan earnings, which are allocated proportionately among all participants based on their investment in each fund.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of participation in the Plan. A participant is 100% vested after six years of participation in the Plan.

Participant Loans - Participants may borrow a minimum of \$1,000 and up to a maximum of \$50,000 or 50% of their vested account balance, whichever is lower. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest may be repaid over a period not to exceed five years.

Termination Rights - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the employer contributions allocated to their accounts.

Payments of Benefits - Upon termination of employment, the participant's attainment of normal retirement age, participant's disabilities or termination of the Plan, the vested portion of a participant's individual account shall be distributed to the participant in a lump sum payment; as soon as administratively feasible, following the date on which a distribution is requested or is otherwise payable.

Forfeitures - Forfeitures of non-vested employer contributions will occur in the Plan year when a terminated participant receives a distribution of his entire vested account. Forfeitures may be used to pay administrative expenses of the plan. At December 31, 2024 and 2023, there was \$375 and \$356, respectively remaining in a holding account to be used to pay future administrative expenses of the Plan.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation - The accompanying financial statements have been prepared on the accrual basis of accounting, which recognizes income when earned and expenses when incurred.

Notes Receivable from Participants - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Investment Held in Trust - Mid Atlantic Trust Company is the trustee of the Plan and holds the Plan's investment portfolio.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year-end. Participant loans are valued at amortized cost, which represents fair value.

Purchases of sales and securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Plan and are included in administrative expenses.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Information Certified by the Trustees - The Plan administrator has elected the compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under the election, no audit procedures have been performed with respect to information certified as complete and accurate by the trustee except for comparing such information to that included in the Plan's financial statements. Amounts included in the accompanying financial statements that are certified by the trustee are listed in Note 4.

Subsequent Events - In preparing these financial statements, the Company has evaluated events and transactions for potential recognition and disclosure through September 25, 2025, the date the financial statements were available to be issued.

NOTE 3: FAIR VALUE MEASUREMENTS

FASB ASC 820 "Fair Value Measurements and Disclosures" establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual and money market funds - Valued at net asset value (NAV) of shares held by the plan at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with the other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5: RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Genesee Valley Trust Company. Genesee Valley Trust Company (a fully owned subsidiary of Canandaigua National Corporation) is the designated advisor of the Plan and, therefore, these transactions qualify as party-in-interest transactions. For the years ended December 31, 2024 and 2023, fees paid by the Plan for these investment management services amounted to \$25,171 and \$24,347, respectively.

NOTE 6: TAX STATUS

The Plan has obtained its latest determination letter dated April 2, 2012, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.

The following description of Acro Industries, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of Acro Industries, Inc. (the Company) who have three months of service for 401(k) deferrals. For employer matching contributions or employer discretionary contributions, employees must complete three months of service and attain the age of 20. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan became effective on July 1, 1989.

Employee Contributions - Each year, participants of the Plan may elect to contribute up to a maximum amount as determined by section 401(k) of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Employer Contributions - Profit sharing amounts may be contributed at the option of the Company. For the years ended December 31, 2024 and 2023, the Company did not contribute to the Plan.

Participants' Accounts - Each participant's account is credited with the participant's voluntary contribution, the Company's matching contributions, and Plan earnings, which are allocated proportionately among all participants based on their investment in each fund.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of participation in the Plan. A participant is 100% vested after six years of participation in the Plan.

Participant Loans - Participants may borrow a minimum of \$1,000 and up to a maximum of \$50,000 or 50% of their vested account balance, whichever is lower. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest may be repaid over a period not to exceed five years.

Termination Rights - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the employer contributions allocated to their accounts.

NOTE 1: DESCRIPTION OF THE PLAN (CONTINUED)

Payments of Benefits - Upon termination of employment, the participant's attainment of normal retirement age, participant's disabilities or termination of the Plan, the vested portion of a participant's individual account shall be distributed to the participant in a lump sum payment; as soon as administratively feasible, following the date on which a distribution is requested or is otherwise payable.

Forfeitures - Forfeitures of non-vested employer contributions will occur in the Plan year when a terminated participant receives a distribution of his entire vested account. Forfeitures may be used to pay administrative expenses of the plan. At December 31, 2024 and 2023, there was \$375 and \$356, respectively remaining in a holding account to be used to pay future administrative expenses of the Plan.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation - The accompanying financial statements have been prepared on the accrual basis of accounting, which recognizes income when earned and expenses when incurred.

Notes Receivable from Participants - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Investment Held in Trust - Mid Atlantic Trust Company is the trustee of the Plan and holds the Plan's investment portfolio.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year-end. Participant loans are valued at amortized cost, which represents fair value.

Purchases of sales and securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Plan and are included in administrative expenses.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Information Certified by the Trustees - The Plan administrator has elected the compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under the election, no audit procedures have been performed with respect to information certified as complete and accurate by the trustee except for comparing such information to that included in the Plan's financial statements. Amounts included in the accompanying financial statements that are certified by the trustee are listed in Note 4.

Subsequent Events - In preparing these financial statements, the Company has evaluated events and transactions for potential recognition and disclosure through September 25, 2025, the date the financial statements were available to be issued.

NOTE 3: FAIR VALUE MEASUREMENTS

FASB ASC 820 "Fair Value Measurements and Disclosures" establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual and money market funds - Valued at net asset value (NAV) of shares held by the plan at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with the other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5: RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Genesee Valley Trust Company. Genesee Valley Trust Company (a fully owned subsidiary of Canandaigua National Corporation) is the designated advisor of the Plan and, therefore, these transactions qualify as party-in-interest transactions. For the years ended December 31, 2024 and 2023, fees paid by the Plan for these investment management services amounted to \$25,171 and \$24,347, respectively.

NOTE 6: TAX STATUS

The Plan has obtained its latest determination letter dated April 2, 2012, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.
