



**NOTE 1 DESCRIPTION OF PLAN**

The following description of Edison Electric Institute Cooperative Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan originally effective July 1, 1974, covering employees of Edison Electric Institute (the Employer). The Plan is available to substantially all employees of the Employer, however seasonal employees and interns are not eligible to participate in the Plan. Participants may begin participation in the Plan on the first day of the month following the day he or she has completed one hour of service. The Plan has been amended and restated throughout the years to comply with tax legislation. The plan was amended in 2023 for updates to the vesting service schedule, as well as to incorporate certain provisions of the Secure 2.0 Act passed by Congress. The Plan is subject to the provisions of ERISA, as amended.

**Contributions**

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are automatically enrolled in the Plan at a rate of 6% upon becoming eligible unless they affirmatively elect a different deferral rate or opt out. Participants who are subject to an automatic election may change or suspend any automatic election no less than 30 days following distribution of the notice of automatic election. Participants may defer up to 85% of eligible compensation as pre-tax or Roth after-tax 401(k) contributions to the Plan. Eligible participants are also permitted to contribute up to 10% of after-tax compensation. Participants age 50 or older are allowed to make catch-up contributions.

The Employer contributes a matching contribution on elective deferrals (including Roth and after-tax contributions) of 100% up to 6% of each participant's eligible compensation, as defined by the Plan document. At the end of each Plan year, a match true-up contribution will be made to each participant which represents the excess, if any, of (1) 100% up to 6% of eligible compensation and (2) actual matching contributions made during the year. The Employer made matching contributions of \$1,645,190 and \$1,571,515 for the years ended December 31, 2024 and 2023, respectively.

Employees who are hired after December 31, 2009, shall receive the Employer's nonelective contribution as determined by the following table:

**Contributions (Continued)**

For each Plan year beginning after January 1, 2017, employees whose accrued benefits were frozen under the Retirement Income Plan for Employees of Edison Electric Institute (Retirement Income Plan) on December 31, 2016, and who have not ceased to accrue benefits under the Retirement Income Plan prior to December 31, 2016, shall receive the Employer's nonelective contribution as determined by the following table:

Employees must be employed on the last day of the Plan year to receive the Employer's nonelective contribution.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans or conduit individual retirement accounts (IRAs).

Participants shall direct the investment of Employer contributions, pre-tax, Roth, after-tax contributions, and rollover contributions in multiples of 1% into one or more funds as determined by the Plan administrator. In order to provide investment flexibility, a self-directed brokerage option is available, which allows participants to invest up to 25% of their vested balance in any publicly traded security, including stocks, bonds, and mutual funds, with certain exceptions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Employer's matching contributions, the Employer's nonelective contributions, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative and investment related expenses that are paid by the Plan. Allocations are based on participant earning or account balances, or participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account balance.

**Vesting**

Participants are immediately vested in his or her contributions plus actual earnings thereon. Vesting in the Employer's matching and nonelective contribution portion of their accounts, plus actual earnings thereon, is based on years of vesting service, as defined by the Plan.

Effective January 1, 2023, participants vest according to the following schedule.

**Vesting (Continued)**

Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts, excluding their Employer nonelective accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate of the Prime Rate as published in the *Wall Street Journal* plus 1% as of the first business day of the month in which the employee applied for the note. Principal and interest are paid ratably through payroll deductions.

**Benefit Payments**

Upon termination of service, death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or installments. The Plan allows for in-service distributions if a participant reaches age 59½ and in the event of a hardship, subject to Plan provisions. If a participant terminates employment, and the participant's vested account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. Effective January 1, 2024, the Plan was amended to incorporate provisions of the Secure 2.0 Act passed by Congress, which included changes to distribution rules for surviving spouse beneficiaries and updated the automatic IRA rollover balance threshold for terminated participants. As of this date, if the vested balance of a terminated participant exceeds \$1,000 but does not exceed \$7,000, then this balance may be rolled over into an IRA designated by the Plan Administrator without the participant's consent.

**Forfeited Accounts**

Forfeited nonvested accounts are used to reduce future Employer contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023, totaled \$88,638 and \$98,772, respectively. During the years ended December 31, 2024 and 2023, forfeitures used to reduce Employer contributions were \$84,000 and \$90,005, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

**Contributions**

Contributions from participants, Employer matching and nonelective contributions are recorded in the year which the employee contributions are withheld from compensation.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Certain fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in the notes receivable balance from participants on the statements of net assets available for benefits. Certain investment related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statements of changes in net assets available for benefits, while certain participant directed expenses are included in administrative expenses.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding addition to corrective distributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants.

**Subsequent Events**

The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Vanguard Fiduciary Trust Company, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

**NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund:* Valued at the net asset value (NAV) of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Brokerage Link Account:* Consists primarily of common stock and money market funds. Common stocks are valued at the closing price reported on the active market on which the individual securities were traded. Money market funds are valued and traded at a stable \$1.00 NAV which approximates fair value. These are all considered to be Level 1 measurements within the fair value hierarchy.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan provides for investment in a variety of investment funds which are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become fully vested in his or her Employer contributions.

**NOTE 7 PLAN TAX STATUS**

The Plan obtained its latest determination letter dated January 23, 2017, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Vanguard Fiduciary Trust Company, the trustee, as defined by the Plan. Therefore, these investment transactions qualify as party-in-interest. As described in Note 2, the Plan made a direct payment to the third-party administrator of \$43,546 and \$39,069 for the years ended December 31, 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
