### Note 1: Description of Plan

The following description of Badger Mining Corporation 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Badger Mining Corporation, LogicHaul Logistics LLC, and Nicolet Plastics LLC (collectively referred to as the "Company"). To become eligible to participate in the Plan and receive safe harbor matching contributions, employees must have attained 20 years of age and have completed three months of service. Effective May 15, 2023, the eligibility age requirement was reduced from 20 years of age to 18. Employees enter the Plan the first day of the following month after meeting eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Management of the Company is responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and monitoring of investment performance.

#### Contributions

Each year, participants may contribute to the Plan up to 90% of eligible annual compensation, as defined in the plan document, on a pre-tax or Roth basis, not to exceed the maximum allowable limits as defined by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollover contributions"). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect an alternate deferral rate. Automatically enrolled participants have their pre-tax deferral rate set at 6% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Participants who are automatically enrolled are subject to 1% annual increases in their deferral rate, up to 90% of eligible compensation.

The Company contributes a safe harbor matching contribution equal to 100% of the first 4% and 50% of the next 2% of eligible compensation that a participant contributes to the Plan. Rollover contributions are not matched. In addition, the Company has the option of making a discretionary profit sharing contribution. Participants must earn at least 501 hours of service during the plan year or be employed on the last day of the plan year to be eligible for any discretionary profit sharing contributions. The Company did not make any discretionary profit sharing contributions during 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Company safe harbor matching contributions, and allocations of (a) the Company's discretionary profit sharing contributions and (b) plan earnings (losses). Participant accounts are reduced by withdrawals and are charged an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Note Receivable From Participant**

Notes receivable from participants are not allowed by the Plan. Due to a merger in 2019, participant loan balances transferred into the Plan. At December 31, 2024, the last remaining note receivable balance from a participant was paid in full. This note was secured by the balance in the participant's account and bore interest at 6.50%. Principal and interest were paid ratably through payroll deductions.

#### **Vesting**

Participants are vested immediately in their voluntary contributions and Company safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contribution portion of their account plus actual earnings thereon is based on continuous years of service subject to a five-year graded vesting schedule, as defined in the plan document. Participants vest at a rate of 20% per year beginning with the first year of service. Participants become fully vested after five years of service or upon becoming disabled, as defined in the plan document.

#### **Payment of Benefits**

On termination of service due to death, disability, normal retirement (age 65), or termination of employment, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or in installment payments if the account balance is greater than \$5,000. If the participant's vested account balance does not exceed \$5,000 but is greater than \$1,000, the plan administrator will pay an involuntary cashout distribution as a direct rollover to an individual retirement plan. Vested balances less than \$1,000 can be distributed only in a single lump-sum payment. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59½. Participants may withdraw their rollover contributions at any time.

### **Note 1: Description of Plan (Continued)**

#### **Forfeitures**

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's discretionary profit sharing contributions. Forfeited nonvested accounts totaled \$48,905 at December 31, 2024, and \$23,817 at December 31, 2023. These accounts can be used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the plan document. During the year ended December 31, 2024, forfeitures in the amount of \$11,665 were used to pay administrative expenses.

#### **SECURE ACT 2.0**

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan has adopted some of these provisions, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **Use of Estimates**

The preparation of the financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Note Receivable From Participant**

The note receivable from participant was measured at its unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. Delinquent participant notes receivable were recorded as benefit payments on the basis of the terms of the plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative and Investment Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment management fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are reflected as investment expenses and included in net investment income. Certain fees incurred by the Plan for investment management fees are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than direct payment. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses. All other expenses paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are included in administrative expenses.

#### **Subsequent Events**

Subsequent events have been evaluated through October 2, 2025, which is the date the financial statements were available to be issued.

### **Note 3: Fair Value Measurements**

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs would be used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

### Note 3: Fair Value Measurements (Continued)

*Mutual funds and money market fund:* Valued at the daily closing price as reported by the fund. Mutual funds and the money market fund held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

*Common/collective trust fund:* Valued at the NAV provided by the administrator of the fund using NAV as a practical expedient to estimate fair value. This practical expedient would not be used if it were determined to be probable that the fund would sell the underlying investments for an amount different than the reported NAV. This fund is a stable fund, and its NAV is based on the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily, and there are no restrictions as to the redemption of this fund or unfunded commitments as of December 31, 2024 and 2023.

### Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and note receivable from participant held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on the note receivable from participant for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company ("Fidelity"), the trustee of the Plan.

### Note 5: Party-in-Interest Transactions

Certain plan investments are managed by Fidelity. Fidelity is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Spectrum Investment Advisors Inc. ("Spectrum") serves as the investment advisor to the Plan and, therefore, transactions with Spectrum qualify as party-in-interest transactions. Wipfli LLP ("Wipfli") is the auditor of the Plan and, therefore, transactions with Wipfli qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under ERISA regulations.

Fees paid by the Plan to Fidelity for administrative expenses and certain participant fees amounted to \$46,537 in 2024. The Plan investment expenses of \$69,410 to Spectrum in 2024. The Plan paid audit fees of \$11,312 to Wipfli in 2024.

The note receivable from participant also qualifies as a party-in-interest transaction, which is exempt from the prohibited transaction rules of ERISA.

### **Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company discretionary profit sharing contributions.

### **Note 7: Tax Status**

The Company adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document, as then designed, is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
