Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of R.W. Beckett Profit Sharing and 401(k) Plan, (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of R.W. Beckett Profit Sharing and 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution, Lincoln Financial Group Trust Company, LLC, as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about R.W. Beckett Profit Sharing and 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

1 Description of Plan

The following description of the R.W. Beckett Profit Sharing and 401(k) Plan provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General:

The Plan, which began April 30, 1970 and was amended and restated effective May 1, 2021, is a defined contribution plan covering all employees of R.W. Beckett Corporation ("Company") who meet the eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

In January 2022, the Company acquired Delavan Spray LLC ("Delavan"). Effective February 1, 2022, Delavan became a participating employer, and the Plan was amended and restated to allow employees of Delavan who meet the Plan's eligibility requirements to participate in the Plan.

During 2023, the Plan was amended to revise the definition of eligible compensation and other plan provisions.

Eligibility:

Employees of the Company age eighteen and older are eligible to participate in the Plan. Leased employees, co-op employees or interns, and employees covered by a collective bargaining agreement are not eligible to participate in the Plan.

Participants who have completed at least one year of service and are actively employed by the Company on the last day of the Plan year will be eligible to receive an allocation of the Company's discretionary profit sharing contribution. Participants become eligible for discretionary profit sharing contributions on the first day of the month following the date eligibility requirements are satisfied.

Contributions:

Employee Contributions - Participants may elect up to 100% of their compensation to be contributed to the Plan by the Company, subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan also allows participants to contribute on an after-tax basis. The Plan provides for an automatic salary deferral of 6% of compensation, unless otherwise elected. Any participant contributing less than 6% is automatically increased to 6%, unless they elect to opt-out of the increase.

Employer Matching Contributions - The Company will make safe harbor contributions to each eligible participant's account by matching 100% of the first 3% and 50% of the next 3% of compensation for the Plan year.

Employer Discretionary Contributions - The Company may also make discretionary profit sharing contributions to the Plan. Such additional contributions, if any, shall be allocated to each eligible Participant as a uniform percentage of his or her eligible compensation for the Plan year. Employer discretionary contributions were \$690,492 (2024) and \$554,404 (2023).

1 Description of Plan, Continued

Contributions, Continued:

Rollover contributions from other Plans are also accepted, providing certain specified conditions are met.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

Participants' Accounts:

Each participant's account is credited with the participant's elective contributions, employer matching contributions, employer discretionary contributions, earnings and losses thereon.

Vesting:

All participants are 100% vested in elective deferrals and rollover contributions made to the Plan. For employer safe harbor matching contributions made, a participant is vested after two years of service.

Vesting in the Company's discretionary profit-sharing contribution is based on years of continuous service. A participant is vested as follows:

Years of Service	Vested %

3	40%

6	100%

Forfeitures:

If a participant is not fully vested on his or her termination date, the non-vested amount of the participant's account is forfeited. Forfeited non-vested accounts totaled \$61 (2024) and \$32 (2023). Forfeitures can be used to reduce future employer contributions or to pay administrative expenses of the Plan. Total forfeitures used were \$63,000 (2024) and \$32,135 (2023).

Other Plan Provisions:

Normal retirement age is 65. The Plan also provides for early payment of benefits after reaching age 59-1/2.

1 Description of Plan, Continued

Payment of Benefits:

Upon termination of service by reason of separation of service, retirement, death or total and permanent disability, a participant may receive a distribution in the form of a lump sum amount or installment payments equal to the value of his or her vested account balance. Vested account balances \$5,000 or less are distributed in the form of a lump sum payment. Benefit payments to participants are recorded upon distribution.

Investment Options:

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

2 Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's transactions are reported on the accrual basis of accounting.

Valuation of Investments:

Investments are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker. The common collective trust fund is valued based on the net asset value as the practical expedient as determined by the asset custodian on a daily basis.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as held during the year.

Use of Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

Administrative Fees:

Plan expenses are fees for services that are provided on a regular basis, such as recordkeeping and general plan administration. Reasonable administration expenses may be paid out of the Plan, unless paid by the Company.

2 Summary of Significant Accounting Policies, Continued

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Risks and Uncertainties:

The Plan invests in various investment securities, including mutual funds and a common collective trust with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

Contributions:

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Subsequent Events:

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued.

3 Tax Status

The Plan adopted a non-standardized defined contribution pre-approved plan from Lincoln Retirement Services Company, LLC. On June 30, 2020, the Internal Revenue Services stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- * Quoted prices for similar assets or liabilities in active markets.
- * Quoted prices for identical or similar assets or liabilities in inactive markets.
- * Inputs other than quoted prices that are observable for the asset or liability.
- * Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds:

The fair value of the mutual funds is based on quoted market prices and are classified as Level 1.

Common Collective Trust Fund:

The fair value of the common collective trust fund (BNYM Mellon Stable Value Fund) is based on the fair value of the fund's underlying assets. The value is expressed in units and is based on net asset value ("NAV") as the practical expedient.

To achieve its investment objective of principal stability while providing current income, the BNYM Mellon Stable Value Fund invests primarily in a diversified portfolio of stable value products, including guaranteed investment contracts, wrapped fixed income contracts, separate account contracts, and cash and cash equivalents. Participant transactions (purchases and sales) may occur daily and there are no redemption restrictions for participant directed withdrawals.

Common Collective Trust Fund, Continued:

Were the Plan to initiate a full redemption of the BNYM Insight Stable Value Fund, the investment advisor reserves the right to delay withdrawal from the fund by up to 12 months in order to ensure that securities liquidations will be carried out in an orderly business manner.
