### *Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Federal International, Inc. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTES TO FINANCIAL STATEMENTS  
December 31, 2024 And 2023**

**1. Description Of The Plan**

The following description of the Federal International, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General**

The Plan, which is sponsored by Federal International, Inc. (the Company), is a defined contribution 401(k) retirement savings plan. Federal Foam Technologies, Inc. and Federal International Recycling and Waste Solutions, LLC are wholly owned subsidiaries of the Company and are participating in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Employees are eligible to participate in the employee and Company matching portion of the Plan upon reaching age 18 and completing one month of service. To be eligible for nonelective Company contributions employees must be employed at the end of the year and have one year of service completed. Eligible participants can enter the Plan one month from the date of employment.

**Contributions**

Participants may defer salary up to the maximum dollar limitation allowed under the Internal Revenue Code (IRC). Participants who do not affirmatively elect not to participate or have a specified amount contributed to the Plan, will be automatically enrolled and will have 4% of eligible compensation contributed to the Plan upon meeting the eligible requirements. The Plan allows participants to make Roth after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan provides for discretionary Company matching and Company nonelective contributions, as determined annually by the Board of Directors. For 2024 and 2023, the Company matched salary deferral contributions at the rate of 50% of the first 8% of eligible compensation. No nonelective Company contributions were made in 2024 or 2023.

**Payment Of Benefits**

Upon termination of service, hardship, death, total disability, or attainment of normal retirement age, a participant (or beneficiary) may take a distribution as a lump-sum or partial withdrawal. The normal retirement age is defined as age 59-1/2.

**Vesting**

Participants are 100% vested in their salary deferral contributions plus actual earnings thereon. Vesting of discretionary Company contribution accounts is based on years of service with partial vesting after one year of service. Participants are fully vested after five years of service.

In any event, participants become fully vested upon death, disability, or reaching normal retirement age.

**Forfeitures**

At the time a participant terminates employment, the nonvested portion of the discretionary Company contribution accounts is forfeited. Forfeitures available to pay administrative expenses or reduce future Company contributions amounted to \$14,183 and \$77,080 at December 31, 2024 and 2023, respectively. Forfeitures used to pay administrative expenses amounted to \$2,050 and \$3,970 during 2024 and 2023, respectively. Forfeitures used to reduce discretionary Company matching contributions in 2024 were \$160,098. There were no forfeitures used to reduce discretionary Company matching contributions in 2023.

**Participant Accounts**

Participants' accounts are credited with participant salary deferral contributions, discretionary matching contributions, discretionary nonelective contributions and earnings thereon. Participant accounts are charged with an allocation of administrative expenses, unless such expenses are paid from forfeitures. The earnings of the individual investment accounts are allocated to participants based on the number of units held in each participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable From Participants**

A participant may borrow from the Plan with the minimum amount of any loan of \$1,000. In no event can the participant borrow more than \$50,000 or 50% of the participant's vested balance. Loans are for a period not exceeding five years or 30 years for purchase of a principal residence and bear interest at rates commensurate with local prevailing rates and practices. Effective April 1, 2024, participants are limited to one loan outstanding at any time instead of the previously allowed two loans. The loans are repaid through ACH payments directly from the participants' accounts, including principal and interest.

**Administration Of The Plan**

Effective April 1, 2024, the Plan's custodian and recordkeeper became Fidelity Trust Management Company and Fidelity Workplace Services LLC, respectively. Prior to April 1, 2024, Minnesota Life Insurance Company was the Plan's custodian and The Standard was the Plan's recordkeeper.

**Investment Options**

Upon enrollment in the Plan, participants may direct the employee contributions and Company contributions in a variety of investment options. Participants may change their investment options at any time.

**Administrative Expenses**

Administrative expenses under the contract with Fidelity Trust Management Company and Minnesota Life Insurance Company are paid by the Plan. The Company pays all other administrative expenses.

**Subsequent Events**

Management evaluates subsequent events through the date financial statements were available for issue, which is the date of the Independent Auditor's Report.

**2. Significant Accounting Policies**

**Basis Of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

**Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**Contributions Receivable And Credit Loss Policy**

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

**Investment Valuation And Income Recognition**

The Plan's investments other than fully benefit responsive investment contracts are stated at fair value. Fair value is the price that would be received to sell an asset or pay to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date.

Investment contracts held by a defined contribution plan that are fully benefit-responsive are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investments in the Minnesota Life Insurance Guaranteed Account and the Lincoln Stable Value Account are fully benefit-responsive investment contracts and are reported at contract value in the statement of net assets available for benefits.

The net change in the fair value of investments in the accompanying statement of changes in net assets available for benefits includes realized and unrealized gains and losses.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document.

**Payment Of Benefits**

Benefits are recorded when paid.

**3. Certified Investment Information**

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information certified by Fidelity Trust Management Company and Minnesota Life Insurance Company (collectively, the Custodians), and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Custodians that the information provided to the Plan Administrator related to the following information is complete and accurate.

Accordingly, as permitted by CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets as of December 31:

In 2024 and 2023, the Plan invests in fully benefit-responsive investment contracts (the Contracts) with the Custodians, which maintain the contributions in a guaranteed return account, at contract value.

As described in Note 2, because the contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Contracts. Contract value, as reported to the Plan by the Custodians, represents contributions made under the contract, plus investment activity, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) the decision by the Plan Sponsor to withdraw all assets from the fund and reinvest in another investment vehicle, (3) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (4) the delivery of any communication to Plan participants designed to influence the participant not to invest in the fund, (5) any change in law, regulation, ruling, administrative or judicial position, or accounting requirement applicable to the Plan. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

#### **4. Fair Value Measurements**

The Plan utilizes an established framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

**Registered Investment Companies And Money Market Fund**

Valued at the daily closing price as reported by the fund. Registered investment companies and the money market fund held by the Plan are open-end investment funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies and money market fund held by the Plan are deemed to be actively traded.

**Pooled Separate Accounts**

Valued at the NAV of units held by the Plan at year end. The NAV is determined by dividing the net assets, at fair value, of the fund by the number of units outstanding on the day of valuation. Pooled separate accounts are comprised, primarily, of shares of registered investment companies held through sub-accounts of a separate account of an insurance company. The Plan has concluded that the NAV as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company approximates fair value of the investments. The NAV, as provided by Minnesota Life Insurance Company, is used as a practical expedient to estimate fair value. The investments are redeemable daily at the adjusted NAV under agreements with the insurance company. However, it is possible that the redemptions rights may be restricted or eliminated in the future. Due to the nature of the investments, changes in the market conditions, liquidity requirements, and the economic environment may significantly affect the NAV of the registered investment companies and, consequently, the fair value of the Plan's investments. All of the pooled separate accounts held by the Plan file an annual report on Form 5500 as a direct filing entity. There are no redemption notice requirements or unfunded capital commitments as of December 31, 2023. The pooled separate accounts were liquidated in April 2024 with the change in custodians.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**6. Party In Interest Transactions**

**9. Income Tax Status**

As of April 1, 2024, the Plan adopted a non-standardized pre-approved plan sponsored by FMR LLC. The pre-approved plan received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the pre-approved document satisfies the applicable provisions of the Code. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code, which provides that, if certain conditions are met, an employer may rely on a favorable opinion letter issued to a pre-approved plan sponsor as if the employer had received a favorable determination letter. Therefore, no provision for income tax has been included in the Plan's financial statements.

Prior to April 1, 2024, the Plan used a non-standardized pre-approved plan sponsored by Minnesota Life Insurance Company. The pre-approved plan received an opinion letter from the IRS dated June 30, 2020.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
