### *Disagreements with Management*



## Independent Auditors' Report

Notes to Financial Statements

December 31, 2024 and 2023

**A. Description of Plan**

The following description of First Bankers Trustshares, Inc. 401(k) Profit Sharing Plan provides only general information. Participants should refer to the Plan agreement for a more complex description of the Plan's provisions.

**1. General**

The Plan is a defined contribution plan covering all employees from First Bankers Trust Company, N.A. (the Plan Sponsor), provided they are not an excluded employee. Employees will be eligible to participate in the Plan once they satisfy the age and service requirements. For salary reduction contributions, voluntary after-tax contributions, and matching contributions, employees will be eligible to participate in the Plan if they have attained age 21. For discretionary profit-sharing contributions, employees will be eligible to participate in the Plan if they have completed one (1) year of service and have also attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions became effective in 2024 and thereafter. Accordingly, there has been no material impact on the Plan's financial statements.

**2. Excluded Employees**

If an employee is a member of a class of employees identified below, they are an excluded employee for purposes of the Plan. The excluded employees are:

- Union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining.
- Certain non-resident aliens who have no earned income from sources within the United States.

**3. Contributions to the Plan**

Employee Contributions

Eligible employees may defer up to 100% of their gross wages into the Plan on a pre-tax basis to a regular 401(k) account or on an after-tax basis to a Roth 401(k), however the maximum salary reduction for the 2024 and 2023 calendar years was \$23,000 and \$22,500, respectively, and \$30,500 and \$30,000 for participants age 50 or older. These levels are set by the IRS and are subject to change each year. Total deferrals for the Plan Years ended December 31, 2024 and 2023, were \$866,791 and \$833,838, respectively.

Employer Contributions

The Plan Sponsor may contribute to the Plan discretionary matching contributions and discretionary profit-sharing contributions.

Discretionary Contributions

The Plan Sponsor may make a matching contribution equal to a uniform percentage of salary deferrals; the Plan Sponsor will determine the percentage each year.

**3. Contributions to the Plan (Concluded)**

In applying this matching percentage however, the Plan Sponsor has the option to disregard salary deferrals made each year that exceed a certain dollar amount or a certain percentage of compensation for such period. To share in the matching contribution, an Employee must satisfy the following conditions:

- If an employee is actively employed on the last day of the Plan Year, the employee will share in the matching contribution if they have completed one year of service during the Plan Year.
- The employee will share in the matching contribution for the year regardless of the number of Hours of Service credited in the year of the employee's death, disability, or retirement.

Total matching contributions for the years ended December 31, 2024 and 2023, were 50% of the employee deferral up to 4% (2% max) that a participant elects to defer. Total matching contributions were \$200,735 and \$204,063 for the years ending December 31, 2024 and 2023, respectively.

The Plan Sponsor may make a discretionary profit-sharing contribution.

In order to share in the discretionary profit-sharing contribution, an employee must satisfy the following:

- If the employee is actively employed on the last day of the Plan Year, the employee will share in the discretionary profit-sharing contribution if they have completed one year of service during the Plan Year.
- If the employee terminates employment (not actively employed on the last day of the Plan Year), they will not receive a discretionary profit-sharing contribution regardless of the number of hours of service credited for the Plan Year.
- The employee will share in the discretionary profit-sharing contribution for the year regardless of the number of hours of service credited in the year of the employee's death, disability, or retirement.

Any discretionary profit-sharing contribution will be "allocated" or divided among participants eligible to share in the contribution for the Plan Year.

Total discretionary profit-sharing contributions for the years ended December 31, 2024 and 2023, were \$413,817 and \$382,004, respectively.

**4. Year of Service and Hour of Service**

An employee will have completed one year of service if, at the end of their first twelve consecutive months of employment they have been credited with at least 1,000 hours of service. If an employee has not been credited with 1,000 hours of service by the end of their first twelve consecutive months of employment, they will have completed one year of service at the end of any following Plan Year during which they were credited with 1,000 hours of service.

**5. Participant Accounts**

Each participant's account is credited with the participant's contributions, allocations of the Plan Sponsor's contributions, Plan earnings, and charged with an allocation of investment gains or losses, withdrawals, and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**6. Investment Options**

Participants have a choice of investments to elect from which to contribute. The allocation can be changed by participants at any time on the website of its investment provider. An enrollment kit explaining these choices is available to all participants.

**7. Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of the participants' accounts is based on years of continuous service. Employees vest 20 percent per year after completing two years of service until becoming 100 percent vested after six years of credited service in accordance with the Plan document, or immediately if employment is terminated due to death, disability, or retirement upon attainment of the age of 65.

**8. Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant can elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account as provided in the Plan document. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**9. Forfeitures**

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures may first be used to pay Plan expenses and any forfeitures left will be added to any employer discretionary profit-sharing contributions. However, forfeitures attributable to matching contributions will be allocated in the same proportion that individual compensation bears to the total compensation of all participants. The employee will receive this allocation if they are eligible to receive a matching contribution regardless of whether they made any salary deferrals.

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$30,470 and \$469, respectively. During the years ended December 31, 2024 and 2023, forfeitures of \$12,138 and \$11,416, respectively, were used to pay Plan expenses.

**10. Transfers from Qualified Plans (Rollovers)**

At the discretion of the Administrator, employees may be permitted to deposit into the Plan distributions employees have received from other plans.

Rollovers will be placed in a separate account called the participant's rollover account.

Employees will always be 100% vested in their rollover account.

There were no rollovers for the Plan year ended December 31, 2024. Participant rollovers of \$2,131 were received during the Plan year ended December 31, 2023.

**11. Loans**

Loan provisions do not apply to this Plan.

**B. Summary of Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

***Use of Estimates***

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded when paid.

***Expenses***

Certain expenses incurred to maintain the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

**C. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described below:

***Level 1 Fair Value Measurements***

Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

***Level 2 Fair Value Measurements***

Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as: a) Quoted prices for similar assets or liabilities in active markets, b) Quoted prices for identical or similar assets or liabilities in inactive markets, c) Inputs other than quoted prices that are observable for the asset or liability, d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3 Fair Value Measurements*

Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund:* Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV. Participant transactions (purchase and sales) may occur daily.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

**F. Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**G. Administrative Expenses**

Most administrative expenses, plan administration, and other costs associated with the Plan, are paid directly by the Plan Sponsor.

Other costs such as brokerage commissions in association with security buys and sells are added to the cost of the security when purchased or used to reduce the gain or increase the loss when the asset is sold.

**H. Commitments and Contingencies**

The Plan Sponsor is not aware of commitments or contingencies concerning the Plan. In addition, the Plan Sponsor is not aware that any transactions have occurred that are prohibited by ERISA.

**I. Tax Status**

The Plan Sponsor has adopted a non-standardized plan pre-approved by the Internal Revenue Service (IRS). The IRS issued an opinion letter dated November 30, 2020, that the Plan is acceptable with the applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Sponsor and the Plan administrator believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**J. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**K. Subsequent Events**

The Plan administrator has evaluated events and transactions subsequent to the statement of net assets (in liquidation) available for benefits date through the date of the independent auditors' report (the date the financial statements were available to be issued) for potential recognition or disclosure in the financial statements. The Plan administrator has not identified any items requiring recognition or disclosure in the financial statements.
