Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Shyft Group Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1. Plan Description

The following description of The Shyft Group Retirement Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all employees of The Shyft Group, Inc. (the "Company"), who have at least 60 days of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's trustee and recordkeeper is Fidelity Management Trust Company (Fidelity).

Contributions:

Each year, the participants may elect to contribute up to 60% of pretax annual compensation, as defined in the Plan agreement, limited to the maximum amount allowed by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Newly eligible employees automatically defer 3% of their compensation, and that deferral is automatically escalated by 1% per year up to a maximum of 10%, unless they elect a contrary salary reduction or increase or elect not to participate. Participants may elect to make Roth deferral contributions. Participants direct their contributions into various investment options offered by the Plan.

The Company may make employer matching contributions based on a percentage of participant contributions to be determined annually by the Company. In 2024, the Company match was 50% of the participant's contribution up to 6% of eligible compensation.

Participant accounts:

Each participant's account is credited with the participant's contributions and the Company's matching contributions and an allocation of (a) the Company's discretionary contribution, if any, (b) plan earnings, and (c) forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings, specific participant transactions or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of 50% of their vested account balance not to exceed \$50,000. The number of outstanding loans allowed at any given time is two, and participants may apply for only one loan each calendar year. These loans bear interest at a rate based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Interest rates on outstanding loans as of December 31, 2024 ranged from 4.25% to 10.50%. The maximum loan term allowed is five years unless used to purchase the participant's principal residence, in which case the loan terms shall not exceed ten years. Principal and interest are payable each pay period, primarily through payroll deduction.

Notes receivable from participants related to these loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Note 1. Plan Description (continued)

Vesting:

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Should a discretionary employer contribution be made, vesting for this portion of the account is based on years of continuous service, as defined by the Plan. The discretionary employer contribution vests at a rate of 20% per year until the participant has reached five years of credited service, at which time the participant is 100% vested. As defined in the Plan document, a participant is entitled to 100% of his or her total account balance upon retirement, death, or disability regardless of years of service, provided he or she is an employee.

Forfeitures:

Forfeitures of non-vested employer matching contributions are used to pay administrative expenses or to reduce employer matching contributions. In 2024, the Company used approximately \$744,000 to reduce employer matching contributions.

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$44,000 and \$77,000, respectively.

Investment Options:

Participants may direct the investment of funds in their accounts to any investment option available under the Plan. Effective January 2, 2013, participants are no longer permitted to direct salary deferrals or exchange in transfers to purchase shares of The Shyft Group, Inc. common stock. Participants may continue to hold existing shares or sell shares of common stock that were held in the Plan prior to January 2, 2013.

Payment of benefits:

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the vested value of his or her account, or upon death, disability or retirement, receive periodic installments over a period not to exceed the life expectancy of the participant or joint lives of the participant and spouse. Participants may withdraw portions of their vested account (other than voluntary contributions) at any time after reaching 59½. Benefits are recorded when paid.

Administration of Plan assets:

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Administrative Expenses:

Certain administrative expenses are paid by the forfeited nonvested employer matching contributions. Administrative expenses for the 2024 Plan year for the trustee's fees were paid by the Plan. Fees incurred as a result of participant-directed transactions (e.g., participant loan origination fees) are charged directly to the participant's account.

Note 2. Summary of Significant Accounting Policies

Basis of accounting:

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates:

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and uncertainties:

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

Subsequent events:

The Plan has evaluated subsequent events for potential recognition and/or disclosure through September 24, 2025, the date the financial statements were available to be issued.

On January 1, 2025, the Independent Truck Upfitters 401(k) plan was acquired by and merged into The Shyft Group Retirement Plan. As a result, net assets of \$5,388,407 were transferred to the control of The Shyft Group Plan on January 14, 2025. The merger does not impact participant benefits as the benefit provisions were incorporated into the Plan.

Subsequent to the plan year-end, on July 1, 2025, the parent company of the Plan Sponsor underwent a change in ownership. Aebi Schmidt Group acquired the parent entity of the Plan Sponsor, resulting in a change to the organizational structure at the parent level. The Plan Sponsor itself, including its responsibilities and operations related to the Plan, remains unchanged.

This transaction is considered a Type II subsequent event under ASC 855, Subsequent Events, as it does not relate to conditions that existed as of the plan year-end but may be relevant to users of the financial statements. Accordingly, the event has not been reflected in the financial statements but is disclosed herein due to its potential impact on future governance and oversight of the Plan.

Management has evaluated this event and determined that no adjustments to the financial statements are necessary as of December 31, 2024.

Note 3. Investments and Information Certified by Fidelity Management Trust Company (Fidelity)

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, that were prepared by or derived from information provided by Fidelity Management Trust Company, the trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets:

Fidelity also certified to the completeness and accuracy of \$10,100,337 of net appreciation in fair value of investments, \$3,751,834 of interest and dividends related to the aforementioned investments, and \$220,088 of interest related to notes receivable from participants for the year ended December 31, 2024.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds and The Shyft Group, Inc. common stock: Valued at the daily closing price as reported on the active market on which the individual securities are traded.

Common/Collective Trust Fund: The Plan's interest in the Fidelity Managed Income Portfolio Fund is valued at net asset value ("NAV") (as a practical expedient) based on information reported by the investment advisor using the audited financial statements of the Fidelity Managed Income Portfolio Fund.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. We evaluate the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. During the year ended December 31, 2024, there were no transfers in or out of Level 1, 2 or 3.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6. Related Party and Party-In-Interest Transactions

Certain Plan investments are managed by affiliates of Fidelity. Fidelity and its affiliates perform services for the Plan and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan amounted to approximately \$196,000 for the year ended December 31, 2024.

Note 7. Income Tax Status and Uncertain Tax Positions

The Company has adopted the Fidelity Basic Plan Document No. 14, a volume submitter defined contribution Plan. In a letter dated June 30, 2020, the IRS stated that the volume submitter plan is in compliance with the applicable requirements of the IRC. The plan opinion letter has been relied upon by this Plan. The Plan has been amended since this date; however, the Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

The Plan's administrator has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
