Notes to Financial Statements For the Year Ended December 31, 2024

Note 1 - Description of the Plan

The following description of the San Diego Family Care 403(b) Retirement Plan (the Plan) provides general information only. Participants should refer to the plan document for complete information regarding the Plan's definitions, benefits, eligibility and other matters.

General - The Plan is a defined contribution plan that was established for the benefit of employees of San Diego Family Care (the Sponsor). The Plan is intended to be a plan that meets requirements under Section 403(b) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility - Employees that are the result of an acquisition or merger are excluded from the Plan until the year following the acquisition or merger. All other employees are eligible to make salary deferral contributions to the Plan on their date of hire, and those who have completed one year of service in which they worked at least 1,000 hours are eligible to receive discretionary employer matching contributions.

Contributions - Participants may elect to contribute pre-tax or Roth contributions to the Plan each pay period through payroll deductions at the rate of any whole percentage from 1% up to 100% of the participant's eligible compensation. Participants who attain age 50 before the end of the plan year or participants having at least 15 years of service are eligible to make catch-up contributions. Participants may rollover contributions into the Plan from other eligible retirement plans or individual retirement accounts.

The Sponsor may make discretionary employer matching contributions for participants. For the year ended December 31, 2024, the Sponsor authorized matching contributions equal to 50% of employee deferrals applied to a maximum of 6% of plan compensation.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts - Participant contributions to the Plan are voluntary. Participants are allowed to direct the investment of all contributions into various investment options that offer a diversity of investment risk and return. Each participant's account is credited with any contributions made to the account as well as increases or decreases in the market value of investments. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in all contributions to the Plan plus actual earnings thereon.

Benefit Payments - Upon termination of service, retirement, death or disability, a participant or beneficiary may elect to receive a distribution equal to the value of the participant's vested interest in his or her account. The distribution may be in the form of a lump-sum or partial lump-sum payment, annuity or installment payments. Participants may elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawals) upon attainment of age 59. The Plan also allows for hardship withdrawals in accordance with the provisions specified in the plan document.

Notes Receivable From Participants - A participant may borrow the lesser of \$50,000 or 50% of their vested balance, with a minimum loan of \$1,000. The maximum loan repayment period is five years. The loan interest rate is set at 1% above the prime rate. Principal and interest are paid directly from the participant to the recordkeeper.

Note 1 - Continued

Plan Loans - The Plan provides for loans which are issued directly from funds owned by Lincoln National Life Insurance Company (Lincoln). Accordingly, plan loans are not reported on the statements of net assets available for benefits. A portion of the participant's account is held as collateral to cover outstanding loans in case of default. There was approximately \$254,000 and \$303,000 of the Plan's assets held as collateral for outstanding plan loans at December 31, 2024 and 2023, respectively. Plan loans carry an interest rate of 7.0% which is fixed unless a participant defaults on his or her loan, at which point the interest rate is reduced to a fixed 4.5% rate.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Benefits Paid to Participants - Benefits paid to participants are recognized when they are paid.

Investment Valuation and Income Recognition - Investments are reported at fair value except for fully benefit responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Company are excluded from these financial statements. Transaction based fees for notes receivable from participants and benefit payments are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Subsequent Events - The Plan's management has evaluated subsequent events through October 1, 2025, the date on which the Plan's financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Guaranteed Interest Account - Valued at contract value which is the aggregation of contributions, plus interest, less any withdrawals. Contract value approximates a discounted cash flow value, calculated using an appropriate risk-adjusted market discount rate which correlates closely with the Plan's guaranteed interest account's historical crediting rates. Fair value is determined annually for financial statement reporting purposes since participants normally transact at contract value. In determining the reasonableness of the methodology, the Plan's management evaluates a variety of factors, including review of historical returns, market conditions, and overall credit ratings. Certain unobservable inputs are determined through review of contract terms (e.g. historical crediting rates) while others are substantiated utilizing available market data (e.g. Treasury yields). Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Lincoln is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Transfers or withdrawals from the guaranteed account may be subject to a market value adjustment or surrender charge based on the number of years the contract is held. In addition, Lincoln has placed some restrictions on the ability of plan participants to transfer/transact some or all of their balance in the guaranteed interest account to other investment options available to them. Therefore, the Plan's guaranteed interest account is not considered fully benefit-responsive.

Variable Annuity Accounts - Fair values of the Plan's variable annuities are estimated using their net asset value (NAV) per unit as determined by Lincoln. The fair values of participation units are based on the market value of securities underlying the variable annuities. NAV per unit is used as a practical expedient for measuring fair value. Participant transactions (purchases and sales) may occur daily. Participants eligible to receive benefit payments may withdraw the value of their variable annuity accounts, in whole or in part, at any time without penalty. There are no participant redemption restrictions for these investments.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts - Accounts primarily consist of mutual funds that are valued based on readily determinable market prices.

Note 4 - Fully Benefit-Responsive Investment Contract

Plan investments include the Lincoln Stable Value Account which is a fixed annuity contract issued by Lincoln. Contributions to the Lincoln Stable Value Account are maintained in Lincoln Alliance's general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Lincoln Alliance is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by Lincoln which will never be below 1.0% annually. The crediting rate is reviewed on a quarterly basis for resetting. The Plan's ability to receive amounts due in accordance with the contract is dependent on Lincoln Alliance's ability to meet its financial obligations. Lincoln Alliance's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the issuer or otherwise.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Therefore, the Lincoln Stable Value Account is considered to be fully benefit-responsive and is reported at contract value. Contract value represents contributions made, plus interest, less withdrawals. Upon termination of the contract by the Sponsor or Lincoln, the contract provides for an immediate payout of the entire contract which may be reduced by a market value adjustment. This may limit the ability of the Plan and participants to transact at contract value with Lincoln Alliance. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Lincoln and that also would limit the ability of the Plan to transact at contract value with the participants. Certain events allow Lincoln to terminate the contract without approval by the Sponsor. Examples of such events include the Plan not meeting the requirements of the IRC, the Sponsor failing to furnish requested information, and the Sponsor terminating the recordkeeping agreement with Lincoln.

Note 5 - Certified Information

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln National Life Insurance Company and Lincoln Financial Group Trust Company, Inc, qualified institutions. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 6 - Tax Status

Management adopted a Lincoln Retirement Services Company LLC (Lincoln Retirement) pre-approved plan document. Lincoln Retirement received an approval letter from the IRS dated March 31, 2017, which states that the volume submitter document satisfies the applicable provisions of Section 403(b) of the IRC. The Plan itself has not received a determination letter from the IRS, however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 8 - Party-in-Interest Transactions

The Plan's investments include fixed and variable annuity contracts issued by Lincoln. Lincoln is the custodian for the plan, and, therefore, transactions with such investments are party-in-interest transactions. The plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions.

Note 9 - Risks and Uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 10 - Concentrations of Credit Risk

Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of the fixed annuity contracts issued by Lincoln. These investments represent approximately 28% and 33% of total Plan net assets available for benefits at December 31, 2024 and 2023, respectively. The Plan's management seeks to limit its credit exposure by placing its contracts with high-credit quality institutions.

Note 11 - Reconciliation to Form 5500

The value of the Plan's variable annuity accounts are classified as registered investment companies on Schedule H of Form 5500, which reflect the underlying investments for those accounts.

Amounts held as collateral in the guaranteed interest account for outstanding plan loans are classified as participant loans on the Schedule H of Form 5500. This has no impact on the total net assets available for benefits reported on either the Form 5500 or the financial statements.
