Notes to Financial Statements

December 31, 2024 and 2023, and For the Year Ended December 31, 2024

Note 1 - The Plan and Its Significant Accounting Policies

General - The following brief description of Kamet 401(k) Plan (the Plan, formerly Kamet Profit Sharing/401k Plan) provides only general information. Participants should refer to the related plan document for a more complete description of the Plan's provisions.

During May 2024, the Company has restated the Plan at its entirety with effective date of July 1, 2024 by changing to EPIC Advisors Inc Non-Standardized Pre-Approved Profit Sharing Plan With CODA from Ascensus LLC Non-Standardized Pre-Approved Profit Sharing / Money Purchase / CODA. Participants are encouraged to seek further plan detail and benefit changes with the Company.

The Plan is a defined contribution plan that was established on 1994 by Khuu's Inc. dba Kamet (the Company or Plan Sponsor) to provide benefits to eligible employees, as defined in the plan document. The Plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code (the Code) and the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Administration - Under the terms of the Plan, a group of designated officers of the Company act as the trustee. The Company has appointed an Administrative Committee (the Committee) to manage the operation and administration of the Plan. The Company has contracted with Charles Schwab Trust Bank (effective July 1, 2024) and with Charles Schwab One Trust Account (prior to July 1, 2024) to act as the Plan's custodians, and a third-party administrator to process and to maintain the records of participant data. Substantially all expenses incurred for administering the Plan are paid by the Company except for direct investment brokerage commissions.

Basis of accounting - The accompanying financial statements have been prepared in accordance with U.S. generally accepted accounting principles (GAAP).

Use of Estimates - The preparation of financial statements in conformity with GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

Subsequent events - The Company monitors significant events occurring after the financial statement date and prior to its issuance to determine the impacts, if any, of events on the financial statements to be issued. All subsequent events of which the Company is aware are evaluated through the date of the independent auditor's report.

Investments, investment valuation and income recognition - The Plan's investments are stated at fair value. Investments of the Plan are held by Charles Schwab Trust Bank and its self-directed brokerage accounts (Schwab Personal Choice Retirement Accounts) and invested based solely upon instructions received from participants. Participants are able to self-direct their own investments in money market funds, publicly listed common stocks, mutual funds and exchange-traded funds (ETF) through their own self-directed brokerage accounts. Participants may also direct the investment of their contributions and employer contributions into their own self-directed brokerage accounts and into various investment options offered by the Plan and may change investments and transfer amounts between funds and/or their self-directed brokerage accounts daily. The Plan offers mutual funds, Vanguard Target Retirement Fund Series, and a short-term fixed income fund in Schwab Bank Savings.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Fair value measurements - Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date.

Fair value hierarchy - Valuation techniques used by the Plan are based upon observable and unobservable inputs. Observable or market inputs reflect market data obtained from independent sources, while unobservable inputs reflect the Plan's assumptions about market participant assumptions based on the best information available. Assets and liabilities are classified in the fair value hierarchy based on the lowest level of input that is significant to the fair value measurement.

Level 1: Quoted prices (unadjusted) in active markets for identical assets or liabilities.

Level 2: Quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3: Unobservable inputs for the asset or liability. No level 3 assets were held by the Plan.

The fair value hierarchy gives the highest priority to observable inputs and lowest priority to unobservable inputs.

Valuation techniques - The following is a description of the valuation techniques used to measure fair value. There were no changes in the techniques used to measure fair value during the year ended December 31, 2024.

- Money market funds, common stocks, mutual funds and ETF: Valued at the daily closing price reported on the active market on which the individual securities were traded.

The self-directed brokerage accounts include money market funds, common stocks, mutual funds and ETF.

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation techniques are appropriate and consistent with other market participants, the use of different techniques or assumptions to estimate fair value could result in a different fair value measurement at the reporting date.

Cash and cash equivalents - All highly liquid investments purchased with an original maturity of three months or less (generally money market funds) are considered to be cash equivalents. These investments are usually held for a short period of time, pending long-term investment.

Forfeited accounts - Forfeited nonvested accounts will be used to reduce future employer contributions or plan expenses, as determined by the Company.

Benefit payments - In general, benefit payments are recorded when paid.

Income taxes - Effective July 1, 2024, the Plan has adopted EPIC Advisors Inc Non-Standardized Pre-Approved Profit Sharing Plan With CODA which has received an acceptable opinion letter from the Internal Revenue Service, under section 401 of the Code, for use by employers for the benefit of their employees. The Company believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the Code and related state statutes, and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

The Plan administrator evaluates any uncertain tax position taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax position taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Reconciliation of financial statements to Form 5500 - The differences between the information reported in the financial statements and the information reported in the Form 5500 are due to \$1,506 excess contributions refundable at December 31, 2023.

Risks and uncertainties - Investment securities are exposed to various risks, such as interest rate, market risks, and credit risks. Due to the level of risk associated with certain investment securities held by the Plan, it is at least reasonably possible that changes in fair value may occur and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 2 - Related Party Transactions

Certain Plan investments in units of money market funds, common stocks, mutual funds and ETF are managed by Charles Schwab, the custodian of the Plan. Any purchases and sales of these investments are performed in the open market at fair value and qualify as party-in-interest. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 3 - Participation and Benefits

Upon employment and meeting the Plan's eligibility requirements, eligible participants may decide to enroll in the Plan with default investment in the Schwab Trust Bank's Vanguard Target Retirement Date Funds closest to the employee's normal retirement date.

The Plan document definition of compensation is based on when the compensation is "paid" versus when it is "earned." As such, the Company has determined that participant deferrals may not be due to the Plan, and the Plan may have no right to the deferrals, until the compensation is actually paid to the participant.

Employer contributions - During 2024, the Company has provided matching contributions to eligible participants of 50% of their deferrals with an annual limit of \$1,200 per participant. The Company is also allowed to make additional discretionary contribution and/or nonelective contribution as defined in the Plan and as approved by the Board of Directors.

Participant contributions - Participants may elect to have the Company contribute any amount of their eligible pre-tax compensation not to exceed the annual limitation amount allowable under current income tax regulations. Participants who elect to have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Contributions withheld are invested in accordance with the participant's direction.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited into the participant's self-directed brokerage accounts in accordance with the participant's direction and the Plan's provisions.

Vesting - Participants are fully vested in their contributions and earnings thereon. In general, participants are subject to a five-year cliff vesting with regard to Company matching contributions, and earnings thereon, after which time they become 100% vested in their Company matching contributions, and earnings thereon. In addition, participants become 100% vested in their Company matching contributions, and earnings thereon, at attainment of age 65, death before termination of employment, or becoming permanent disabled.

Participant accounts - Each participant's account is credited with the participant's contributions, applicable Company matching contributions, and Plan earnings, and is reduced for any benefit payments and administrative expenses. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance and share of net earnings or losses of their respective elected investment options. Allocations are determined in accordance with the provisions of the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Forfeitures - If a participant terminates employment before becoming fully vested in their Company matching contributions, the nonvested Company matching contributions (and earnings thereon) are forfeited at the earlier of the date the participant receives a distribution or incurs a five-year break-in-service. Forfeited balances due to taking a distribution of vested amounts are restored if the participant returns to an eligible status within five years of termination and repays any amount previously distributed. Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company matching contributions, restore previously forfeited balances, or pay eligible plan expenses.

Unallocated forfeiture balances as of December 31, 2024 and 2023, were \$14,928 and \$13,876, respectively. During 2024, employer matching contributions were reduced by \$0 from forfeited nonvested account.

Payment of benefits - Upon termination, death, or retirement, participants or beneficiaries may elect to receive a lump-sum amount or a partial or systematic withdrawal amount based on the vested value of their accounts. The Plan allows for in-service and hardship distributions when participants meet certain criteria. Participants may also, at any time, withdraw all or part of their rollover accounts. The Plan also allows for automatic lump sum distribution of participant vested account balances that do not exceed \$5,000.

Life insurance – Prior to July 1, 2024, the trustee may elect to purchase life insurance on participants' behalf. The amount of life insurance that may be purchased is limited by law. The life insurance contract must designate the trustee as sole owner and named beneficiary for the account of the insured participant. Any life insurance purchased will be used to provide a death benefit for participants' beneficiary. If a life insurance policy is purchased on a participant's behalf, the participant's account will be reduced by the amount of the premiums and credited with any policy dividends. Effective July 1, 2024, life insurance policy is no longer available under the restated Plan provision.

Loans to participants - Participant loans are not available under the current Plan provisions.

Note 4 - Certified Information

In accordance with 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by Charles Schwab Trust Bank regarding the current value of assets held at December 31, 2024, and transactions entered into for the period from July 1, 2024 to December 31, 2024.

Note 5 - Nonexempt Transaction

Certain participant contributions of \$21,265 and \$150 made by a participant in 2023 and 2022, respectively, were not timely deposited with the Plan custodian in accordance with the United States Department of Labor regulations. As a consequence, the delay in the deposit of the participant's contributions is considered a prohibited transaction under ERISA. The Company will make the related correction to restore the participant's lost earnings and will make the necessary filings with the Internal Revenue Service for the year ended December 31, 2023 and 2022, respectively.

Note 6 - Plan Termination and/or Modification

The Company intends to continue the Plan indefinitely for the benefit of its participants; however, it reserves the right to terminate and/or modify the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA. In the event the Plan is terminated in the future, participants would become fully vested in their accounts.

Note 7 - Review by Department of Labor

Plan Sponsor has received a U.S. Department of Labor (DOL) letter dated October 6, 2021 requesting to review the Plan for compliance with Title I of the Employee Retirement Income Security Act, which establishes standards governing the operation of the Plan. Plan Sponsor has fully cooperated with the reviewing agent and has provided relevant reviewed requests. Plan Sponsor has also engaged an ERISA attorney on April 19, 2024 to assist in responding to DOL's findings based on DOL's review of the Plan.

As a result of DOL's review, there are identified and alleged certain ERISA violations against the Plan's trustee, including alleged failures to meet the safe harbor provisions of ERISA Section 404(c) and to prudently administer the Plan's investments. Rather than entering a formal settlement agreement with DOL, Plan Sponsor has agreed to undergo fiduciary training with counsel, to develop an investment policy statement supporting an updated core investment lineup, and to make corrective contributions to the Plan based on alleged lost earnings of \$464,473. This amount is later adjusted down to \$264,507, without three participants' lost earning amounts. These three excluded participants are the Plan's two trustees and a related family member. Starting April 15, 2025, Plan Sponsor is on a nine month installment payment plan plus interest to pay off this obligation by December 15, 2025.

As of this audit report date, Plan Sponsor has not received further formal DOL correspondence regarding their review status. DOL may have further follow up matters before finalizing its review of the Plan.

Note 8 - Subsequent Event

On April 18, 2025, the Company has sent out a notice of suspension of its discretionary employer matching contributions under the Plan effective December 14, 2025 and continuing through the 2026 plan year. The Company will continue to assess whether to reinstate its discretionary employer matching contributions for 2027 plan year.
