### Note 1 – The Plan and Its Significant Accounting Policies

**General** – The following description of Santen, Inc. 401(k) and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document, as amended, for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan that was established in 1995 by Santen, Inc. (the Company), to provide benefits to eligible employees, as defined in the plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (the Code) and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Administration** – Under the terms of the Plan, a designated officer of the Company has been appointed to act as the trustee. The Company has appointed a Fiduciary Committee (the Committee) to manage the operation and administration of the Plan. The Company contracted with Matrix Trust Company (Matrix Trust) to act as the custodian, and with a third-party administrator to process and maintain the records of participant data. Substantially all expenses incurred for administering the Plan are paid by the Company.

**Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Basis of accounting** – The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Forfeited accounts** – Forfeited nonvested accounts may be used to reduce future discretionary employer matching contributions. Forfeited nonvested accounts totaled \$200,751 for the year ended December 31, 2024, and \$90,292 for the year ended December 31, 2023. For the year ended December 31, 2024, approximately \$5,700 of forfeiture balances was used to reduce employer matching.

**Investment valuation and income recognition** – The investments are reported at fair value. The Plan's custodian, Matrix Trust, certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 2 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

**Notes receivable from participants** – Notes receivable from participants (notes receivable) are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions upon the occurrence of a distributable event based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Income taxes** – The Plan has adopted a prototype plan that has received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that the plan, as then designed, was in accordance with the applicable sections of the Internal Revenue Code. Although the Plan has been amended since the date of the opinion letter, the Company believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the Code and related state statutes, and that the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

In accordance with guidance on accounting for uncertainty in income taxes, management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Risks and uncertainties** – The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations, and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Expenses** – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses paid by the Plan may include notes receivable and distribution fees charged to participants' accounts and administrative Plan fees. Investment-related expenses are included in net appreciation in fair value of investments.

**Benefits payable** – Amounts payable to participants for benefits paid subsequent to December 31, 2024.

**Subsequent events** – The Plan has evaluated subsequent events through October 1, 2025, which is the date the financial statements were available to be issued.

### Note 2 – Fair Value Measurements

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described below:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There had been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual funds and money market fund* – Valued at the daily closing price as reported by the fund. Mutual funds and the money market fund held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds and the money market fund held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 3 – Participation and Benefits

**Participant contributions** – Participants may elect to have the Company contribute their eligible pre-tax or after-tax compensation to the Plan in the form of pre-tax, Roth, after-tax, or catch-up contributions up to the amounts allowable under the plan document and current income tax regulations. Participants who have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable or taxed compensation. Contributions withheld are invested in accordance with the participant's direction.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

**Employer contributions** – The Company is allowed to make discretionary matching contributions as defined in the Plan and as approved by the Board of Directors. In 2024, the Company matched 100% of the participants' contributions up to 5% of eligible pre-tax, Roth, and after-tax compensation per year. The Plan also allows for a discretionary nonelective employer contribution. No discretionary nonelective employer contribution was made in 2024.

**Vesting** – Participants are immediately vested in their contributions. Participants are fully vested in the employer's discretionary matching and discretionary nonelective employer contributions allocated to their account after four years of credited service. See Note 6 related to the vesting applied related to the partial termination of the Plan for the 2024 plan year.

**Eligibility** – All employees over the age 18, except for those excluded per the plan document, can participate immediately.

**Participant accounts** – Each participant's account is credited with the participant's contribution, plan earnings or losses, and an allocation of the Company's contributions, if any. Allocation of the Company's contributions is based on participant contributions or eligible employee compensation, as defined in the Plan.

**Payment of benefits** – Upon termination, the participants or beneficiaries may elect to leave their account balance in the Plan, or receive their total benefits in a lump-sum amount equal to the value of the participant's vested interest in their account. The Plan allows for the automatic lump-sum distribution of participant vested account balances that do not exceed \$7,000.

**Notes receivable from participants** – The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable are secured by the participant's vested balance. Such notes receivable bear interest at the available market financing rates and must be repaid to the Plan within a five-year period, unless the proceeds are used for the purchase of a principal residence, in which case the maximum repayment period may be longer. The specific terms and conditions of such notes receivable are established by the Committee. Principal and interest is paid ratably through biweekly payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 4.25% to 10.50% with various maturities through August 2039.

#### **Note 4 – Certified Investment Information**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust, the custodian of the Plan, has certified to the completeness and accuracy of:

- Investments, notes receivable from participants, and cash reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

#### **Note 5 – Party-In-Interest**

Notes receivable from participants are managed by Northwest Plan Services, Inc., the recordkeeper of the Plan, and transactions with this entity qualify as exempt party-in-interest transactions.

#### **Note 6 – Partial Termination of the Plan**

During the year ended December 31, 2023, the Company underwent a reduction in force and determined the termination represented a partial termination of the Plan. As a result of this partial termination, all accumulated benefits of affected employees were fully vested as of December 31, 2023.

The Company intends to continue the Plan indefinitely for the benefit of its participants; however, it reserves the right to further terminate or modify the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA. In the event the Plan is terminated in the future, participants would become fully vested in their accounts.

#### **Note 7 – Delinquent Participant Contributions**

As disclosed in the accompanying supplemental schedule, certain employee deferrals were not remitted to the Plan within the timeframe required by the Department of Labor. The Company has determined the amount of related lost earnings and will remit these amounts to participants' accounts subsequent to year end.
