INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator of the
Hazen Paper Company Salary Investment 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Hazen Paper Company Salary Investment 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

The following description of the Hazen Paper Company (the “Employer”) Salary Investment 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and related amendments for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”) covering all eligible employees of the Employer who have completed six months of service during which the employee worked at least 1,000 hours and has attained age 21, and the Plan also allows long-term, part-time employees who completed three consecutive 12-month periods, each with at least 500 hours of service to participate in the employee deferral component of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Contributions

Each year, participants may contribute a percentage of pre-tax compensation, as defined in the Plan and IRC. Current tax law limits each employee’s annual pretax deferral to \$23,000, plus an additional \$7,500 for catch up contributions for participants over 50 years old or older for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other plans (rollover). Participants can change their contribution percentages at any time and those changes will be effective as soon as administratively feasible.

The Employer contributes, for each Plan participant who is making a pre-tax contribution, an amount equal to 25% of the participant’s contribution to the Plan. Contributions are subject to certain limitations. The Employer may also make a discretionary profit-sharing contribution. There was no discretionary profit-sharing contribution for the year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, as well as allocations of the Employer’s matching contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants

The Plan allows for notes receivable from participants, subject to the provisions as set forth in the Plan. The loan amount shall not exceed the lesser of \$50,000 or 50% of the sum of the participant’s total vested balance. Principal and interest are paid ratably through payroll deductions in each pay period. Interest accrues on the unpaid balance at the prime rate as of the date of borrowing. The Plan administrator determines a reasonable interest rate by reviewing the interest rates charged for similar types of loans by other lenders. Only one loan may be outstanding at a time.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

Forfeited Accounts

Any forfeitures resulting from the non-vested interest in a participant's accounts shall remain in a suspense account to be restored to the participant's account if the participant should be re-employed prior to incurring a break in service. If the former participant is not re-employed prior to incurring a break in service, the forfeiture may be used to reduce the Employer's contribution for the Plan year or for payment of Plan expenses.

At December 31, 2024 and 2023, there were no forfeited non-vested accounts. These accounts may be used to reduce future Employer contributions or pay for administrative expenses. During 2024, forfeitures of \$3,650 were used to reduce Employer contributions and \$2,307 was used to reduce administrative expenses.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer contribution portion of their accounts is based on the following schedule or when they reach early or normal retirement age, become totally and permanently disabled, or upon death.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant can elect to receive an amount equal to the value of the participant's vested interest in their account. For vested account balances in excess of \$5,000, participants may elect to take their distribution as a lump sum, installment payments or annuity payments. For sums under \$5,000, lump sum distributions will be made. After age 55, a participant may make in-service withdrawals from their account without financial hardship up to their vested account balance. In addition, during employment, a participant may withdraw a portion of their salary deferral account to the extent necessary to meet a qualifying financial hardship, or for childbirth or adoption purposes.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the guaranteed interest account which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee, and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a deemed distribution benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other transactional costs are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events from December 31, 2024 through September 25, 2025, the date these financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

NOTE 3 – FAIR VALUE MEASUREMENTS (CONTINUED)

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The funds must to publish their daily net asset value (“NAV”) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There were no participant redemption restrictions for the pooled separate accounts; the redemption notice period was only applicable to the Plan. As of December 31, 2024, there were no unfunded commitments, daily redemption restrictions and a 12-month redemption notice period.

NOTE 4 – BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan offers an insurance company general account, the Principal Fixed Income Guaranteed Option, which carries a benefit-responsiveness feature that allows Plan participants to make exchanges or request benefit payments at contract value. Principal Life Insurance Company maintains the contributions to the investment in fixed accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The insurance company general accounts invest issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Principal Life Insurance Company credited the account between 5.15% to 6.05% for the year ended December 31, 2024. As of December 31, 2024 and 2023, the balances the general account were \$5,834,877 and \$7,247,050, respectively.

Because the insurance company general account has a benefit-responsiveness feature, contract value is the relevant measurement attributable for that portion of the net assets available for benefits. Contract value, as reported to the Plan by Principal Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

NOTE 4 – BENEFIT-RESPONSIVE INVESTMENT CONTRACT (CONTINUED)

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include but may not be limited to a participant termination of employment due to: (1) removal of a group of participants from Plan coverage as a result of temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under common control with the Employer; or (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan sponsor's business. Such events also include: (1) removal from the Plan of one or more groups or classifications of participants; (2) partial or complete plan termination; or (3) Plan disqualification under Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is probable.

NOTE 5 – TAX STATUS

The Plan is a proto-type plan. The Internal Revenue Service has informed the Plan Sponsor, in a letter dated June 30, 2020, that the form of the proto-type plan is acceptable under section 401(a) of the IRC. As such, the Plan is exempt from federal income tax, and amounts contributed by the employers will not be taxed to the participant until the participant receives a qualifying distribution from the Plan. The Plan has been amended since the Employer received the opinion letter, but the Plan Sponsor believes that the Plan is operating in accordance with the applicable sections of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Plan investments are managed by Principal Trust Company ("Principal"). Principal is the custodian of the Plan's assets, therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Principal for the investment management services are included in net appreciation/depreciation in fair value of investments. The Plan hires certain other firms to perform administrative, advisory and recordkeeping services for the Plan.

The Plan provides for loans to participants. Transactions in such investments qualify as party-in-interest transactions as defined by ERISA.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 8 – CERTIFIED INVESTMENTS

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal, the custodian of the Plan.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan provides for various investment options. The underlying investments held by the registered investment companies may include stocks, bonds, fixed income securities and other investment securities. Such investments are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
