### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Lomanco, Inc. 401(K) Employee Retirement Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

## **NOTE 1: DESCRIPTION OF PLAN**

The following description of the Lomanco, Inc. 401(K) Employee Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan, which was established May 1, 1990, is a defined contribution plan maintained for the benefit of employees of Lomanco, Inc. (the Employer, Plan Sponsor and Plan Administrator), who have met eligibility requirements as defined in the Plan agreement. Generally, an employee is eligible to participate in the Plan upon reaching the age of 21 and completing one year of service.

The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

The Employer utilizes the services of Transamerica Retirement Solutions, LLC (Transamerica), a third-party administrator, to process participant transactions and maintain participant account balances. State Street Bank and Trust Company is the Plan's asset custodian. The Employer entered into an agreement with Gallagher Fiduciary Advisors, LLC to provide investment advisory services related to the Plan's investment portfolio.

Certain duties related to administration of the Plan are performed by employees of the Plan Sponsor; however, the Plan Sponsor does not charge the Plan for the estimated cost of such services. Other expenses paid by the Plan Sponsor on behalf of the Plan totaled approximately \$19,000 for the year ended December 31, 2024.

### **Contributions**

Participants may contribute up to 100% of annual compensation (as defined in the Plan agreement) in the form of pre-tax salary deferral, after tax (Roth) salary deferral, or a combination of these options not to exceed limitations imposed by the Internal Revenue Service (IRS). Prior to November 15, 2024, the Plan included an automatic enrollment provision, which provided that, employees who met eligibility requirements were automatically enrolled in the Plan at a salary deferral rate of 2% of eligible compensation, unless the employee elected otherwise. Additionally, the salary deferral percentage would increase annually by 1% until the salary deferral percentage equaled 8% of eligible compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

### Contributions (Continued)

The Employer may make a discretionary matching contribution on behalf of eligible participants equal to a percentage of each participant's salary deferral. In addition, the Employer may also make a discretionary profit sharing contribution on behalf of eligible participants based on the ratio that a participant's compensation bears to the total compensation of all eligible participants for the plan year. Employer contributions are also subject to limitations imposed by the IRS. The amount of Employer matching and profit sharing contributions are determined annually and may only be received by eligible participants who have attained the age of 21 and completed at least one year of service, as defined in the Plan agreement, and who are employed on the last day of the Plan year.

### Participant Accounts

Each participant's account is credited with the participant's contributions, Employer matching contributions and allocations of Employer profit sharing contributions and Plan earnings, net of certain administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are fully vested at all times in their own contributions plus earnings thereon. Vesting in the Employer's discretionary matching contribution, discretionary profit sharing contribution and earnings thereon is based on years of credited service as follows:

A participant is one hundred percent vested in the Employer discretionary matching contribution, discretionary profit sharing contribution and earnings thereon upon retirement, permanent disability or death.

### Investment Options

Contributions to the Plan are invested as directed by participants. Participants may invest in one or more of the various mutual funds, a collective trust fund offered by the Plan or self-directed brokerage accounts. Participants may change their investment options at any time.

### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser \$50,000 or of 50% of their vested account balance. Loans may be extended for periods not to exceed five years except when loan proceeds are used for the purchase of the borrower's primary residence, in which case the loan may be extended up to thirty years. Loans are secured by the participant's vested account balance. Interest will be charged at 1% over the Prime Rate published in

the Wall Street Journal on the first business day of the month the loan is originated. Principal and interest are paid through payroll deductions.

#### **Forfeitures**

The nonvested portion of a participant's account to which the participant is not entitled upon termination is deemed a forfeiture. As allowed under the Plan agreement, forfeitures are used to pay administrative expenses or reduce discretionary matching contributions. There were approximately \$1,050 and \$6,500 in forfeitures available for future allocation at December 31, 2024 and 2023, respectively. Forfeitures used reduce discretionary matching contributions during the year ended December 31, 2024, totaled approximately \$6,500.

#### **Payment of Benefits**

Upon termination of service due to death, disability or retirement, a participant (or designated beneficiary) may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, a partial payment or in periodic payments over a period of not more than the participant's (or their designated beneficiary's) assumed life expectancy. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or, if the account balance exceeds \$5,000 on the date of termination, may leave the account under the Plan until the participant reaches normal retirement age or dies. In-service distributions after a participant's attainment of age 59 ½ are permitted as specified in the Plan agreement.

#### **Hardship Withdrawals**

In case of immediate and heavy financial hardship, a participant may withdraw all or a portion of the participant's vested account balance. A withdrawal shall be deemed for purposes of an immediate and heavy financial hardship if the withdrawal is necessary for certain eligible expenses, such as medical care, the purchase of a principal residence for the participant, payment of tuition and related education fees for the next twelve months of post-secondary education, payments necessary to prevent eviction of the participant from his or her principal residence or to avoid foreclosure on said residence, payments for funeral or burial expenses or expenses to repair damage to the participant's principal residence.

#### **Termination of the Plan**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## **NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly fashion between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Custodian. See Note 4 for further discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as those held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### **Payments of Benefits**

Benefits are recorded when paid. There are no amounts allocated to withdrawing participants that have not been paid at December 31, 2024 and 2023.

### **Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, all information pertaining to the Plan’s investments, notes receivable from participants and related activity reflected in the financial statements and supplemental schedule was certified by the Plan’s Custodian, State Street Bank and Trust Company, as of December 31, 2024 and 2023, and for the year ended December 31, 2024. This information was not subject to audit procedures except for comparing it to the related information included in the financial statements and supplemental schedule.

### **NOTE 4: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

#### Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### Collective Investment Trust

The collective investment trust (CIT) invests in collective trust funds, separate accounts, mutual funds, guaranteed investment contracts and money market mutual funds. The fair value of the underlying investments may not use publicly quoted pricing inputs. The fair value of all the underlying investments is used in determining the NAV of the CIT, which is not publicly quoted. This is used as a practical expedient to estimate fair value.

This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The investment strategy for the Wilmington Trust fund is to seek stability of principal, adequate liquidity and a competitive yield with low return volatility by investing in group annuity contracts.

#### Self-directed Brokerage Accounts

Assets held in self-directed brokerage accounts are valued at the daily closing price reported by the active market in which the individual securities are traded. The self-directed brokerage accounts consist of mutual funds, government debt securities and certificates of deposit.

**NOTE 5: TAX STATUS**

Effective May 25, 2021, the Plan executed an adoption agreement for the Friday, Eldredge & Clark, LLP Non-standardized Defined Contribution Plan. As an adopter of the Prototype, the Plan is not subject to tax under present income tax law.

The Plan obtained its latest opinion letter on September 23, 2022, in which the IRS informed the Plan Sponsor, that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the Internal Revenue Code.

Accounting standards require the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require the recognition of a liability or disclosure in the financial statements. The Plan may be subject to audit by the IRS; however, there are currently no audits for any tax periods in progress.

## ***NOTE 6: RISKS AND UNCERTAINTIES***

The Plan's investments are exposed to various risks such as interest rate, market and credit risks. In addition, certain of the investment options available to Plan participants may invest in foreign securities. There are certain additional risks involved when investing in funds with underlying foreign securities that are not present with investments in domestic securities. These risks may involve foreign currency exchange rate fluctuations, adverse political and economic developments and the possible prevention of currency exchange due to foreign governmental laws or restrictions. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Plan's financial statements.

## ***NOTE 7: SUBSEQUENT EVENTS***

Management has evaluated subsequent events through August 11, 2025, the date that the financial statements were available to be issued.

Subsequent to the year end, the Plan Sponsor elected to change third-party administrators from Transamerica to Lincoln Financial. Additionally, the Plan was amended to enhance both the automatic enrollment and automatic increase provisions.
