To the Participants and Trustees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed an audit of the financial statements of HCW Management Consultants, LLC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Opinion on the Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 and 2023 Financial Statements section—

- the amounts and disclosures in the accompanying 2024 and 2023 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying 2024 and 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 and 2023 Financial Statements section of our report.

We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(c) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(c) audit does not affect management's responsibility for the financial statements.

NOTE A - DESCRIPTION OF PLAN

The following description of the HCW Management Consultants, LLC Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of HCW Management Consultants, LLC, (the Company). The Plan was formed effective January 1, 2021. The first contributions into the Plan occurred on March 5, 2021, as a rollover from a prior plan. Employees are eligible to participate in the Plan on the first day of the 7th month of the plan year, coincident with or next following the date you attain age 21 and complete one year of eligibility service, provided that you are an eligible employee on that date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute, as a salary deferral, up to 100% of pretax annual compensation, as defined in the Plan (subject to Internal Revenue Code limitations). Participants may also rollover amounts representing distributions from other qualified plans and certain IRAs. Participants direct the investment of their contributions into various investment options currently offered by the Plan. For the year ended December 31, 2024 and 2023 the company contributed to the Plan (as a Safe Harbor Matching Contribution) an amount equal to 100% of the matched employee contributions that are not in excess of 3% of your Plan Compensation, plus 50% of the amount of the matched employee contributions that exceed 3% of your plan compensation, but that do not exceed 5% of your plan compensation. Company employer match and discretionary profit-sharing contributions were \$256,213 and \$206,026 for the years ended December 31, 2024, and 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. Certain administrative expenses are allocated proportionately to each participant based on their account balance or the number of participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions as well as the employer match contributions plus actual earnings thereon.

NOTE A - DESCRIPTION OF THE PLAN (Continued)

Notes Receivable from Participants

Participants may borrow (for certain reasons specified in the Plan) from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 2%. Principal and interest is paid ratably through bi-weekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, or separation from service a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount.

Forfeited Accounts

Forfeited non-vested accounts totaled \$7 at December 31, 2024 and 2023. These accounts will be used first to reduce Plan expenses, with any remaining forfeitures reallocated to participants in the same manner as the Company's discretionary profit-sharing contribution described above.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Revenue Recognition

Investments are carried at fair value. Fair value is determined by quoted market prices. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end, participant loans are recorded at face value. Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024, and 2023.

NOTE D – FAIR VALUE MEASUREMENTS (Continued)

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consist of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 inputs were available to the Plan, and Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

Level 1	The fair values of mutual funds and participant directed brokerage accounts investing in equity securities are based on quoted market prices in active markets for identical assets.
Level 2	There are no Level 2 Investments.
Level 3	There are no Level 3 Investments.

NOTE F – PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to participant accounts will become 100% vested. Account balances will be distributed as soon as practical in a manner permitted by the Plan.

NOTE G – TAX STATUS

The Internal Revenue Service has determined and informed Capital Bank and Trust Company by letter dated January 1, 2023, that HCW Management Consultants, LLC Profit Sharing Plan and related trust (adopted by the Company) are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

NOTE H – RISKS AND UNCERTAINTIES

The Plan investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE I – RELATED PARTY TRANSACTIONS

HCW Management Consultants, LLC is considered to be a "Party in Interest" and provides administrative support and pays certain costs directly on behalf of the Plan. No amounts were remitted to HCW Management Consultants, LLC for the years ending December 31, 2024, or 2023.

NOTE J – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued. No subsequent events were identified that required adjustment to or disclosure in the financial statements.
