INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants and Beneficiaries
of the University Physician Associates Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of University Physician Associates Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (in liquidation) as of December 4, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits (in liquidation) for the final period ended December 4, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 4, 2024 and December 31, 2023, and for the final period ended December 4, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As further discussed in Note A[1] to the financial statements, pursuant to an amendment executed December 21, 2021, the Plan was terminated effective December 31, 2021. As of the effective date of Plan termination, all employer contributions ceased, other than those accrued as of December 31, 2021, and Plan participants became 100% vested in each participant’s respective account balance. The Plan sponsor, as of December 4, 2024, has distributed all remaining Plan assets. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.



In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A - DESCRIPTION OF PLAN

The following description of the University Physician Associates Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

[1] General and Plan Termination:

The Plan was a profit-sharing plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Participating employers of the Plan included University Physician Associates, Doctors Center Management Corporation, and Clinical Practice PC (collectively, the "Company"). The Plan adopted a Volume Submitter Profit Sharing Plan sponsored by Planned Retirement Consultants and Administrators, LLC, the Company's third-party administrator.

On December 31, 2020, Empower Retirement, LLC acquired the retirement business of Massachusetts Mutual Life Insurance Company ("MassMutual"). MassMutual was the recordkeeper prior to the acquisition date. The Plan utilized insurance products issued by MassMutual and Talcott Resolution Life Insurance Company ("Talcott"). As a result, the certifications are provided on behalf of MassMutual and Talcott under a power of attorney granted to Empower Annuity Insurance Company ("EAIC").

Pursuant to a resolution of the Board of Directors of University Physician Associates of New Jersey, Inc. and a Plan amendment executed December 21, 2021, the Plan was terminated effective December 31, 2021. As of the effective date of Plan termination, all employer contributions ceased, other than those accrued as of December 31, 2021, and Plan participants became 100% vested in each participant's respective account balance.

Effective September 5, 2024, the Plan sponsor executed a Plan Termination Authorization and Election Form and an Empower Automatic Rollover IRA Plan Sponsor Agreement. The Plan sponsor authorized Empower Retirement, LLC to process distribution requests received in good order without approval of the Plan sponsor. In addition, participants were provided with a minimum of 30 days notice of the decision to execute the final distribution of Plan assets. The account balance of any participant who had not previously provided instruction for distribution, or remained unresponsive, was transferred to an Empower Automatic Rollover IRA. Amounts were invested in the Empower Guaranteed Income Fund made available through a group funding agreement issued by Empower Life & Annuity Insurance Company of America under Empower Trust Company, LLC, the IRA custodian. Any outstanding fees were first deducted from balances that remained in plan level accounts and then from participant balances on a pro rata basis. Final distribution of Plan assets occurred on December 4, 2024.

[2] Participation:

Employees of the Company, excluding highly compensated employees, were eligible to participate under the Plan as of January 1st and July 1st each year, if the employee attained the age of eighteen years and completed one year of employment with at least 1,000 hours of service completed.

[3] Contributions:

Prior to termination, the Company generally made a discretionary contribution to the Plan each year. The amount of the contribution was determined by the Company and was not limited to net profits. The Company's contributions were allocated to all participants eligible to share in the allocations in the same proportion that each participant's compensation, excluding bonuses, commissions, overtime, fringe benefits and other expense reimbursements, bore to the total compensation of all participants for the year. Participants must have completed 1,000 hours of service during the Plan year, as defined, to receive a contribution. Participants were not permitted to contribute to the Plan.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

[4] Participant accounts:

Each participant's account was credited with an allocation of the Company's contribution and Plan earnings and may have been charged for Plan expenses. Allocations were based on a participant's base earnings, account balances, or specific transactions, as defined. The benefit to which a participant was entitled was the benefit that could have been provided from the participant's vested account.

[5] Vesting:

Vesting in the Company's contribution portion of a participant's account plus earnings thereon was based on years of continuous service. A participant had no vested interest in his or her account until the completion of three years of credited service, upon which a participant became 100 percent vested.

[6] Notes receivable from participants:

Participants were not permitted to borrow from their funded accounts.

[7] Payment of benefits:

On termination of service due to death, disability or retirement, a participant or beneficiary may have elected to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, as well as partial withdrawals or installment payments. For termination of service due to other reasons, a participant was able to receive the value of the vested interest in his or her account as a lump-sum distribution. As noted in Note A[1], the Plan has been terminated and all participant account balances were distributed as of December 4, 2024.

[8] Forfeitures:

The portion of a participant's account balance which was not vested upon his or her termination of employment was forfeited and could have been used in future periods to reduce the employer's contributions. At December 4, 2024 and December 31, 2023, there were no forfeited non-vested accounts available for future use. Effective December 31, 2021, upon termination of the Plan, all active participants became 100 percent vested in his or her account balance.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of accounting:

As a result of the Plan termination effective December 31, 2021, the financial statements have been prepared under the liquidation basis of accounting. Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would exclude any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

[2] Subsequent events:

The Plan has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.

[3] Investment valuation and income recognition:

The Plan's investments were reported at fair value (except for fully benefit-responsive investment contracts, which were reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net realized/unrealized appreciation in value of investments included the Plan's gains and losses on investments bought and sold, as well as held during the year.

[4] Payment of benefits:

Benefits were recorded when paid.

[5] Plan expenses:

All significant administrative expenses were paid by the Company, with the exception of investment transaction fees, which were paid by the Plan.

[6] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, EAIC certified to the completeness and accuracy of all investments and related investment activity in the accompanying statements of net assets available for benefits (in liquidation) as of December 4, 2024 and December 31, 2023, and the statement of changes in net assets available for benefits (in liquidation) for the final period ended December 4, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provided the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for investment assets measured at fair value. There have been no changes in the methodology used at December 4, 2024 and December 31, 2023.

Pooled separate accounts – Valued at net asset value ("NAV"), as a practical expedient, based on the market value of the underlying investments. The NAV is not a publicly quoted price in an active market. The pooled separate accounts were comprised of mutual funds. The pooled separate accounts had no unfunded commitments, redemption restrictions, or redemption notice requirements.

The preceding method described may have produced a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method was appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in a different fair value measurement at the reporting date.

The remaining pooled separate account strategies were identified by the name of the investment.

NOTE E - FIXED INTEREST CONTRACT WITH INSURANCE COMPANY

In September 2014, the Plan entered into a benefit-responsive fixed interest contract under a group variable funding agreement with Hartford Life Insurance Company. The Hartford Life Insurance Company became Talcott Resolution Life Insurance Company. All significant terms of the agreement remained unchanged. MassMutual, through an agreement with Talcott Resolution Life Insurance Company, maintained the contributions in a general account. The contract was reported at contract value. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed interest contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan.

Because the fixed interest contract is fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fixed interest contract. Contract value, as reported to the Plan by MassMutual, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants were able to ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The investment contract held by the Plan was a fixed interest contract. The contract issuer was contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but could not be less than 1 percent. The crediting rate was reviewed on a quarterly basis for resetting. The contract could not be terminated before the scheduled maturity date. The initial contract's term was through December 31, 2018. The contract automatically renewed annually for a period of one year until canceled. The contract did not allow transfers to competing funds other than the competing fund the initial transfer is made from for a period of 90 days. New contributions to the Plan could be prohibited or the contract could have been suspended at the discretion of the contract issuer provided advanced written notice of no less than 90 days. The Plan was able to terminate the contract in its discretion with 90 days written notice to the contract issuer.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

NOTE F - TAX STATUS

The Plan had adopted a Volume Submitter Profit Sharing Plan sponsored by Planned Retirement Consultants and Administrators, LLC, the Company's third-party administrator. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the volume submitter adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC") and, therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believed that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believed that the Plan was qualified and the related trust was tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator had analyzed the tax positions taken by the Plan, and concluded that as of December 4, 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan was subject to routine examinations by taxing jurisdictions; however, there were currently no examinations for any tax periods in progress.

NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

All investments were managed by MassMutual or Empower Retirement, LLC, as administrative agent for the Plan's insurance company. Therefore, transactions related to these investments qualified as party-in-interest transactions. Fees paid by the Plan amounted to \$18,362 for the final period ended December 4, 2024.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks, as well as risks related to the financial strength of the insurance company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
