Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

## **Note 1 - Description of Plan**

The following brief description of The Funk Companies 401k Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan covering qualified employees of The Funk Companies and related entities (collectively referred to as the Company, Employer, or Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Retirement Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

### **Eligibility**

Employees are eligible to participate in the Plan if they have completed three months of service and are 21 years of age. Service need not be continuous and there is no minimum number of hours of service required.

### **Entry Date**

Employees may enter the Plan on the first day of the month coinciding with or following the date they satisfy the Plan's eligibility requirements.

### **Contributions**

Each year, participants may contribute up to 90% of their pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover).

The Plan allows for employer discretionary matching contributions. The Company contributes 50% of the first 20% of the employee's salary deferred for a maximum matching contribution of 10%. In addition, the Plan allows for employer discretionary non-elective contributions. During the year ended December 31, 2024, there were no discretionary non-elective contributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation and their contributions invested in a designated American Funds Target Date (TD) fund until changed by the participant. Participants in the plan are allowed to modify their elective deferral elections on the first day of each month.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions (if any), allocations of the Company's discretionary non-elective contributions (if any), and Plan earnings. Participant accounts are charged with withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's compensation, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Investment Options**

Upon enrollment in the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily.

### **Vesting**

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 3 years of credited service.

### **Forfeitures**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$18,009 and \$24,642, respectively. These amounts will be used to reduce future employer discretionary matching contributions or offset plan expenses. During the year ended December 31, 2024, employer contributions were reduced by \$47,168 from forfeited non-vested accounts.

### **Payment of Benefits**

Participants may elect to receive either a lump-sum amount equal to the value of their vested interest or annual installments as defined in the Plan document upon retirement, termination of service, death or disability. Prior to January 1, 2024, a terminated participant with a balance of \$5,000 or less could have been automatically paid out if their balance was rolled into a qualified Individual Retirement Account. Effective January 1, 2024, the Plan was amended to increase the mandatory cash-out limit from \$5,000 to \$7,000 as allowed per the SECURE 2.0 Act. Distributions may be made at the participant's election prior to termination upon attainment of age 59 ½ or hardship as defined in the Plan document.

If a participant attains age 50 and is credited with at least 10 years of service while still employed by the company, he or she may elect to withdraw the vested portion of employer contributions in his or her account.

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions set forth in the ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

## **Note 2 - Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and other third parties. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

### **Contributions**

Participant contributions and the related Company discretionary matching contributions and the Company discretionary non-elective contributions, if any, are recorded in the year in which the employee contributions are withheld from compensation.

### Payment of Benefits

Benefit payments to participants are recorded upon distribution.

### Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

### Note 3 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Pooled separate accounts - Valued at fair value based on the net asset value (NAV) of the units held in the account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the observable market prices of the underlying investments within the account less liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The pooled separate accounts consist of various investment options (i.e. common stock, mutual funds, short-term securities, real estate) and are valued based on the investments held. While the majority of the underlying asset values are quoted prices, the net asset value of the pooled separate accounts are not publicly quoted.

The following is a brief description of the nature and significant investment strategies of the major categories of pooled separate accounts:

(a) Asset allocation funds – These funds seek long term growth of capital by investing in alternative strategies and alternative asset classes.

(b) Aggressive growth funds – These funds aggressively seek capital appreciation and are designed primarily for aggressive investors seeking capital growth over the long-term. Investors should be willing to assume the substantial risks of short-term price fluctuations and losses that are typical for an aggressive fund focusing on stock investments in developing and emerging markets.

(c) Growth funds – These funds seek capital appreciation and invest primarily in common stocks and securities convertible into common stock. They may also invest in preferred stocks, warrants, and other debt securities.

(d) Income funds – These funds primarily seek to realize maximum total return, consistent with preservation of capital and prudent investment management.

(e) Growth & income funds – These funds seek to produce income and to provide an opportunity for growth of principal consistent with common stock investing. These funds strive to accomplish this objective through fundamental research, careful selection and broad diversification.

(f) Conservative funds – These funds seek to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term.

**Note 4 - Certified Information**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (the custodian of the Plan).

**Note 5 - Tax Status**

The Plan uses a pre-approved plan document sponsored by Nova 401k Associates, Inc., which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the IRC. The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Related Party and Party-in-Interest Transactions**

Certain Plan investments are units of pooled separate accounts managed by John Hancock Asset Management. John Hancock Asset Management is an entity related to John Hancock Life Insurance Company, the custodian as defined by the Plan. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under the ERISA.

Certain fees incurred by the Plan for recordkeeping services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than as a direct payment.

**Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8 - Transfer to Express Oil & Gas, LLC 401(k) Plan**

Effective January 1, 2024, the Plan was amended to remove or spin off the participant balances of Express Oil & Gas LLC as part of a partial contract termination. The balance of the participants' accounts were transferred out of the Plan to the Express Oil & Gas, LLC 401(k) Plan..

**Note 9 - Plan Amendments**

Effective January 1, 2024, the Plan increased the threshold for the mandatory cash-out limit to \$7,000 in connection with the SECURE 2.0 Act. The Plan shall be formally amended to adopt the other provisions of the Act by December 31, 2026.

**Note 10 - Subsequent Events**

Effective January 1, 2025, the Plan has been restated and the following amendments will apply to the Plan:

- The eligibility requirement for participation increased from 3 months of service to 6 months of service.
- The automatic deferral rate will increase from 2% to 3% of eligible compensation for an employee who are hired on or after January 1, 2025.
- The Plan will implement an automatic escalation feature that increases deferral rates by 1% of compensation annually, up to a maximum of 5% of compensation. Escalation will occur on the first day of each plan year.
- Roth Elective Deferral accounts will be eligible for hardship withdrawals in accordance with Plan rules and applicable regulations.

The Plan sponsor has evaluated subsequent events through September 29, 2025, the date which the financial statements were available to be issued.
