Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Operations

The XOtech & Ganuch, Inc. 401(k) Plan (the Plan) is a defined contribution profit-sharing plan covering eligible employees of XOtech, LLC and Ganuch, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Basis of Accounting

The financial statements are reported using the accrual basis of accounting in which revenue is recognized when earned or otherwise available, and expenses are recognized when incurred.

Investment Valuation and Income Recognition

Investments are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the statements of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid principal balance at year end plus any unpaid accrued interest. The Plan considers the notes receivable from participants fully collectible at year end; accordingly, no allowance for doubtful accounts is required. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits and Excess Contributions

Benefits are recorded when paid. Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability on the statements of net assets available for benefits and as a deduction on the statements of changes in net assets available for benefits. There were no excess contributions paid during 2024 and 2023.

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTE 2 RISKS AND UNCERTAINTIES

Investments – The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 3 DESCRIPTION OF PLAN

The following brief description of XOtech & Ganuch, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all full-time employees of XOtech, LLC and Ganuch, Inc. who are age 21 or older.

Contributions. Financing of the Plan comes from employer and participant contributions and investment income. Rollover contributions by participants are permitted. Participants may elect to defer a specific percentage or dollar amount of their eligible compensation as defined by the Plan. Participants can defer either a pre-tax elective deferral or a Roth elective deferral up to a maximum of 90% of eligible compensation. The Owners of XOtech, LLC and Ganuch, Inc. determine annually, at their discretion, the total amount of employer contributions to be made to the Plan. Employer discretionary contributions may consist of matching contributions and nonelective contributions to eligible participants as defined by the Plan. Employer nonelective contributions are allocated using a nonintegrated (prorata) allocation formula. In no event will the employer plus employee elective deferral contributions exceed the maximum amount permitted by law. There were no discretionary employer contributions for 2024 or 2023.

NOTE 3 DESCRIPTION OF PLAN (Continued)

XOtech, LLC and Ganuch, Inc. may be required to make Prevailing Wage Contributions to those that are employed under specific service contracts, in accordance with The McNamara-O'Hara Service Contract Act of 1965 (SCA). The hourly rates are determined by the Department of Labor, varying by contract, and reduced by any benefits the employees elect. The owners determine annually whether to pay these contributions into participants' 401(K) accounts or in their normal wages. In 2024 and 2023, the contributions were deposited into the eligible participants' 401(K) accounts, whether they were actively contributing themselves, or not. For those employees that were not eligible to participate in the Plan, these contributions were paid in their normal wages. Prevailing wage employer contributions were \$115,092 and \$304,664 for the years ending December 31, 2024 and 2023, respectively.

Under a subcontractor agreement, XOtech, LLC and Ganuch, Inc. are subject to a collective bargaining agreement (CBA) covering specific employees working under the contract. The current CBA requires employer matching contributions for the covered employees in the amount of 100% of the first 3% of employee's voluntary contributions and 50% of the next 2% of employee's voluntary contributions, up to a 4% employer contribution. For the years ending December 31, 2024 and 2023, the employer matching contribution under the CBA were \$8,165 and \$2,884, respectively.

Vesting. Participants are immediately 100% vested in both their elective deferrals and all employer contributions.

Payment of Benefits. Benefit payments are made upon normal retirement, death, disability or termination of service. In-service distributions are also allowed upon reaching age 59 ½ for a minimum amount of \$500. The benefits are paid in a lump-sum payment in accordance with the Plan document. The Plan also allows hardship withdrawals.

The Plan has a mandatory cashout rollover provision if the participant terminates employment and has an account balance of \$5,000 or less but greater than \$1,000. This cashout rollover provision allows the employer to rollover the participant's account balance into an IRA designated by the Plan, unless the participant makes a distribution election.

Participant Accounts. Each participant's account is credited with the participant's contributions, XOtech, LLC and Ganuch, Inc. employer contributions, and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are directed by the Plan participants. Participants may choose among 28 mutual funds and one stable value fund.

NOTE 3 DESCRIPTION OF PLAN (Continued)

Notes Receivable from Participants. The Plan allows for participant loans. Participants may borrow from their accounts a minimum of \$500 and a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All loans shall be for a fixed term of not more than five years. A longer repayment term may be allowed for a loan which shall be used to acquire the participant's principal residence. The loans are collateralized by no more than 50% of the vested balance in the participant's account and bear interest at a rate of 1% over the prime rate. Only two loans per participant are permitted at one time.

Plan Termination. Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the net assets of the Plan will be allocated as prescribed by ERISA and regulations pursuant thereto.

NOTE 4 FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board authoritative guidance on fair value measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Common and Collective Trust: The fair value of the Plan's investment in the common and collective trust is determined by its sponsor.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

All assets have been valued using a market approach, except as noted above.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 TAX STATUS

The Plan is an adoption of a prototype standardized profit-sharing plan and is qualified under Section 401(a) of the Internal Revenue Code plan and is therefore, not subject to tax under present income tax law.

The prototype plan obtained its latest determination letter on July 16, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 6 SUMMARY OF INFORMATION CERTIFIED BY PLAN CUSTODIAN

The total fair value of investments held in trust was \$5,192,256 and \$5,029,543 at December 31, 2024 and 2023, respectively. The total amount of notes receivable from participants held in trust was \$39,464 and \$84,291 at December 31, 2024 and 2023, respectively.

The Custodian, Reliance Trust Company, has supplied the Plan's administrator with certifications as to the completeness and accuracy of all information regarding investments and notes receivable from participant assets, transactions, and income presented in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the statements of changes in net assets available for benefits for the years ending December 31, 2024 and 2023, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 7 PARTIES-IN-INTEREST

A party-in-interest is defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. Plan assets are used to pay some expenses for administration of the Plan and the remaining administrative expenses are paid by the employer. Payments to such service providers by the Plan qualify as party-in-interest transactions.

NOTE 8 PLAN AMENDMENTS

Effective January 1, 2024, the Plan's eligibility requirements were amended to include additional exclusions. Under the new amendment, the following classifications of employees are now excluded from contributing to the Plan.

- Residents of Puerto Rico and Guam.
- Collective bargaining agreement (CBA) employees that are eligible for the Teamsters National 401k Savings Plan.

NOTE 9 SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 29, 2025, the date on which the financial statements were available to be issued.
