- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.



- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

DECEMBER 31, 2024 AND 2023**

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the Zidell Employees Profit Sharing / 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan which contains a cash or deferred arrangement pursuant to Section 401(k) of the Internal Revenue Code (IRC). The Plan covers all employees of the participating Zidell Companies (the Company) who have met eligibility requirements under the Plan. Employees are eligible to participate in the Plan on the first day of the month following their hire date. Employees who are employed on December 31 and have 1,000 hours of service during the year are eligible to receive an allocation of the profit sharing contribution, if a profit sharing contribution is made, for the Company(ies) they worked for during the year.

Contributions - Contributions consist of employee elective deferrals, employee qualified rollover contributions, employer matching contributions, employer discretionary profit sharing contributions and employer qualified non-elective contributions. Employee elective deferrals and employer matching contributions are recorded in the year which the employer elective deferrals are withheld from compensation.

Each year the employer reviews the annual profitability of the Company. The Board of Directors of the employer may authorize a profit sharing contribution to the Plan for the year. The permitted range of profit sharing contributions is from 0% to 25% of the participants' eligible annual compensation. There was no profit sharing contribution in 2024 and 2023. The Plan permits the reduction of the profit sharing contribution of all highly compensated employees to the extent necessary to satisfy the minimum coverage requirements of IRC Section 410(b) or the nondiscrimination requirements of Code Section 401(a)(4).

Under the 401(k) feature of the Plan, highly compensated employees may voluntarily contribute up to 24% of compensation for 2024 and 2023 and non-highly compensated employees may contribute up to 60% of compensation to the Plan for 2024 and 2023, in increments of whole percentages. Participant contributions are limited to \$23,500 in 2024 and \$22,500 in 2023, respectively, as prescribed by the IRC. Participants age 50 and older may elect to make an additional catch up contribution of up to \$7,500 annually.

The Plan has an automatic enrollment provision. Under the provision, newly eligible participants are automatically enrolled at a 3% contribution rate. Participants can elect out of the provision or otherwise change their deferral rate.

On behalf of each participant who has made a 401(k) contribution to the Plan, the employer shall contribute to the trustee a matching contribution. The matching contribution shall be an amount equal to the lesser of 25% of the participant's 401(k) contribution for the Plan year, or 2.25% of the participant's compensation for the Plan year.

The Plan allows after-tax contributions to a segregated Roth 401(k) account. The Plan also allows direct rollovers from 401(k) plans, profit sharing plans, and Roth elective deferral accounts to the extent permitted by law.

Participant Accounts - A separate account is maintained for each participant, which is credited with the allocation of the employer's and participant's contribution and Plan earnings or loss. Profit sharing contributions are allocated based on participant compensation, as defined. Plan earnings are allocated based on the value of a participant's account. The benefit to which a participant is entitled is the combined benefit that has been allocated to the participant's account. Other than when a participant dies or terminates employment, a withdrawal is permitted only after a participant attains age 62.

Vesting - Participants are immediately 100% vested in all amounts credited to their accounts.

Payment of Benefits - Upon termination of service, a participant may request receipt, rollover, or transfer of a cash distribution equal to the value of his or her account. An employee who has attained age 62 may elect a payment withdrawal of any portion of his or her account. With limited exceptions, in service distributions must commence no later than April 1 of the calendar year following the year in which the participant attains age 70½.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding increase to distributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants in March 2025 and 2024, respectively.

Expenses - Administrative expenses may be paid by the Company. Administrative and investment expenses not paid by the Company are satisfied through fees charged to the participant accounts based upon relative account values, and until October 2024, were charged on a monthly basis. In October 2024, the Plan changed from a monthly charge to charging participant accounts as Plan expenses are incurred. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses.

Forfeitures - The Plan did not have forfeited account balances at December 31, 2024 or 2023. Forfeited accounts generally are the result of Company matching contributions made to employees who have excess contributions issued to them and include earnings thereon. Forfeitures were used to reduce employer matching contributions by \$5,162 and \$0 in 2024 and 2023, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and management and operating expenses associated with the Plan's investments in mutual funds and a collective investment trust.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments - Benefit payments are recorded when paid. Accordingly, benefits payable to persons that have elected to withdraw from the Plan but are not yet paid have not been accrued. At December 31, 2024 and 2023, there were no amounts payable to participants.

Administration of the Plan - Certain administrative functions are performed by officers or employees of the Company(ies). No such officer or employee receives compensation from the Plan. Some administrative expenses and recordkeeping fees are paid directly by the Company(ies).

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

NOTE 3 – FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Basis of Fair Value Measurement

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Interest-bearing cash: Valued at cost, which approximates fair value.

Collective investment trust: The Plan holds investments in the Morley Stable Value Fund, a collective investment trust (the CIT) that is comprised primarily of fully benefit-responsive investment contracts. Principal Global Investors Trust Company is the trustee of the CIT. The objective of the CIT is to provide a diversified group of investments offering competitive levels of yield consistent with a stable fixed income methodology and the careful and prudent assumption of investment risk providing for preservation of capital stability and predictability of returns, liquidity to pay Plan benefits and high credit quality. The CIT invests in other conventional, synthetic and separate account investments contracts issued by life insurance companies, banks, and other financial institutions that invest in a portfolio of securities, primarily equity securities, money market funds and US treasuries. Units in the CIT are valued based on the underlying investments, the majority of which are based on quoted prices. The NAV provided by the trustee is used as a practical expedient to estimate fair value. Units in common investment trust funds are not publicly traded, but rather, are redeemable only by the issuer. The value of the Plan's investment in common investment trust funds represents the value of the Plan's interests in the overall value of the common investment trust fund. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal to ensure that securities liquidation will be carried out in an orderly business manner. Investments in common investment trust funds can generally be redeemed without restriction; however, in certain cases, redemption or purchase may be limited to prevent excess and/or short-term trading. In addition, if a fund experiences periods of insufficient liquidity then the fund may defer honoring any payment request until liquidity is sufficient.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – NOTES RECEIVABLE FROM PARTICIPANTS

The Plan allows loans to be made to a participant based on the value of the participant's 401(k) elective deferral, matching and any rollover accounts. The minimum loan amount is \$1,000. The maximum loan is 50% of the total amount of the participant's 401(k) elective deferral, matching and rollover accounts reduced by any outstanding loans or \$50,000, whichever is less. Loans must be repaid within five years, except for loans made for the purchase of a primary residence. Interest is charged at reasonable market rates as determined by the Plan administrator. As of December 31, 2024, interest rates on outstanding participant loans ranged from 4.25% to 9.50%, with various maturities through April 2033. Loans are secured by the 401(k) account balance of the participant.

NOTE 5 – INFORMATION CERTIFIED BY TRUSTEE OF THE PLAN

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income and revenue sharing for the years then ended, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Charles Schwab Trust Bank, the trustee of the Plan.

NOTE 6 – RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

The Plan administrator is an employee of the Company and is also a participant in the Plan. Certain Plan investments consist of interest-bearing and non interest-bearing cash managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the trustee, therefore, these transactions qualify as party-in-interest transactions. Investment management and administrative fees paid to Charles Schwab Trust Bank amounted to \$18,586 and \$21,535 in 2024 and 2023, respectively.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon Plan termination, the Company may continue the Plan to pay benefits as they mature, or liquidate and distribute the relevant portion of the Plan to a successor defined contribution plan, or in the absence of a successor plan, to the participants. Net assets transferred or distributed shall be allocated to participants in proportion to their interests.

NOTE 8 – CONCENTRATIONS, RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits, and therefore participants' account balances. There are four and three investments that individually represented more than 10% of the investments held as of December 31, 2024 and 2023, respectively. See the supplemental Schedule of Assets (Held at End of Year) for the complete listing of investments held as of December 31, 2024.

NOTE 9 – INCOME TAX STATUS

The Plan document is a non-standardized pre-approved profit sharing plan sponsored by CCH Incorporated, dba FTWilliam.com. The Plan document obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving its latest determination letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 10 – SUBSEQUENT EVENTS

The Plan's management has performed an evaluation of subsequent events through October 1, 2025, which is the date these financial statements were available to be issued.

Effective August 26, 2025 the Plan submitted notice to terminate its participation in the Morley Stable Value Fund (Fund) subject to certain withdrawal restrictions as outlined in the Fund's disclosure document. The Plan does not expect liquidation of the Fund to occur prior to August 2026.
