Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of Minneapolis Clinic Employees' Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as of and for the year ended December 31, 2022, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by a qualified institution that prepared and certified the investment information in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the first two paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified. In addition, because of inherent limitations in internal control, including the possibility of management override of controls, misstatements due to fraud or error may occur and not be detected by such controls. However, as discussed below, we identified certain deficiencies in internal control that we consider to be a material weakness.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis.

**Material weakness**

We consider the following deficiencies in the Plan's internal control to be a material weakness

**Preparation of Financial Statements**

The Benefits Committee and management share the ultimate responsibility for the Plan's internal control system. While it is acceptable to outsource various accounting functions, the responsibility for internal control cannot be outsourced. The Plan engaged CliftonLarsonAllen LLP to assist in preparing the financial statements and accompanying disclosures, however, as independent auditors, CliftonLarsonAllen LLP cannot be considered part of the Plan's internal control system. As part of its internal control over the preparation of its financial statements, including disclosures, the Plan should consider implementing a comprehensive review procedure to ensure that the financial statements, including disclosures, are complete and accurate. Such review procedures should be performed by an individual possessing a thorough understanding of applicable generally accepted accounting principles and knowledge of the Plan's activities and operations. The Plan's personnel have not monitored recent accounting developments to the extent necessary to enable them to prepare the Plan's financial statements and related disclosures, to provide a high level of assurance that potential omissions or other errors that are material, would be identified and corrected. This puts management at risk of not detecting material errors in the financial statements.


**Management's response**

Management would like to point out that this only relates to the preparation of the annual audited financial statements, supplemental schedule, and disclosures. We currently maintain effective internal control and review procedures by performing all recommended functions with the exception of the preparation of the annual financial statements, supplemental schedule, and disclosures.

The Plan has a system of internal control that it will continue to maintain. Management will continue to evaluate the cost benefit of using external resources to prepare a draft of the audited financial statements, supplemental schedules, and disclosures. As is common with many plans, we recommend continuing to utilize our external auditors in assisting with the preparation of the annual financial statements, supplemental schedule, and disclosures.

Minneapolis Clinic Employees' Pension Plan's written response to the material weakness identified in our audit was not subjected to the audit procedures applied in the audit of the financial statements and, accordingly, we express no opinion on it.

### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Minneapolis Clinic Profit Sharing & 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Minneapolis Clinic Profit Sharing & 401(k) Plan (the Plan) provides general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan. The Plan covers substantially all employees of Minneapolis Clinic of Neurology, Ltd. (the Clinic or Plan Sponsor) excluding nonresident aliens and employees covered by a collective bargaining agreement. The Plan is subject to ERISA, as amended.

**Eligibility**

Employees are eligible for the 401(k) deferral and employer safe harbor nonelective contribution features of the Plan after attaining age 18 and completing 60 days of service and will become active participants in the Plan the first of the month immediately following or coincident with the completion of the eligibility requirements. Employees are eligible for the nonelective discretionary contribution upon the completion of two years of service (1,000 hours each year), who are age 18 or older and are employed on the last day of the Plan year. Employees enter the Plan with regards to nonelective discretionary contributions on January 1 or July 1 immediately following or coincident with the completion of the eligibility requirements.

**Contributions**

Eligible employees are automatically enrolled in the Plan with a participant contribution equal to 3% of eligible compensation, unless otherwise directed by the participant. Effective June 1, 2024, Eligible employees are automatically enrolled in the Plan with a participant contribution equal to 4% of eligible compensation, unless otherwise directed by the participant. The automatic deferral percentage will increase each Plan year for which the employee is a participant, subject to a specified schedule, up to a maximum of 10% of eligible compensation. Participants may direct their contributions to pre-tax or Roth accounts. In addition, the Clinic makes a nonelective safe harbor contribution equal to 4% of qualifying compensation for participants employed by the Clinic any time during the Plan year.

The Clinic's nonelective discretionary contribution to the Plan is made at the discretion of its board of directors. Subject to certain exceptions, participants must be employed on the last day of the Plan year to receive an allocation of the nonelective discretionary contribution. Nonelective discretionary contributions were \$1,210,507 and \$1,192,332 for the years ended December 31, 2024 and 2023, respectively.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. All contributions are subject to certain limits.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Clinic's contributions and Plan earnings, net of certain expenses. The Clinic's contributions are allocated to participants using a basic contribution rate plus an integrated rate multiplied by excess recognized compensation, as defined by the Plan, for the Plan year. Allocations of Plan earnings, net of certain expenses, are based on participant account balances, as defined in the Plan. Participants are allowed to self-direct their investment of the account balances in a variety of funds.

**Vesting**

Participants are immediately vested in all contributions plus actual earnings thereon.

**Notes Receivable from Participants**

Participants may borrow from their accounts up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The notes receivable are secured by the balance in the participant's account and bear interest. Principal and interest is paid ratably through monthly payroll deductions.

**Benefit Payments**

Upon termination of service, death, disability, or retirement, the participant has the option to receive the value of the vested interest in his or her account in the form of a lump sum distribution. The Plan allows for in-service distributions if a participant reaches age 59½ subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accounting records of the Plan are maintained on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

The Clinic pays certain administrative expenses on behalf of the Plan. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Certain investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Clinic terminated their sponsored Minneapolis Clinic Employee's Pension Plan (Pension Plan) in 2024. As result of the termination, in 2025, excess qualified assets of the Pension Plan approximately \$1.7 million were transferred into the Plan. Per the termination agreement, the amount will be used to reduce future Clinic contributions over a period of seven years.

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 12, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION**

Delaware Charter Guarantee & Trust Company dba: Principal Trust Company, the qualified institution, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE MEASUREMENT**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Collective Trust Funds:* Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**NOTE 4 FAIR VALUE MEASUREMENT (CONTINUED)**

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Account:* Valued at the NAV of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

*Self-Directed Brokerage Funds:* The self-directed brokerage funds include mutual funds, common stock and ADRs. The mutual funds are valued as per the above. The common stock and ADRs are valued at the closing price reported in the active market in which the individual security is traded.

Although it has not expressed any intent to do so, the Clinic has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 6 PLAN TAX STATUS**

The Plan is placing reliance on an opinion letter received from the IRS on the pre-approved plan indicating that the Plan is qualified under Section 401 of the IRC and is therefore, not subject to tax under current income tax law. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by the qualified institution of the Plan and, therefore, the investment transactions qualify as party-in-interest transactions.
