### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of G.S. Long Co., Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of G.S. ## G.S. Long Co., Inc. 401(k) Profit Sharing Plan Notes to Financial Statements

---

### Note 1 – Description of Plan

The following description of the G.S. Long Co., Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of Plan provisions.

**General** – The Plan is a 401(k)-salary deferral and profit-sharing plan covering substantially all employees of G.S. Long Co., Inc. and G.S. Long Co. of Oregon, Inc., and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). G.S. Long Co., Inc. (the Company), is the Plan's sponsor and serves as Plan administrator.

**Eligibility** – Employees of the Company are eligible to participate in the Plan upon reaching age 21, and after completing one year of service in, which at least 1,000 hours are worked. Participants must complete at least 1,000 hours of service during the Plan year and be employed as of the last day of the Plan year, to be eligible to receive any discretionary, nonelective contributions.

### Contributions

*Participant contributions* – Each year, participants may contribute between 1% and 100% of pretax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

*Employer safe harbor* – The Company makes safe harbor matching contributions up to 4% of the participant's eligible compensation, regardless of the employee's hours of service or employment on the last day of the Plan year.

*Employer nonelective contributions* – The Company may elect to make discretionary additional matching contributions to the Plan. If the Company elects, they will match 100% of employee contributions, up to 6% of eligible compensation deferred to the Plan. There were no employer nonelective contributions for the year ended December 31, 2024.

Contributions are subject to regulatory limitations.

**Participant accounts** – Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's nonelective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

### Notes to Financial Statements

**Vesting** – Participants are vested immediately in their contributions and employer safe harbor match contributions plus actual earnings thereon. Vesting in the Company’s employer discretionary additional matching contribution portion of their account is based on years of continuous service. Participants vest in the Company’s nonelective contributions based on the following schedule:

**Notes receivable from participants** – Participant loans are not permitted by the Plan.

**Payment of benefits** – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. A participant who terminates employment with a vested balance of \$5,000 or less will have an automatic rollover of their entire vested balance.

**Forfeitures** – Forfeitures are the nonvested portion of a participant’s account that is lost upon termination of employment. Forfeitures are retained in the Plan, must be used no later than in the subsequent year, and may be used by the Plan to reduce employer contributions, to pay reasonable Plan expenses, or to allocate as additional discretionary nonelective contributions. As of December 31, 2024 and 2023, there were no forfeited nonvested accounts, and no forfeitures were used during the year ended December 31, 2024.

#### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in accordance with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment valuation** – The investments are reported at fair value and contract value. The Plan’s custodian, John Hancock Life Insurance Company (U.S.A.), certifies the contract value of the guaranteed interest contracts and the fair value of all other investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

**Contributions** – Contributions from participants and corresponding matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through August 19, 2025, which is the date the financial statements were available to be issued.

### **Note 3 – Investments**

The Plan's investments consist of units held in pooled separate accounts (PSAs), that are valued using the net asset value (NAV), practical expedient of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding. There are no unfunded commitments from participants in the Plan who invest in these accounts. The Plan has no restrictions on its ability to redeem any of the pooled separate accounts. Except for a trading restriction of two investment trades per month (with a third allowed for a safe haven fund), there are no other restrictions as it relates to participant directed transactions and withdrawals as of December 31, 2024 and 2023.

The Plan invests in the following significant pooled investment funds:

*John Hancock Multimanager Growth LS* – The investment seeks long-term growth of capital with current income as a secondary consideration.

*John Hancock Multimanager Aggressive LS* – This investment seeks long-term growth of capital by investing all of the portfolio's assets in underlying portfolios that invest primarily in equity securities.

*Money Market Fund* – This investment seeks high liquidity by investing in high quality, short-term debt securities, cash, and cash equivalents.

*John Hancock Multimanager Moderate LS* – This investment seeks to achieve a balance between a high level of current income and growth of capital, with a greater emphasis on income.

*John Hancock Multimanager Balanced LS* – This investment seeks to achieve a balance between a high level of current income and growth of capital with greater emphasis on growth of capital.

*Vanguard Target Retirement 2030* – This investment seeks to broaden diversification while incrementally decreasing exposure to stocks and increasing exposure to bonds as the target retirement date approaches.

*500 Index Fund* – This investment seeks to replicate the performance of the S&P 500 index. It is composed of 500 of the largest publicly traded companies in the United States.

*Vanguard Short-Term Federal* – This investment seeks to provide current income while maintaining limited price volatility. The fund will invest at least 80% of its assets in short-term bonds issued or guaranteed by the United States government and its agencies.

There have been no changes to the valuation techniques used at December 31, 2024 and 2023.

The valuation techniques used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 4 – Guaranteed Interest Accounts with John Hancock Life Insurance Company (U.S.A.)**

In 2019, the Plan entered into benefit-responsive guaranteed interest accounts (the Accounts) with John Hancock Life Insurance Company (U.S.A.). John Hancock Life Insurance Company (U.S.A.) maintains the contributions in a general account. The Accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero. The crediting rate is reviewed on a monthly basis for resetting. The fully benefit-responsive investment contract (FBRIC) does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the FBRIC criteria and is; therefore, reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by John Hancock Life Insurance Company (U.S.A.), represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

#### **Note 5 – Tax Status**

The Plan document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with the investment securities, that changes in the values of investments in the near term could materially affect a participant's account and the amounts reported in the statements of net assets available for benefits.

#### **Note 7 – Certified Investment Information**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (U.S.A.), the custodian of the Plan, has certified to the completeness and accuracy of the following:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation and interest income in fair value of investments reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year).

#### **Note 8 – Party-in-Interest Transactions**

Plan investments are managed by John Hancock Investment Management, LLC. John Hancock Investment Management, LLC, is an affiliate of John Hancock Life Insurance Company (U.S.A.), which is the custodian of the Plan, and, therefore, transactions with these entities qualify as exempt party-in-interest transactions.

#### **Note 9 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.
