To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of MasterMold LLC 401(k) Plan ("the plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor ("DOL")'s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions, as further described in Note 1 to the financial statements, covering the years and periods ended December 31, 2024 and 2023, stating that the investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's elections of ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audits is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

ERISA-Required Supplementary Information

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and is derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the 2024 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of accounting - MasterMold LLC 401(k) Plan ("the plan") follows the accrual method of accounting wherein additions and deductions are reflected in the period earned or incurred.

Accounting estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Risks and uncertainties - The plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent events - The financial statements include management's evaluation of the events and transactions occurring subsequent to December 31, 2024 through August 29, 2025, which is the date the financial statements were available to be issued.

Key parties of the plan - MasterMold LLC is the plan sponsor, employer and plan administrator. Definiti LLC is the third party administrator that maintains plan documents and tax counsel that performs various compliance tests. Three officers of the plan sponsor act as plan trustees. Amicus Wealth Advisory Group is the plan's investment advisor.

Prior to November 17, 2023, Nationwide Trust Company, FSB was the recordkeeper that maintained investment and participant records and held custody of the mutual fund investments and Nationwide Life Insurance Company was the investment agent that held custody of the fixed select investment option. The two investment agents were collectively referred to as "Nationwide". Effective November 17, 2023, Reliance Trust Company ("Reliance Trust") became custodian of the plan's interest-bearing cash, common/collective trusts and mutual fund investments and Transamerica Retirement Solutions, LLC assumed the responsibilities of recordkeeper for the plan and maintains investment and participant records. Transamerica Life Insurance Company Inc. is the custodian that holds the plan's stable value core account investment. Prior to July 1, 2024, Reliance Trust Company was the custodian that held the plan's mutual fund investments. Effective July 1, 2024, Transamerica Trust Company assumed the role of custodian that holds the plan's mutual fund investments. The related Transamerica entities are collectively referred to as "Transamerica".

Investments - The plan sponsor determines the investments available to plan participants. The participants allocate their contributions and transfer existing balances among the available investment options. Earnings, including the net appreciation (depreciation) in fair value of investments bought, sold, and held during the years, are reflected in the statements of changes in net assets available for benefits. Participants should refer to the prospectuses and annual reports of the investments for more information.

Fair value measurements - GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical investments (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Valuation is based upon quoted prices in active markets for identical investments.
- Level 2 - Valuation is based upon other significant observable inputs (including quoted prices for similar investments).
- Level 3 - Valuation is based upon significant unobservable inputs (including the plan's assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for investments measured at fair value.

Interest-bearing cash - Consists of cash deposits with various banks and other financial institutions through agreements with Reliance Trust. Such deposits generally earn interest consistent with money market rates. The cash deposits may be withdrawn at any time without prior notice or penalty. Interest-bearing cash is stated at cost plus accrued interest, which approximates fair value.

Mutual funds - Valued at the daily quoted market prices as reported by the fund. The mutual funds held by the plan are registered with the U.S. Securities and Exchange Commission, are required to publish their daily net asset value ("NAV") and are deemed to be actively traded.

Common/collective trusts - The common/collective trusts held by the plan are a part of a single direct filing entity and are valued at their NAVs. The NAVs are used as practical expedients to estimate fair values and are generally based on the fair values of the underlying investments held by the common/collective trusts less their liabilities. The practical expedient would not be used if it is determined to be probable that the common/collective trusts would sell the investments for an amount different from the reported NAVs.

The plan administrator determines by level, within the fair value hierarchy, the plan's investments at fair value as set forth below.

Investment at contract value - The plan has a traditional fully benefit-responsive investment contract through a group annuity contract issued by Transamerica. This is an investment based on the general unallocated account of Transamerica. Transamerica pays interest and guarantees the plan's capital deposit regardless of the activity in the general account. The investment is not considered a Guaranteed Investment Contract or Common Collective Trust as there are no specific underlying securities and no stated minimum or maximum interest rate. The investment, as a deposit liability of Transamerica with no underlying assets, has no direct investments on behalf of the plan. The investment value is based on the general unallocated account of Transamerica and the risk of investment is based on Transamerica's insurance ratings. The effective annual interest rate is established every six months. Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six month period.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of the investment at contract value.

The contract does not have a maturity date and there are no contract provisions that require a distribution at contract value at any specified time. Although plan participants may direct withdrawals at any time without restrictions, a hold can apply in the event the plan sponsor request a full distribution from the investment. The plan has no intention to request a full distribution at this time.

The plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events might limit the ability of the plan to transact at contract value with the issuer. As of the date these financial statements were available to be issued, the plan administrator is not aware of any events that may limit the ability of the plan to transact at contract value with the contract issuer or limit the ability of the plan to transact at contract value with the participants.

2. DESCRIPTION OF PLAN

The following brief description of the plan is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

General - The plan was established on January 1, 2018 as a defined contribution plan with a 401(k) salary deferral arrangement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments.

Eligibility - Employees that reach 18 years of age are eligible to make elective contributions once they have completed two months of service. Employees are allowed to enter the plan on the first day of the month coinciding with or following meeting these eligibility requirements. To receive discretionary employer contributions, employees must also be employed on the last day of the year and have completed 1,000 hours of service during the plan year to which the contributions relate.

Contributions - Contributions are recorded in the year in which the eligible compensation is paid. Contributions to the plan can be made as follows:

- a. Participants may contribute a percentage of their compensation, subject to certain limitations (elective deferral contributions). The plan also allows Roth elective deferral contributions. Upon meeting the eligibility requirements, employees are automatically enrolled in the plan and have 2% of compensation withheld as elective deferral contributions. These participant deferral percentages automatically increase by 1% each year on January 1 until they reach a maximum of 6%. Such employees have the option to increase, decrease, or stop the deferral by completing the necessary documentation.
- b. Participants may make rollover contributions to the plan from other qualified plans.
- c. Employer matching contributions may be made at the employer's discretion. The discretionary matching contributions are funded on an annual basis, subsequent to the year to which the contributions relate. Employer matching contributions were \$0.50 of every \$1.00 contributed to the plan by employees, up to 2.10% of an employee's compensation during 2024 and up to 6% of an employee's compensation during 2023.
- d. Employer nonelective contributions may be made at the employer's discretion. No such contributions were made in 2024 or 2023.

Participant accounts - Earnings, including the fair value appreciation (depreciation), are allocated to participant accounts on a daily basis based upon the performance of the investment options selected. Each participant's account is credited with the participant's elective deferral and rollover contributions and an allocation of employer contributions. Participants are allowed to transfer funds between the various investment options on a daily basis and change their deferral percentage each pay period.

Vesting - Participants are always 100% vested in their elective deferral and rollover contributions and related earnings. Participants begin vesting in employer contributions and related earnings upon completing two years of service at which time they are 20% vested. The participant then vests at the rate of 20% for each year thereafter. Upon death, disability or attainment of normal retirement age (defined as age 65) while employed, participants become 100% vested.

Payment of benefits - Benefits are recorded when paid. Benefit payments may commence upon death, disability, retirement or termination of employment. Distributions are generally in the form of a single lump sum or partial payments. Hardship withdrawals are allowed under certain circumstances and in-service distributions are permitted after reaching age 59½.

Forfeitures - Forfeitures may be used to pay administrative expenses or reduce employer contributions. Forfeitures used to pay administrative expenses were \$5,000 in 2024 and \$6,000 in 2023. Unapplied forfeitures were \$62,000 and \$2,000 as of December 31, 2024 and 2023. Forfeitures used in 2025 to fund a portion of the employer discretionary matching contributions receivable were \$26,000.

Administrative expenses - Certain administrative expenses of the plan are paid by the employer and not included in these financial statements. Certain other fees are paid using plan assets and recorded as administrative expenses in these financial statements. Such expenses include participant directed charges for distributions fees and nonparticipant directed charges for service and administrative fees. Nonparticipant directed fees are allocated to the participants on an account value basis

Notes receivable from participants - Loans to participants are not permitted by the plan.

3. TERMINATION OF PLAN

Although it has not expressed any intent to do so, the employer has the right to terminate the plan at any time subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and related earnings.

4. INCOME TAX STATUS

The plan is operating under a National Administration, Inc. non-standardized pre-approved profit sharing plan that received a favorable opinion letter dated June 30, 2020. The letter provided by the Internal Revenue Service stated that the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator has not obtained a separate Internal Revenue Service opinion or determination letter for the plan; however, the plan administrator and tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize tax liabilities (or assets) for any uncertain tax positions taken that more likely than not would not be sustained upon examination by the applicable authorities. Plan management analyzed the requirements for accounting for such uncertain tax positions taken and determined the plan was not required to recognize any tax liabilities (or assets) related to uncertain tax positions taken as of December 31, 2024 and 2023. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress.

5. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investment options are managed by the custodians. The custodians also provide certain administrative services to the plan pursuant to service agreements between the plan sponsor and custodians and therefore, these transactions qualify as party-in-interest transactions. Direct fees paid by the plan to the custodians were \$13,000 in 2024 and \$16,000 in 2023. A portion of the 2023 direct fees are recorded as a reduction of net appreciation (depreciation) in fair value of investments in the accompanying statements of changes in net assets available for benefits. In addition, the custodians receive indirect compensation from mutual fund providers for services provided to the funds. This indirect compensation is used to offset certain amounts that would otherwise be owed by the plan for administrative services. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

6. INFORMATION CERTIFIED BY THE CUSTODIANS

Management has obtained certifications from the custodians (as defined in Note 1), which are qualified institutions under the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, that state the following information with respect to assets held for investment of the plan is complete and accurate.

- a. Investments held and the fair and contract values of such as of December 31, 2024 and 2023;
- b. Dividend and interest income from investments and net appreciation (depreciation) in fair value of investments during 2024 and 2023; and
- c. Contributions to, withdrawals from, purchases, sales and transfers between investment accounts during 2024 and 2023.
