Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Scientific Certification Systems, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 – Description of Plan

The following description of the Scientific Certification Systems, Inc. 401(k) Profit Sharing Plan (the Company) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of the Company's provisions.

General – The Company is a 401(k) salary deferral and profit sharing plan covering substantially all employees of Scientific Certification Systems, Inc. (the Company), and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Company is the Company's sponsor and serves as the plan administrator.

Eligibility – Employees of the Company are eligible to participate in the Company upon reaching age 21 and after completing three months of service. Entry into the Company will occur immediately upon satisfaction of the minimum age requirement and service requirements. Employees that are part of a collective bargaining agreement (union) cannot participate in the Company. Employees that are nonresident aliens, part time, temporary, and seasonal employees who's regularly scheduled service is less than 1,000 hours, also cannot participate in the Company. Participants are eligible for discretionary nonelective contributions, if the participant is employed on the last day of the plan year and if the participant completed at least 1,000 hours of service during the plan year.

Contributions

Participant contributions – Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Company. Upon reaching the age of 50, participants may elect to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer match and discretionary nonelective contributions – The Company has both a discretionary employer match contribution and a discretionary nonelective contribution. The discretionary employer matching contribution is 50% of participant elective contributions per payroll period. Participants are eligible for the discretionary employer match contribution upon meeting the eligibility requirements for participation and after completing three months of service. The Company's discretionary employer match contributions totaled \$1,503,064 for the year ended December 31, 2024. The discretionary nonelective contribution amount is at the sole discretion of the Company. There were no discretionary nonelective contributions for the year ended December 31, 2024.

Contributions are subject to regulatory limitations.

Participant accounts – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, contract terms, or account balances, as defined. Participants may direct the investment of their account balances into various investment options offered by the Company. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are fully vested in their salary deferrals plus actual earnings thereon. The Company’s employer match and discretionary nonelective contributions and earnings thereon are vested in accordance with the following schedule.

Notes receivable from participants – A participant may borrow a minimum of \$1,000 and up to 50% of their vested account, but not in excess of \$50,000. A participant may have two loans outstanding at any time. Loans are secured by the balance of the participant’s account and bear a fixed rate of interest, defined as Prime plus 1%, as determined by the plan administrator. The maximum loan term is five years, unless the loan is for the purchase of a home, in which case a longer term may be permitted. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, the rate of interest on outstanding loans ranged from 5.00% to 9.50%, with various maturities through April 2034.

Payment of benefit – On termination of service due to death, disability, or retirement, or otherwise becoming eligible to receive benefits, a participant may elect to receive either a lump-sum amount or an annuity equal to the value of the participant’s account balance. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Company also allows in-service withdrawals for participants who have attained age 59 ½, participants that have incurred a financial hardship, and for participants who have incurred a disability. Terminated participants less than 62 years old with a vested account balance of \$5,000 or less receive a mandatory distribution. Terminated participants age 62 or greater with a vested account balance of \$1,000 or less receive a mandatory rollover distribution. Each former plan participant, of any age, required to receive a mandatory distribution who did not inform the Company’s sponsor their elections on how to receive the mandatory distribution will receive an automatic rollover distribution of an established individual retirement account.

Forfeitures – Forfeitures are the nonvested portion of a participant’s account that are lost upon termination of employment. Forfeitures are retained in the Company. Allocations of forfeitures are applied subsequent to year end and may be used to pay plan administrative expenses and to reduce employer and/or matching contributions.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – Investments are reported at fair value. The Company's trustee, Empower Trust Company, LLC, certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (i.e., the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of participant-directed investments consists of both the realized gains or losses and unrealized appreciation or depreciation of those investments.

Contributions – Contributions from participants and corresponding matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Company.

Expenses – Administrative expenses related to operating and maintaining the Company are paid by the Company. Certain transaction fees are paid by participants in the Company.

Payments of benefits – Benefits are recorded when paid.

Subsequent events – Subsequent events are events or transactions that occur after the statements of net assets available for benefits date, but before the financial statements are available to be issued. The Company recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statements of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Company's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statements of net assets available for benefits, but arose after the statements of net assets available for benefits date and before the financial statements are available to be issued.

The Company has evaluated subsequent events through August 25, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

Basis of Fair Value Measurement

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Company has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Company are deemed to be actively traded. Mutual funds held by the Company are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

Collective trusts – Units held in collective trusts (CTs) are valued using the NAV practical expedient of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding.

The CT can be redeemed daily, and there are no redemption restrictions or notice requirements.

Note 4 – Information Certified by The Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee of the Company has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of participant-directed investments, interest and dividends, and interest income from notes receivable from participants reflected in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the supplemental schedule of assets (held at end of year).

Note 5 – Tax Status

The Company is a volume submitter profit sharing plan that received a favorable opinion letter from the Internal Revenue Service on November 14, 2022, which stated that the Company, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Company has been amended since receiving the opinion letter, the plan administrator believes that the Company is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Notes to Financial Statements

In accordance with guidance on accounting for uncertainty in income taxes, the plan administrator has evaluated the Company's tax positions and does not believe the Company has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Company is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risk. It is reasonably possible that given the level of risk associated with investment securities, changes in the near term could materially affect a participant's account balance and the amounts reported in the financial statements.

Note 7 – Plan Termination

Although it has not expressed any intention to do so, the Company has the right to terminate the Company and discontinue its contributions at any time. If the Company is terminated, amounts allocated to a participant's account become fully vested.
