Note 1 - Description of the Plan

The following description of the Trident Seafoods Corporation 401(k) Retirement Plan (the Plan) provides only general information about the Plan. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan, established April 1, 1980, covering all eligible employees of Trident Seafoods Corporation (the Company). The Company acts as the plan administrator. The Plan's trustee is Fidelity Management Trust Company (Fidelity). The Plan's recordkeeping service is provided by Fidelity Workplace Services, LLC (Fidelity Recordkeeping).

Eligibility - Employees of the Company who are age 18 or older are eligible to participate in the Plan. The entry date is the first day of the month coinciding with or subsequent to the date on which such employees meet the eligibility requirements. The Plan covers all full-time employees of the Company with the exception of any employee who is covered by a collective-bargaining agreement, unless such agreement expressly provides for coverage under the Plan, or who is a nonresident alien who does not receive any earned income from sources within the United States.

Contributions - Participants may elect to contribute at least 1% but not more than 50% of their annual eligible compensation as pre-tax or Roth contributions, subject to certain limitations under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make "catch-up" contributions. Participants who are eligible for "catch-up" contributions, may elect to contribute up to 75% of their annual eligible compensation, subject to certain limitations under the IRC. Participants may also contribute amounts representing distributions from other eligible retirement plans (rollover).

The Company makes safe harbor matching contributions equal to 100% of the first 3% of deferrals and 50% of the next 2% of deferrals, subject to certain limitations under the IRC. The Plan includes a true up feature to ensure participants receive their maximum matching contribution for the year, regardless of the timing of contributions, and any amounts due are contributed to the participant's account subsequent to year end.

Participant Accounts - Participant contributions to the Plan are voluntary. Each participant's account is credited with the participant's contribution, the Company's matching contributions, and increases or decreases in the market value of investments. Allocations of earnings and losses are based on a ratio of the participant's account balance to the total Plan account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants are allowed to direct the investments of all contributions into various investment options that offer a diversity of investment risk and return.

Vesting - Participants are immediately vested in their salary deferral contributions and Company matching contributions, and actual earnings thereon.

Payment of Benefits - Upon termination of service, retirement, death, or disability, a participant or beneficiary may elect to receive installment payments or a lump-sum distribution equal to the value of the participant's vested interest in their account. Participants who have attained age 59½ may also elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

Note 1 - Continued

Upon termination of service, a participant or beneficiary will automatically receive the vested interest in their account as a lump-sum payment if their vested balance is \$5,000 or less.

Notes Receivable From Participants - Participants may obtain loans from the Plan as specified by the plan document. A participant's loan is limited to the lesser of \$50,000 or 50% of the participant's vested account balance. The minimum loan amount is \$1,000. Loans are payable through payroll deductions over a period ranging up to five years, unless such loan is for the purchase of a primary residence, in which case the repayment period may be extended to ten years. The Plan also allows terminated employees to continue making payments on their outstanding loans directly to Fidelity. If such a participant is rehired, their regular loan payment schedule will resume. The interest rate is based on the prime rate published in the Wall Street Journal on the last business day of the month immediately preceding the month in which the loan was issued, plus 1%. Principal and interest are paid ratably through payroll deductions.

Note 2 - Summary of Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities with disclosure on contingent assets and liabilities at the date of the financial statements and reported amounts of additions to or deductions from plan assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments represents the change in fair value of assets from one period to the next and includes realized gains and losses on investments.

Notes Receivable From Participants - Notes receivable from participants are measured at the unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Several of the investment fund options are subject to investment management and recordkeeping fees based on a percentage of invested assets, as disclosed in the funds' prospectus. All such fees are charged directly against the funds' investment performance and thus are not separately disclosed in the accompanying financial statements.

Note 2 - Continued

The Plan has a revenue sharing account under the fee arrangement between Fidelity Recordkeeping and the Company. Recordkeeping fees that Fidelity Recordkeeping receives in excess of the per participant annual recordkeeping fee are deposited to the plan's revenue credit account. Fees of \$239,896 were incurred during the year ended December 31, 2024. These fees were offset by revenue share credits of \$85,619, resulting in net fees of \$154,277 during the year ended December 31, 2024.

Subsequent Events - The Plan's management has evaluated subsequent events through September 5, 2025, the date on which the Plan's financial statements were available to be issued.

Note 3 - Fair Value Measurements

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under this guidance are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. The funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 3 - Continued

Pooled Separate Account - The New York Life Anchor Account is a pooled separate account group annuity contract (PSA) that is valued at their NAV as determined by New York Life. NAV per unit is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Participants eligible to receive benefit payments may withdraw the value of their pooled separate accounts, in whole or in part, at any time. However, transfer restrictions may exist. If the Company terminates the contract, redemption restrictions may apply.

Self-Directed Brokerage Accounts - Accounts include interest-bearing cash, common stocks, certificates of deposit, mutual funds, government bonds, and corporate debt securities. Interest-bearing cash is valued at cost plus accrued interest, which approximates fair value. Common stocks are valued on the basis of readily determinable market prices. Corporate debt securities, government bonds, and certificates of deposit are valued using published prices (where available) or pricing models maximizing the use of observable inputs for similar securities.

Note 4 - Information Certified by the Trustee

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 5 - Party-in-Interest Transactions

Certain plan investments are shares of mutual funds managed by an affiliate of Fidelity Recordkeeping. Fidelity Recordkeeping serves as the recordkeeper for the Plan and Fidelity serves as the trustee to the Plan, therefore, these transactions qualify as party-in-interest transactions. Management fees charged by the affiliate on such mutual funds are reflected in the NAV of shares held by the Plan. Neither Fidelity nor the affiliate charges the Plan a separate fee for administering such mutual funds. The Plan also issues loans to participants which are considered a party-in-interest transaction.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7 - Tax Status

The Company adopted an FMR LLC pre-approved plan document. FMR LLC received an approval letter from the IRS dated June 30, 2020, which states that the form of the plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 1 - Description of the Plan

The following description of the Trident Seafoods Corporation 401(k) Retirement Plan (the Plan) provides only general information about the Plan. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan, established April 1, 1980, covering all eligible employees of Trident Seafoods Corporation (the Company). The Company acts as the plan administrator. The Plan's trustee is Fidelity Management Trust Company (Fidelity). The Plan's recordkeeping service is provided by Fidelity Workplace Services, LLC (Fidelity Recordkeeping).

Eligibility - Employees of the Company who are age 18 or older are eligible to participate in the Plan. The entry date is the first day of the month coinciding with or subsequent to the date on which such employees meet the eligibility requirements. The Plan covers all full-time employees of the Company with the exception of any employee who is covered by a collective-bargaining agreement, unless such agreement expressly provides for coverage under the Plan, or who is a nonresident alien who does not receive any earned income from sources within the United States.

Contributions - Participants may elect to contribute at least 1% but not more than 50% of their annual eligible compensation as pre-tax or Roth contributions, subject to certain limitations under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make "catch-up" contributions. Participants who are eligible for "catch-up" contributions, may elect to contribute up to 75% of their annual eligible compensation, subject to certain limitations under the IRC. Participants may also contribute amounts representing distributions from other eligible retirement plans (rollover).

The Company makes safe harbor matching contributions equal to 100% of the first 3% of deferrals and 50% of the next 2% of deferrals, subject to certain limitations under the IRC. The Plan includes a true up feature to ensure participants receive their maximum matching contribution for the year, regardless of the timing of contributions, and any amounts due are contributed to the participant's account subsequent to year end.

Participant Accounts - Participant contributions to the Plan are voluntary. Each participant's account is credited with the participant's contribution, the Company's matching contributions, and increases or decreases in the market value of investments. Allocations of earnings and losses are based on a ratio of the participant's account balance to the total Plan account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants are allowed to direct the investments of all contributions into various investment options that offer a diversity of investment risk and return.

Vesting - Participants are immediately vested in their salary deferral contributions and Company matching contributions, and actual earnings thereon.

Payment of Benefits - Upon termination of service, retirement, death, or disability, a participant or beneficiary may elect to receive installment payments or a lump-sum distribution equal to the value of the participant's vested interest in their account. Participants who have attained age 59½ may also elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

Note 1 - Continued

Upon termination of service, a participant or beneficiary will automatically receive the vested interest in their account as a lump-sum payment if their vested balance is \$5,000 or less.

Notes Receivable From Participants - Participants may obtain loans from the Plan as specified by the plan document. A participant's loan is limited to the lesser of \$50,000 or 50% of the participant's vested account balance. The minimum loan amount is \$1,000. Loans are payable through payroll deductions over a period ranging up to five years, unless such loan is for the purchase of a primary residence, in which case the repayment period may be extended to ten years. The Plan also allows terminated employees to continue making payments on their outstanding loans directly to Fidelity. If such a participant is rehired, their regular loan payment schedule will resume. The interest rate is based on the prime rate published in the Wall Street Journal on the last business day of the month immediately preceding the month in which the loan was issued, plus 1%. Principal and interest are paid ratably through payroll deductions.

Note 2 - Summary of Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities with disclosure on contingent assets and liabilities at the date of the financial statements and reported amounts of additions to or deductions from plan assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments represents the change in fair value of assets from one period to the next and includes realized gains and losses on investments.

Notes Receivable From Participants - Notes receivable from participants are measured at the unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Several of the investment fund options are subject to investment management and recordkeeping fees based on a percentage of invested assets, as disclosed in the funds' prospectus. All such fees are charged directly against the funds' investment performance and thus are not separately disclosed in the accompanying financial statements.

Note 2 - Continued

The Plan has a revenue sharing account under the fee arrangement between Fidelity Recordkeeping and the Company. Recordkeeping fees that Fidelity Recordkeeping receives in excess of the per participant annual recordkeeping fee are deposited to the plan's revenue credit account. Fees of \$239,896 were incurred during the year ended December 31, 2024. These fees were offset by revenue share credits of \$85,619, resulting in net fees of \$154,277 during the year ended December 31, 2024.

Subsequent Events - The Plan's management has evaluated subsequent events through September 5, 2025, the date on which the Plan's financial statements were available to be issued.

Note 3 - Fair Value Measurements

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under this guidance are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. The funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 3 - Continued

Pooled Separate Account - The New York Life Anchor Account is a pooled separate account group annuity contract (PSA) that is valued at their NAV as determined by New York Life. NAV per unit is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Participants eligible to receive benefit payments may withdraw the value of their pooled separate accounts, in whole or in part, at any time. However, transfer restrictions may exist. If the Company terminates the contract, redemption restrictions may apply.

Self-Directed Brokerage Accounts - Accounts include interest-bearing cash, common stocks, certificates of deposit, mutual funds, government bonds, and corporate debt securities. Interest-bearing cash is valued at cost plus accrued interest, which approximates fair value. Common stocks are valued on the basis of readily determinable market prices. Corporate debt securities, government bonds, and certificates of deposit are valued using published prices (where available) or pricing models maximizing the use of observable inputs for similar securities.

Note 4 - Information Certified by the Trustee

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 5 - Party-in-Interest Transactions

Certain plan investments are shares of mutual funds managed by an affiliate of Fidelity Recordkeeping. Fidelity Recordkeeping serves as the recordkeeper for the Plan and Fidelity serves as the trustee to the Plan, therefore, these transactions qualify as party-in-interest transactions. Management fees charged by the affiliate on such mutual funds are reflected in the NAV of shares held by the Plan. Neither Fidelity nor the affiliate charges the Plan a separate fee for administering such mutual funds. The Plan also issues loans to participants which are considered a party-in-interest transaction.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7 - Tax Status

The Company adopted an FMR LLC pre-approved plan document. FMR LLC received an approval letter from the IRS dated June 30, 2020, which states that the form of the plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
