Notes to Financial Statements

Note 1: Description of Plan

The following description of the Unity Limited Partnership 403(b) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed, defined contribution plan that operates under Section 403(b) of the Internal Revenue Code (IRC) covering all employees of Unity Limited Partnership (the "Sponsor"), except collectively bargained employees and non-resident aliens who receive no compensation from the Sponsor which constitutes U.S. source income. Employees can participate in the Plan as soon as administratively feasible following employment at the Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. A director of the Sponsor determines the appropriateness of the Plan's investment offerings and monitors investment performance. Participants are eligible for a discretionary matching contribution offered by the Sponsor if the participant is employed by the Sponsor at the end of the plan year and has been credited with at least 12 months of service and 1,000 hours of service during the plan year.

Secure 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. All provisions of SECURE 2.0 have been and will continue to be evaluated and implemented by plan management in accordance with future regulations and guidance, and the Plan will be amended, as needed.

Contributions

Each year, all eligible participants immediately upon hire may contribute up to 100% of their eligible pre-tax annual compensation, as defined by the Plan, up to the annual maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan also allows participants to contribute Roth contributions and rollover distributions from other qualified plans (rollovers).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless the employee affirmatively elects not to participate in the Plan. Participants who are automatically enrolled in the Plan have their deferral rate set at 1% of eligible compensation and their contributions invested in a designated fund until it is changed by the participant.

Contributions (Continued)

The Sponsor provides a discretionary matching contribution equal to 100% of each participant's deferral contribution, up to the first 4% of participant compensation. In addition, the Sponsor has the option to make a discretionary profit sharing contribution each year. The Sponsor's discretionary matching contribution was \$468,977 for the year ended December 31, 2024. No discretionary profit sharing contributions were made during 2024.

Contributions are subject to certain IRS limitations.

Participant Accounts

All investments in the participants' accounts are participant directed. The Plan allows participants to select from a variety of investment options with a mix of mutual funds and a money market fund.

Each participant's account is credited with the participant's contribution and the Sponsor's discretionary matching contribution and allocations of (a) the Sponsor's discretionary profit sharing contribution and (b) plan earnings or losses, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary and rollover contributions plus actual earnings or losses thereon. Participants vest in the Sponsor's discretionary matching and profit sharing contributions plus actual earnings/losses thereon at a rate of 20% each year beginning with the first year of credited service, with participants becoming fully vested after five years of credited service. Participants who leave the Sponsor because of disability or death or reaches normal retirement age (65) becomes 100% vested in all accounts.

Payment of Benefits

On termination of service due to death, disability, or normal retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or installment payments if the account balance is greater than \$5,000. If the participant's vested account balance does not exceed \$5,000, it can be distributed only in a single lump-sum payment. For termination of service because of other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Note 1: Description of Plan (Continued)

Forfeitures

Plan forfeitures arise as a result of participants terminating service with the Sponsor before becoming 100% vested in the Sponsor's discretionary matching and profit sharing contributions.

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,116 and \$2,650, respectively. The Sponsor may decide in its discretion how to treat forfeitures under the Plan. Forfeitures in the amount of \$12,027 were used to pay plan administrative expenses during the plan year ended December 31, 2024.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan were prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Sponsor and, therefore, are excluded from these financial statements. Fees related to the administration of distributions are charged directly to the participant and are included in administrative expenses, except retirement and disability distributions, which are paid by the Sponsor. Fees for certain other administrative services are allocated proportionately to participants based on their respective account balances and are also included in administrative expenses. Fees for investment management services are allocated proportionately to participants based on their respective account balances and are included in total investment income.

Subsequent Events

The Plan has evaluated subsequent events through September 3, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued using NAV as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The fund invests in short-term debt securities designed to maximize current income with liquidity and capital preservation. The fund has no unfunded commitments and redemption frequency and redemption notices occur on a daily basis. Because the fund is measured at fair value using the NAV per share (or its equivalent) practical expedient, it has not been classified in the fair value hierarchy.

Note 3: Fair Value Measurements (Continued)

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Information Prepared and Certified by Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Associated Trust Company, N.A., the Custodian of the Plan.

Note 5: Party-in-Interest Transactions

The Plan pays fees for administrative and investment management services to Associated Trust Company, N.A., the Custodian and record keeper; therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Sponsor contributions.

Note 7: Tax Status

The Sponsor adopted a volume submitter 403(b) plan with an IRS opinion letter which states the form of the plan adopted is in compliance with the applicable sections of the IRC. The plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRS and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
