1. DESCRIPTION OF PLAN

The following description of Data Analysis, Inc. Investment Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

Data Analysis, Inc. adopted the Plan effective January 1, 1990. The Plan is a defined contribution plan, which covers employees of Data Analysis, Inc. and its affiliates (the Company), that include William O'Neil & Co. Incorporated; O'Neil Global Advisors Inc.; O'Neil Digital Solutions LLC; and O'Neil Securities, Incorporated. The Plan is designed to provide participating employees the opportunity to accumulate retirement funds through a tax-deferred contribution arrangement pursuant to Section 401(k) of the Internal Revenue Code of 1986, as amended (the Code). In addition to the Code, the Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Administration of the Plan

The Board of Directors of the Company is responsible for oversight of the Plan. The Plan Committee, as appointed by the Board of Directors of the Company, determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors.

Voya Institutional Trust Company (VITC) serves as the Plan's trustee. Voya Retirement Insurance and Annuity Company (VRIAC) is the custodian and recordkeeper of the Plan. The Company acts as the Plan administrator (the Plan Administrator) and the Plan sponsor (the Plan Sponsor). Most administrative expenses of maintaining the Plan are paid by the Company.

Participation

Participation in the Plan is available to all eligible employees who have completed one month of service. Rehired employees who were previously participants in the Plan are eligible to reenter the Plan immediately.

The Plan accepts direct cash rollovers from other qualified plans regardless of whether the employee has met the Plan's eligibility requirements.

Employees who become eligible to participate in the Plan are automatically enrolled in the Plan to make pretax deferrals unless the employee affirmatively elects not to make pretax deferrals within the applicable time period as described by the Plan. The employee is deemed to have elected to contribute 4% of the employee's pretax compensation each payroll period into a Voya targeted fund, selected based on age and estimated retirement, until a subsequent valid election is made by the participant. The deferral amount is increased by 1% of compensation up to a maximum of 7% at the beginning of each Plan year.

Contributions

The Plan allows participants to contribute in whole percentages from 1% to 100% of their base compensation on a pretax basis or after-tax contribution (Roth), through payroll deductions. A participant's total contributions, in any Plan year, cannot exceed the limits provided under Section 415 of the Code. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions.

The Plan Sponsor has the option of making matching contributions and discretionary contributions but is not obligated to make such contributions.

For the year ended December 31, 2024, the Company made a matching contribution equal to 30% of the amount of a participant's salary reduction contribution up to the first 4% of eligible compensation as defined by the Plan. The Company did not elect to make a discretionary contribution to the Plan in 2024.

Vesting

Participants are immediately 100% vested in both their elective deferrals and employer matching contributions upon contribution. Upon termination of employment, participants are entitled to receive a lump-sum distribution equal to the value of their account. Certain employer matching contributions made in 2022 and prior years were subject to specific vesting schedules.

Participant Accounts

Each participant's account is credited with participant's contributions and employer contributions and any earnings and/or gains/losses resulting from the investment of those contributions. Participants are charged with an allocation of administrative expenses that are paid by the Plan and upon any distributions from the participant accounts. Each participant may select the investment funds in which his or her contributions will be invested and may change his or her election anytime. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Benefits, Distributions and Withdrawals

On termination of service due to death, disability, retirement or termination, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or elect to keep the balance in the Plan. Participants with account balances under \$5,000 are required to withdraw their balances from the Plan within 60 days. Participants with account balances of \$5,000 or more may elect a distribution at any time following the termination of employment. Annuity payments are available if the participant selects one of the Voya Lifetime Income Protection Funds. All amounts are to be distributed in accordance with the minimum required distribution provisions of the Code.

Notes Receivable from Participants

Participants are permitted to borrow from their accounts subject to certain limitations and conditions established to comply with the current requirements of the Code. All notes receivable made to participants are secured by their accounts. Participants may borrow a maximum of one outstanding note receivable at any time.

Notes receivable may have a term of up to five years; however, the term can be extended up to 30 years if the loan is used to acquire or construct a principal residence of the participant. The interest rate on notes receivable is prime rate, plus 1% which ranges between 4.25% and 9.50% for the notes receivable as of December 31, 2024.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$21,692 and \$13,652, respectively. During the year ended December 31, 2024, \$9,428 of forfeitures were used to fund employer contributions and administrative expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP) using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of net assets available for benefits for a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the term of the Plan.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on the investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan but have not yet been paid as of December 31, 2024 and 2023.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Reclassifications

Certain reclassifications have been made to the 2023 financial statements presentation to correspond to the current year's format.

Subsequent Events

The Plan Administrator has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data, by correlation, or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value at December 31, 2024 and 2023:

Pooled separate accounts – valued based on each account’s daily accumulated unit value (AUV), which is considered by Plan management to be the best approximation of fair value. Data for AUV’s are distributed to the Plan Administrator on the qualified service providers’ website and provide corroborative evidence to ascertain the relationship between each funds AUV and the values of the individual underlying holdings. Underlying holdings held in the separate accounts are mutual funds and common collective trust funds and are primarily valued using market quotations or process obtained from independent pricing sources.

Common collective trust funds: – Valued at NAV provided by the fund's Trustee. The NAV is based upon the fair value of the underlying investments held by the respective fund less its liabilities.

There are no unfunded commitments from participants in the Plan who invest in the pooled separate accounts and common collective trusts held by the Plan.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a fully benefit-responsive guaranteed investment contract with the VRIAC. The custodian maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate is reviewed on a monthly basis for resetting. The guaranteed investment contract does not permit VRIAC to terminate the agreement prior to the scheduled maturity date. The contract value of the guaranteed investment contracts at December 31, 2024 and 2023, was \$8,294,381 and \$9,397,557, respectively.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by the VRIAC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value on a daily basis.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) Plan termination or merger, (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that causes a significant withdrawal from the Plan, (4) premature termination of the contract, or (5) failures of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of a material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

The Plan Administrator does not believe that any events that may limit the ability of the Plan to transact at contract value or terminate the contract with the issuer are probable as of December 31, 2024, or the date these financial statements are available to be issued.

5. INFORMATION CERTIFIED BY THE CERTIFYING ENTITIES

Certain information related to investments disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income for the year ended December 31, 2024, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by VITC and VRIAC.

6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. Some of the pooled separate accounts, common collective trusts, and the benefit-responsive investment contract are managed by the VITC and VRIAC. Fees paid for investment management services were included as a reduction of the return earned on each pooled separate account and common collective trust. Participant notes receivable are related party and party-in-interest transactions. These transactions qualify as party-in-interest transactions as permitted by Department of Labor regulations.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Board of Directors has the right at any time to discontinue its contributions and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all net assets available for distribution at the time of termination would be distributed to participants in proportion to their respective account balances.

8. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. TAX STATUS OF THE PLAN

The Plan has adopted a prototype plan prepared by VRIAC. This prototype plan has obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and therefore believe that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
