### **Opinion**

**NOTE 1 - DESCRIPTION OF THE PLAN**

The Revolutionary Medical Trust (the "Plan") is a multiemployer welfare benefit plan providing hospital, medical, dental, prescription drug, vision, chiropractic and life and accidental death benefits to active participants on whose behalf employers contribute to the Plan in accordance with the collective bargaining agreements. Dependents of eligible active participants are also eligible for the same benefits selected by the eligible participant. Effective March 1, 2021, the Board of Trustees approved the expansion of an early retiree program to all Plan employers and the addition of an early retiree Health Reimbursement Agreement (HRA) option for California retirees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**C. Contributions**

Contributions are reported on the financial statements on the accrual basis. Employer contributions are contributions made by employers on behalf of eligible employees based on a certain rate for the months worked during the year. Participant self-payments are payments by participants for months of coverage during the year. Contributions received in advance of the month worked or the month of coverage are reported as deferred contributions. Contribution rates in effect during the years varied based upon amounts required to be contributed in accordance with collective bargaining agreements between participating unions and various employer groups. The Plan allows for continuation of coverage for eligible active participants as required under COBRA. Rates for COBRA continuation of coverage premiums are set by the Board of Trustees.

**D. Employer Payroll Compliance Program**

Employer remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' records under a separate payroll compliance program.

**E. Cash and Cash Equivalents**

Cash and cash equivalents consists of cash deposited in checking accounts and a certificate of deposit.

**F. Benefits**

Benefits reported are premiums for eligible participants paid during the year (Premiums Paid) net of forfeitures from the HRA. Benefit obligations consist of premiums payable, which is an estimate of premiums for coverage during the year, unpaid at the end of the year, and HRA reimbursements made during the runout period for the current year's eligible medical expenses.

The Plan includes an HRA benefit, which is a health-care reimbursement account designed to permit eligible participants to obtain reimbursement of eligible medical expenses, up to a specified dollar amount annually. Contributions to the HRA are made solely by the employer. The Plan has a 90-day run-out period following the end of the year to submit a claim for reimbursement. All remaining funds after the 90-day run-out period are forfeited to the Plan's general assets.

**G. Postretirement Benefits**

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to participant service rendered to December 31, 2024 and 2023. Postretirement benefits include future benefits expected to be paid to or for (1) retirees and covered dependents, (2) other participants fully eligible for benefits, and (3) other participants not fully eligible for benefits. Before an active participant's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that participant's service in the industry rendered to valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical benefit cost data to estimate future annual incurred benefit cost per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions and methods used at December 31, 2024 (2023, if different) were:

- (a) Discount Rate: 5.40% (4.75%).
- (b) Pre/Post Retirement Mortality: Healthy male and female retirees and beneficiaries prior to retiree's death, Pri-2010 Total Dataset Amount-Weighted Healthy Annuitant Table, projected with fully generational improvement from 2012 with Scale MP-2019.
- (c) Retirement Rates: Ranges from 55 to 70.
- (d) Administrative Expenses: \$38.95 per retiree enrolled in a medical plan per month. \$29.56 per retiree and spouse receiving HRA benefits.
- (e) Actuarial Cost Method: Projected Unit Credit.
- (f) Health Cost Trend: Getzen Model. The administrative expenses are assumed to increase at 3.0% per year. The dental and vision costs are assumed to increase at 4.0% per year. HRA amounts are not trended.
- (g) Other assumptions and methods for monthly capita claims cost, withdrawal rates, HRA utilization and others.

The health care cost trend assumption has a significant effect on the postretirement benefit obligations. A 1% increase in the health care cost trend assumption would increase the net postretirement benefit obligation as of December 31, 2024 and 2023 by \$3,038,240 and \$2,786,723, respectively.

**G. Postretirement Benefits (Continued)**

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postretirement benefit obligations.

**NOTE 3 - TAX-EXEMPT STATUS**

The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701d; therefore, no provision is made for federal or state income taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4 - ADMINISTRATION AND SERVICE CONSULTANT FEES**

The Plan is administered by PacFed Benefit Administrators, Inc. ("PacFed") for a monthly administration fee (composite rate) per participant of \$30.43 for the years ended December 31, 2024 and 2023. The fee includes an online enrollment fee of \$2 and a MRP billing fee of \$4.87 for the years ended December 31, 2024 and 2023.

Service consulting consists of consulting about the Plan and benefits, provided by PacFed Insurance Services, to participants at their place of employment. During the years ended December 31, 2024 and 2023, the monthly fee per participant was \$10.64.

**NOTE 5 - PLAN TERMINATION**

Although there is no intent to terminate the Plan, in the event of termination, the Declaration of Trust provides that any assets remaining in the Plan shall be used solely for the continuance of health and welfare benefits to participants, beneficiaries and employees and eligible members of their families in a fair, equitable basis until such assets have been exhausted.

**NOTE 6 - CONCENTRATION OF CREDIT RISK**

During the year ended December 31, 2024, the Plan maintained bank accounts with cash balances in excess of the federally insured limit of \$250,000 per bank. The amount in excess of the limit was subject to risk if the financial institution did not perform. The Plan has not incurred any losses on the uninsured balances. The uninsured balance at December 31, 2024 was \$7,464,738.

Postretirement benefit obligations are reported based on certain assumptions pertaining to interest rates, inflation rates, participant demographics and other assumptions which are subject to change. Due to the uncertainty of the assumption process it is at least reasonably possible that changes in these assumptions in the near term would be material to the financial statements.

**NOTE 9 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through August 26, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
