**Note 1 - Description of the Plan**

The following description of the PATH Profit Sharing 401(k) Incentive Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General** - The Plan is a defined contribution plan covering all employees of the sponsor, PATH (Program for Appropriate Technology in Health, hereafter referred to as the Organization), who are paid from the United States in U.S. dollars. All covered employees, with the exception of temporary employees, who have completed three months of service are eligible to contribute elective deferrals and receive employer matching and nonelective contributions. Temporary employees must complete 12 months of service to be eligible for the Plan. Employees can enter the Plan beginning the first day of the month following attainment of eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions** - Participants may elect to defer up to 75% of their eligible compensation as pre-tax or Roth contributions. Effective May 1, 2025, the Plan was amended to allow for after-tax contributions and limited the total of after-tax, pre-tax and Roth contributions to 75% of eligible compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans. The Plan includes an automatic enrollment provision, under which new participants are set up with a 6% pre-tax deferral unless they formally waive participation or elect a different participation level. Participants may also be subject to an automatic increase of their deferral rate by 1% each year, up to a maximum of 10%, unless otherwise elected.

The Organization matches participant contributions equal to 100% of the first 2% of eligible compensation contributed and 50% of the next 4% of eligible compensation contributed. The Organization also makes a nonelective contribution equal to 8% of eligible compensation.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts** - Participants are allowed to direct the investment of all contributions into various investment options that offer a diversity of investment risk and return. Each participant’s account is credited with any contributions made to the account as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are to be paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting** - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Matching contributions are fully vested after one year of service. Vesting in the employer nonelective contribution is based on years of continuous service as follows:

#### Note 1 - Continued

**Payment of Benefits** - Upon termination of service, retirement, or disability, a participant may elect to receive a lump sum payment equal to or any portion of the value of their vested account or installment payments. The Plan's money purchase pension source's normal form of distribution is an annuity. A deceased participant's vested account will be distributed to a beneficiary in accordance with the provisions specified in the Plan document. Participants who have attained age 59½ may elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

**Forfeitures** - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$631,000 and \$372,000, respectively. During 2024, \$337,678 in forfeited accounts were used in accordance with the provisions specified in the Plan document.

#### Note 2 - Significant Accounting Policies

**Basis of Accounting** - The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates** - The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits** - Benefits are recorded when paid.

**Investment Management and Administrative Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Participant accounts may be charged directly for certain transaction based fees. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

#### Note 3 - Fair Value Measurements

GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

#### Note 3 - Continued

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are considered actively traded.

Collective Trust Funds - Valued on a daily basis at the NAV provided by the fund's trustee which is based on the fair value of the underlying investments held by the fund less its liabilities. These funds trade on a regular basis, have published prices that the Plan can obtain at any time and transact based on published prices.

#### Note 4 - Certified Investments

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company, a qualified institution. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

#### Note 5 - Party-in-Interest Transactions

The Plan invests in shares of mutual funds and collective trust funds managed by an affiliate of the Plan's trustee. Transactions with these investments and fees paid from the Plan to the Plan's trustee and its affiliates qualify as party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers. These transactions are party-in-interest transactions.

#### Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participants would become 100% vested in their employer contributions.

#### Note 7 - Tax Status

The Organization adopted a T. Rowe Price Retirement Plan Services, Inc. (TRP) pre-approved plan document. TRP received an approval letter from the IRS dated August 19, 2020, which states that the form of the plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

#### **Note 8 - Risks and Uncertainties**

The Plan's mutual funds and collective trust funds invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Market risks include global events such as a pandemic or international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

#### **Note 9 - Delinquent Contributions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets. While the Organization remitted all employee contributions to the Plan, contributions of \$1,594,493 and \$545,303 were not remitted within the required time period during 2023 and 2022, respectively, and qualify as prohibited party-in-interest transaction under ERISA. Delinquent contributions also represent a related party transaction between the Plan and the plan sponsor. The Organization remitted lost earnings associated with 2023 and 2022 delinquent deposits in 2024. No delinquent contributions were identified for the plan year ended December 31, 2024.

#### **Note 10 - Subsequent Events**

Effective June 2, 2025, the Plan was amended to add a participant loan program. Under the loan program, participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account. Loans are secured by the balance in the participant's account. Interest rates are set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

The Plan's management has evaluated subsequent events through September 23, 2025, the date on which the Plan's financial statements were available to be issued.
