Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Roseburg Forest Products Co., Carpenters Industrial Council Defined Contribution Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Roseburg Forest Products Co., Carpenters Industrial Council Defined Contribution Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Roseburg Forest Products Co., Carpenters Industrial Council Defined Contribution Plan Notes to Financial Statements

Note 1 – Description of Plan

The following description of the Roseburg Forest Products Co., Carpenters Industrial Council Defined Contribution Plan (the Plan) provides only general information. Participants should refer to the Plan Document, as amended, for a more complete description of Plan provisions.

General – The Plan is a defined-contribution plan, established effective June 1, 2017 by Roseburg Forest Products Co. (the Company or Employer). The Plan covers Oregon and Taylorsville, Mississippi employees of the Company working under a collective bargaining agreement in a plant or operation in the lumber industry and whom the Company has agreed to have covered under the Plan. Full-time employees are eligible to participate as soon as administratively practical following his or her date of hire. Part-time employees are eligible to participate upon completion of 500 hours in a calendar year.

The Plan operates under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred compensation arrangement as described in Section 401(k) of the IRC. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participant contributions – Participants may defer from 1% to 50% of eligible compensation. Any participant, upon first becoming eligible to participate in the Plan and who fails to affirmatively make any deferral election, including an election of 0%, will be deemed to have elected to defer 3% of his or her compensation as a pretax contribution. Additionally, on an annual basis, any participant whose elective deferral rate is less than 15% will have his or her rate increased by 1% unless the participant makes an affirmative election, including an election of 0%. Participants may also contribute amounts representing distributions from other qualified plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also elect to make Roth contributions utilizing after-tax contributions.

Employer match and nonelective contributions – The amount of the matching contribution for hourly employees is determined on an annual basis subject to union and other labor contracts. There were no changes to the matching contribution for hourly employees for the years ended December 31, 2024 and 2023. Total employer match contributions and nonelective contributions were \$3,238,327 and \$2,991,253 for the years ended December 31, 2024 and 2023.

Employer discretionary contributions – The Company's discretionary matching contributions are determined on an annual basis subject to union and other labor contracts. There were no discretionary matching contributions for the years ended December 31, 2024 and 2023.

The Company may make a discretionary nonelective contribution each plan year. There were no discretionary nonelective contributions for the years ended December 31, 2024 and 2023.

Participants within certain employer groups are eligible for additional non-elective contributions, calculated as either a one-time lump sum or as a contribution based on hours worked. Additional details about eligibility for these programs are available from Plan management.

Roseburg Forest Products Co., Carpenters Industrial Council Defined Contribution Plan Notes to Financial Statements

Contributions shall not exceed the maximum allowed under the IRC limits.

Participant accounts – A separate account is maintained for each Plan participant. Participants direct the investment elections within their accounts. Participant contributions are credited to the individual's account, along with the Company's contribution, if any. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Participant accounts are valued daily. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Under the Plan, participants are fully vested in all elective participant contributions and transfers from other qualified plans plus net earnings thereon. Company-matching contributions are not vested until participants reach three years of service, as defined by the Plan, at which time they become 100% vested. Nonelective contributions vest 100% after one year of service. Participants also become fully vested in the event of death.

Notes receivable from participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed 10 years. Under the terms of the Plan Document, Plan loans will bear a reasonable rate of interest determined by the lending institutions in similar circumstances, as determined by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans ranged from 5.25% 10.71%, with various maturities through June 2033.

Payment of benefits – Benefits are payable upon retirement, disability, or death in the form of a lump-sum payment. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

If the vested account balance exceeds \$1,000 but is no more than \$5,000, the participant account will be automatically transferred to a qualified Individual Retirement Account selected by the Plan Administrator, unless directed by the participant. If the vested account balance is no more than \$1,000, unless elected by the participant, the entire account will be paid to the participant in a single lump-sum payment as soon as administratively possible following retirement or other termination of employment.

In addition, hardship withdrawals are permitted if certain criteria are met. Such withdrawals will be limited to pretax contributions. Participants cannot take more than four hardship withdrawals per calendar year.

Forfeitures – Forfeitures are the nonvested portion of a participant’s account that are lost upon termination of employment. Company-matching forfeitures of terminated participants’ nonvested accounts are applied as follows: (1) to restore nonvested accounts related to rehired former participants where applicable, (2) to offset future company contributions, and (3) to pay the Plan’s expenses. Nonelective contribution forfeitures are reallocated to other participants in proportion to compensation, as additional nonelective contribution. There were \$71,651 and \$53,221 of forfeitures available at December 31, 2024 and 2023, respectively. During 2024 and 2023, \$127,949 and \$202,621 forfeitures were used to reduce future Company contributions, with any remaining amount used to pay the Plan’s administrative expenses.

Plan Transfers – Any participant covered under a collective bargaining agreement that provides for participation in the Roseburg Forest Products Co. 401(k) Plan (Roseburg 401(k) Plan) may elect to transfer his or her account under the Plan to the Roseburg 401(k) Plan. Any such transfer shall be made pursuant to regulations issued under the IRC.

Transfers between the Plan and the Roseburg 401(k) Plan are disclosed as a net transfer to Roseburg Forest Products Co. 401(k) Plan in the statements of changes in net assets available for benefits.

Note 2 – Significant Accounting Policies

Basis of accounting – The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), using the accrual basis of accounting.

Investment valuation – Investments are reported at fair value as defined by Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s trustee certifies the fair value of all investments. The trustee is a bank or similar institution that is regulated, supervised, and subject to periodic examination by a state or federal agency in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution). See Note 3 for discussion of fair value measurements.

Income recognition – Interest income is recorded as earned on the accrual basis. Purchases and sales of securities are recorded on the trade date. Dividends are recorded on the ex-dividend date.

The change in fair value and realized gains and losses on the investments sold during the year is recognized and included in net appreciation in fair value of investments on the accompanying statements of changes in net assets available for benefits.

Contributions – Contributions from participants and corresponding matching contributions are recorded in the year in which the related participant compensation is earned.

Investment risk – The Plan’s assets are invested in a variety of investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The Plan may invest in shares in registered investment companies and pooled separate accounts, which include securities with contractual cash flows, which may include asset-backed securities, collateralized mortgage obligations, and commercial mortgage-backed securities. The value, liquidity, and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market’s perception of the issuers and changes in interest rates.

Notes receivable from participants – Participant loans are classified as notes receivable from participants, which are segregated from Plan investments and measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Document.

Benefit payments – Benefit payments to participants are recorded upon distribution.

Administrative expenses – Certain of the Plan’s expenses and various legal expenses have been paid directly by the Company. Administrative expenses paid by the Plan consist primarily of administration, managed accounts, loan, and distribution fees.

Use of estimates – The preparation of financial statements in conformity with U.S. GAAP principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from these estimates.

Reclassification – Certain amounts from the prior year statement of net assets available for benefits have been reclassified in order to conform to the current year presentation.

Note 3 – Fair Value Measurements

The FASB ASC Topic 820, *Fair Value Measurement*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to measurements involving significant unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include the quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024.

Registered investment companies – Shares in registered investment companies are valued at published prices in active markets. Shares in registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price.

Pooled separate accounts – Units held in pooled separate accounts (PSAs) are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding.

Collective trusts – Units held in collective trusts (CTs) are valued using the net asset value practical expedient (NAV practical expedient) of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CTs, minus its liabilities, and then divided by the number of units outstanding.

Cash, interest bearing – Valued at fair value based on face value or cost-plus accrued interest, which approximates fair value because of the short maturity of these investments.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event the Plan is terminated, the account of each participant shall be fully vested and nonforfeitable as of the effective date of complete termination of the Plan. Upon complete termination of the Plan, no further employees shall become participants and no further contributions shall be made.

Note 5 – Tax Status

The Plan has adopted a pre-approved Plan Document that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan Administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Party-in-Interest Transactions

Certain Plan investments are managed by Fidelity Management Trust Company (Fidelity). Fidelity is the trustee, as defined by the Plan for the 2024 and 2023 Plan years, and therefore, these investments and investment transactions qualify as party-in-interest transactions. Fidelity is the record keeper as defined by the Plan, and therefore, services performed qualify as party-in-interest transactions.

Note 7 – Information Certified by the Trustee and Custodian

The Plan Administrator has elected the method of annual reporting and compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the financial statements and schedules was provided and certified by the Plan's trustee, Fidelity, as of and for the years ended December 31, 2024 and 2023, are complete and accurate:

- Investments, at fair value
- Notes receivable from participants
- Investment income, net
- Interest on notes receivable from participants
- Schedule H, line 4(i) – schedule of assets (held at end of year)

Note 8 – Reconciliation to Form 5500
