## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of the  
Tapecon, Inc. 401(k) Profit Sharing Plan  
Buffalo, New York

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tapecon, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Tapecon, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. ## TAPECON, INC. 401(k) PROFIT SHARING PLAN

### NOTES TO FINANCIAL STATEMENTS FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

---

#### 1. DESCRIPTION OF THE PLAN

The following description of the Tapecon, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. A copy of this document is available from the Plan Sponsor.

**General** – The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Tapecon, Inc. (the “Company”) is the Plan Sponsor. All full-time employees of the Company who have completed at least six months of service and are at least 19 years old are eligible to participate. The Plan contains an automatic enrollment feature upon an employee meeting the eligibility requirements and employees have the option to opt out of automatic enrollment, if desired. The administrative committee of the Company is responsible for the administration of the Plan.

**Contributions and Earnings** – Participants may elect to contribute up to 100% of their eligible compensation subject to Internal Revenue Service (“IRS”) dollar limitations. Participants may also contribute rollover amounts representing distributions from other defined contribution plans and certain IRAs. The Company matches 50% of the first 3% of eligible compensation. The Company may also make an additional discretionary contribution and the amount may vary from year to year. This contribution is determined at year end by the Board of Directors and is paid in the succeeding year. In order to share in the discretionary contribution, a participant must be credited with at least 1,000 hours of service, as defined during the Plan year, and be a participant on the last day of the Plan year. There were no discretionary contributions made for the years ended December 31, 2024 and 2023.

**Participant Accounts** – Participant accounts are held in a variety of investment funds as directed by the individual participants. Each participant’s account is credited with the participant’s contributions, applicable Company contributions and an allocation of applicable investment fund earnings, based on participant fund balances. The benefit to which a participant is entitled is that which can be provided from the participant’s vested account.

**Vesting** – Participants are automatically fully vested in their own contributions, earnings and any rollover contributions. Company contributions and earnings vest over five years of service. Regardless of years of service, participants are fully vested upon retirement, disability or death.

**Notes Receivable from Participants** – Participants may borrow from their vested accounts a maximum of \$50,000 or 50% of their vested account balance. Note terms range from one to five years or up to ten years for the purchase of a primary residence, are secured by the balance in the participant’s account, and bear interest at a rate commensurate with a local prevailing rate as determined by the trustee, which ranges from 6.25% to 9.50% as of December 31, 2024, maturing through July 2029. Principal and interest are paid ratably through monthly payroll deductions.

**Payment of Benefits** – The Plan provides for normal retirement benefits upon reaching age 65 and has provisions for disability and termination benefits for those participants who are eligible to receive such benefits. The Plan provides for payment of benefits equal to the value of a participant’s account in the form of a lump-sum distribution, the purchase of an annuity, or a combination of these.

## 1. DESCRIPTION OF THE PLAN (continued)

***Withdrawals and Distributions*** – Participating employees may make financial hardship withdrawals up to the value of their vested employee contributions. In addition, the Plan allows for in-service withdrawals for employees who attain the age of 59½.

***Benefits Payable*** – Net assets available for benefits included benefits of approximately \$1,733,000 and \$778,000 due to participants who have withdrawn from participation in the Plan as of December 31, 2024 and 2023, respectively.

***Forfeited Accounts*** – Forfeited non-vested accounts available to offset administrative expenses or future employer contributions totaled \$7,623 and \$5,090 at December 31, 2024 and 2023, respectively. There were forfeitures of \$545 and \$2,079 used to offset administrative expenses during the years ended December 31, 2024 and 2023, respectively.

***Plan Termination*** – Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

***Life Insurance Policies*** – The Plan owns whole life insurance policies for participants who have elected to purchase them using their contributions. This investment option was frozen in 1997 and is no longer offered to the participants.

***Tax Status*** – The Plan Sponsor has adopted the Empower Annuity Insurance Company of America (“Empower”) Non-Standardized Pre-Approved Profit Sharing Plan with Cash or Deferred Arrangement (The “Non-Standardized Plan”). The Non-Standardized Plan received an Opinion Letter from the IRS dated June 30, 2020, stating that the form of the plan is acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. Accordingly, no provision has been made for Federal income taxes in the accompanying financial statements.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

***Basis of Accounting*** – The accompanying financial statements have been prepared on the accrual basis of accounting.

***Investment Valuation and Income Recognition*** – Accounting principles generally accepted in the United States of America require the Plan to determine the fair value of assets and liabilities which are subject to reporting at fair value. These standards establish a hierarchy for the determination of fair value, as well as disclosure requirements relative to those assets and liabilities. The hierarchy identifies three levels of input. Level 1 inputs are generally quoted market prices for identical assets or liabilities, which are actively traded, on an exchange. Level 2 inputs generally consist of market prices for identical assets which are not actively traded or market prices of similar assets or liabilities which are actively traded, on an exchange. Level 3 inputs are referred to as unobservable inputs and consist primarily of information derived by management where Level 1 and Level 2 inputs are not available. These may include such things as present value of expected future cash flows or other valuation methodologies. Under the hierarchy, Level 1 inputs are the most preferred followed by Level 2, and Level 3. Level 3 inputs are to be used when neither Level 1 nor Level 2 inputs are available.

An investment’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

The following is a description of the valuation methodologies used for investments measured at fair value as of December 31, 2024 and 2023:

*Mutual funds:* Valued based on quoted market prices available on an active market, which represents net asset values (“NAV”) of the shares held by the Plan.

*Cash surrender value of life insurance policies:* Value determined by the underwriting insurance company’s valuation models and represents the guaranteed value to be received upon the surrender of these policies.

The preceding methods described may produce a fair value calculation that is not indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation in fair value of investments, which includes realized and unrealized gains and losses on investments that were held or sold during the year.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividend income is recognized on the ex-dividend date.

***Guaranteed Interest Account*** – This account is fully benefit-responsive and is valued based on contract value. Contract value represents contributions made under the contract plus credited interest less participant withdrawals and fees.

***Payment of Benefits*** – Benefits are recorded when paid.

***Expenses of the Plan*** – The majority of Plan administrative expenses, which consist principally of trustee, legal and accounting fees, are paid by the Company and are excluded from these financial statements. Certain expenses are paid by the Plan. Loan fees are paid from the respective participant’s account. Fees paid during the year for these and other services were based on customary and reasonable rates for such services.

***Use of Estimates*** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

***Subsequent Events*** – Management has evaluated the effects of all subsequent events through August 27, 2025, the date the financial statements were available to be issued, to determine if events or transactions occurring through that date require potential adjustment or disclosure in the financial statements.

### 3. FAIR VALUE MEASUREMENTS

The Plan uses fair value measurements to record fair value adjustments to certain assets and to determine fair value disclosures (as discussed in Note 2). The following table sets forth, by level within the fair value hierarchy, the Plan's assets that are measured at fair value as of December 31:

### 4. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 5. TRANSACTIONS WITH PARTIES IN INTEREST

Empower, the custodian of the Plan, managed certain investments of the Plan during the year ended December 31, 2024. Empower is the parent company of Massachusetts Mutual Life Insurance Company. Therefore, transactions with Empower qualify as party in interest transactions.

### 6. CERTIFIED INVESTMENT INFORMATION
