### Scope and Nature of the ERISA Section 103(a)(3)(c) Audit of the Financial Statements

We have performed audits of the financial statements of Mervis Industries, Inc. Profit Sharing & 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Mervis Industries, Inc. December 31, 2024 and 2023

**1. DESCRIPTION OF THE PLAN**

The following description of the Mervis Industries, Inc. Profit Sharing & 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution 401(k) salary deferred plan covering all employees of Mervis Industries, Inc. and Illini Castings, LLC (the "Company") who have attained age 18 and have four months of service. New participants may enter the Plan on a semi-annual basis upon satisfying the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The administrative committee oversees governance of the Plan, determines appropriateness of the Plan's offerings, and monitors investment performance.

**Contributions**

Each year participants may contribute up to 90 percent of pretax annual compensation, or Roth contributions as defined in the Plan. Contributions are subject to certain limitations. Participants may also contribute amounts representing distributions from other qualified plans. The employer may also make a discretionary matching contribution and/or a discretionary contribution equal to a discretionary percentage of employee salary deferrals as needed to satisfy certain ERISA percentage tests. For 2024 and 2023, the Company contributed 3% of employee's eligible compensation. Additionally, the employer absorbs certain costs of administration.

**Participant's Accounts**

Each participant's account is (a) credited with the participant's contribution, an allocation of the Company's contribution and plan earnings and, (b) charged with an allocation of administrative expenses. Allocations are based on participant contributions or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## 1. DESCRIPTION OF THE PLAN (continued)

### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after five years of credited service.

### **Payment of Benefits**

On termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

### **Note Receivable - Participants**

Participants may borrow from their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Loan fund. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

### **Investment Options**

Upon enrollment in the Plan, a participant may direct all contributions in one percent increments into various investment options offered by the Plan. The plan assets were invested in various accounts offered by Fidelity Management Trust Company.

## 2. SUMMARY OF ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with generally accepted accounting principles.

### **Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's management to make estimates and assumptions that affect the reported amounts of plan assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## **2. SUMMARY OF ACCOUNTING POLICIES (continued)**

### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Minimum Funding Requirements**

Contributions to the Plan have been funded in accordance with the minimum funding standards of ERISA.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Subsequent Events**

The Plan's management has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued.

## **3. INFORMATION CERTIFIED BY THE TRUSTEE**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

#### 4. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the years presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

##### *Level 1 Fair Value Measurements*

The fair value of mutual funds is based on the net asset value (NAV) provided by the transfer agents for the funds. The fair value of interest bearing cash is based on quoted market prices.

##### *Level 2 Fair Value Measurements*

The fair value of common/collective trusts is based on the underlying securities within the fund as determined by the trust sponsor. Unit values are determined by dividing the fund's net assets at fair value by the fund's outstanding shares.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers of investments into or out of Level 3.

#### 5. DEFERRED VESTED BENEFITS AND FORFEITED ACCOUNTS

Assets allocated to participants who have withdrawn from the Plan amounted to \$-0- at December 31, 2024. There were unallocated assets of \$949 at December 31, 2024.

Assets allocated to participants who have withdrawn from the Plan amounted to \$-0- at December 31, 2023. There were unallocated assets of \$930 at December 31, 2023.

#### 6. PLAN TERMINATIONS

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan terminations, participants will become 100 percent vested in their accounts.

**7. TAX STATUS**

The Plan is a prototype plan prepared by Fidelity Management Trust Company (Fidelity). The Internal Revenue Service has determined and informed Fidelity by a letter dated June 30, 2020, that the plan as then designed was in compliance with applicable sections of the Internal Revenue Code (IRC).

**8. REPORTABLE TRANSACTIONS**

There were no single transactions or series of transactions within the plan year in excess of five percent of the current value of the plan assets that are required to be reported on the Form 5500.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**10. PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are shares of investment funds managed by Fidelity Trust Management Company. Fidelity Trust Management Company, the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment advisor services amounted to \$33,036 and \$29,237 for the years ended December 31, 2024 and 2023, respectively. The Plan also paid \$41,449 and \$37,686 for third party administrator services for the years ended December 31, 2024 and 2023, respectively.
