Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Wilshire Country Club 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to Section 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with Section 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Wilshire Country Club 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan was effective January 1, 2010.

General: The Plan is a defined contribution plan established by Wilshire Country Club (Plan Sponsor or Club) and allows eligible employees the opportunity to participate in the salary deferral, matching, and profit-sharing components of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: To be eligible for the salary deferral portion of the Plan, employees must be 21 years of age and must have completed six (6) months of service. To be eligible for the discretionary Plan Sponsor matching contribution, employees must have attained age 21 and completed the required amount of service. Additionally, employees who have attained age 21, completed 12 months of service during the Plan year, and are employed on the last day of the Plan year are eligible for discretionary Plan Sponsor profit sharing contributions.

Contributions: The Plan allows participants to defer 1% to 75% of their salary, as defined by the Plan, in lieu of receiving such amounts as compensation. For the year ended December 31, 2024, the maximum compensation deferral was \$23,000. For participants aged 50 and older, an additional catch-up of \$7,500 was allowed for the year ended December 31, 2024.

Effective January 1, 2023, the Plan adopted a Safe Harbor Matching Contribution provision in which the Plan Sponsor matches 100% on participant salary deferrals up to 4% of compensation.

For the profit-sharing component of the Plan, the contribution by the Plan Sponsor is discretionary, but is not to exceed the maximum amount allowable for Federal income tax purposes.

Investment Elections: Each participant may direct that salary deferrals, matching, and profit-sharing contributions be invested in one or more of the available investment options.

Participant Accounts: Each participant's account is credited or charged with the participant's contributions, Plan Sponsor discretionary contributions, an allocation of earnings or losses from the participant's self-directed investments, and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested account balance. Receivables are secured by the vested balance in the participant's account, and bear interest at the prime rate of interest plus 1%. Principal and interest are paid ratably through recurring payroll deductions. Terms must not exceed five (5) years, unless used for the purchase of a primary residence where the term cannot exceed ten (10) years.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of their account is based on years of service. Each participant's account vests as follows:

Years of Service	Vested Percentage
Less than 2 years	0%
2 but less than 3 years	20
3 but less than 4 years	40
4 but less than 5 years	60
5 but less than 6 years	80
6 or more years	100

Notwithstanding the above, if a participant (1) attains the age of 65, (2) dies, or (3) terminates employment by reason of permanent disability, the Plan Sponsor's discretionary contributions become 100% vested without regard to years of service.

Forfeitures: Upon termination of employment, participants forfeit non-vested balances. Non-vested balances are available to be used to reduce Plan Sponsor contributions or pay Plan-related expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$35,000 and \$15,000, respectively. During the year ended December 31, 2024, no forfeiture balances were used to pay Plan expenses or reduce Plan Sponsor contributions.

Payment of Benefits: Upon retirement, death, disability or other termination of employment, a participant or the beneficiary is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in his or her own account.

In-service distributions are allowed upon either attaining age 59-1/2, or experiencing financial hardship as defined by the Internal Revenue Code (IRC). Such withdrawals are subject to applicable excise and income taxes and may only be made with the approval of the Plan Administrator.

Management of Trust Fund: A member of the Club and an employee of the Club function as trustees of the Plan subject to guidelines established by the trust agreement. The trustees are responsible for the investment and administration of the retirement fund in accordance with the trust agreement. The trustees receive no compensation from the Plan.

Administrative Expenses: The Plan incurs fees and expenses in connection with its operation. These fees and expenses may include administrative charges and fees. The Plan Sponsor, at its discretion, may charge all or a portion of these fees against the Plan or may pay these fees directly.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes realized and unrealized gains and losses on investments sold or held during the year, net of fund investment expense.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Contributions: Employee contributions are recorded in the period in which they are withheld.

Benefit Payments: Benefits are recorded when paid.

Notes Receivables from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Subsequent Events: The Plan has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued and has determined that no events or transactions require recognition or disclosure in these financial statements.

NOTE 3. PLAN TERMINATION

Although the Plan Sponsor has not expressed an intention to terminate the Plan agreement, it may do so at any time. Upon termination of the Plan, participants' shares in the Plan would become fully vested and distributed to them.

NOTE 4. FEDERAL INCOME TAXES

The Plan Sponsor has adopted a Volume Submitter Plan effective on January 1, 2010. The Volume Submitter Plan received a favorable opinion letter from the Internal Revenue Service (IRS) dated November 30, 2020, which stated that it was designed in accordance with applicable sections of the IRC. The Plan has been amended since the date of the opinion letter. The Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

The Plan's policy is to recognize tax positions in the financial statements when it is more-likely-than-not the position will be sustained upon examination by the tax authorities. As of December 31, 2024, the Plan had no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. As of December 31, 2024, the Plan's annual tax filings for the prior three (3) years are open for audit by the IRS.

NOTE 5. CERTIFIED FINANCIAL INFORMATION

Information on the Plan's investment assets as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, was obtained by management and agreed to or derived from information certified by John Hancock Life Insurance Company (U.S.A.), the custodian of the Plan. The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to the investment assets is complete and accurate. Accordingly, as permitted by Section 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedule.

NOTE 6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are based on the unit values of pooled separate accounts managed by John Hancock Life Insurance Company (U.S.A.). John Hancock Life Insurance Company (U.S.A.) holds the investments of the Plan. These transactions qualify as party-in-interest transactions.

NOTE 7. TRANSFER OF ASSETS

During the year ended January 31, 2022, the Plan Sponsor terminated a qualified defined benefit plan. In connection with the termination and settlement of related obligations, remaining assets from the qualified defined benefit plan of approximately \$170,000 were transferred to the Plan. During the year ended December 31, 2024, approximately \$34,000 was used to reduce Plan Sponsor Safe Harbor Matching Contributions.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. The Plan's exposure to credit loss in the event of nonperformance of investments is limited to the carrying value of such investments. The Plan's provisions as well as those of ERISA and the participants' investment preferences dictate the Plan's concentrations of credit risk and market risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE 9. FAIR VALUE MEASUREMENTS

Fair value is determined based on assumptions that a market participant would use in pricing an asset or liability. Measurements of fair value are classified within a hierarchy based upon valuation inputs that gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The three (3) levels of the fair value hierarchy are as follows:

- *Level 1:* Valuations based on unadjusted quoted prices for identical assets or liabilities in active markets. Pooled Separate Accounts (PSA) are valued at the Net Asset Value (NAV) of shares held by the Plan at year-end. The NAV of PSA is based on the readily available market value of its underlying investments, which are principally mutual funds.
- *Level 2:* Valuations based on quoted prices in markets that are not active or quoted prices for similar assets or liabilities in active market or for which all significant inputs are observable, either directly or indirectly, or inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- *Level 3:* Valuations based on inputs that are unobservable in the market and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Furthermore, while the Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments are classified as level 1 for the years ended December 31, 2024 and 2023, respectively.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Wilshire Country Club 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to Section 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with Section 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) at December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Wilshire Country Club 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan was effective January 1, 2010.

General: The Plan is a defined contribution plan established by Wilshire Country Club (Plan Sponsor or Club) and allows eligible employees the opportunity to participate in the salary deferral, matching, and profit-sharing components of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: To be eligible for the salary deferral portion of the Plan, employees must be 21 years of age and must have completed six (6) months of service. To be eligible for the discretionary Plan Sponsor matching contribution, employees must have attained age 21 and completed the required amount of service. Additionally, employees who have attained age 21, completed 12 months of service during the Plan year, and are employed on the last day of the Plan year are eligible for discretionary Plan Sponsor profit sharing contributions.

Contributions: The Plan allows participants to defer 1% to 75% of their salary, as defined by the Plan, in lieu of receiving such amounts as compensation. For the year ended December 31, 2024, the maximum compensation deferral was \$23,000. For participants aged 50 and older, an additional catch-up of \$7,500 was allowed for the year ended December 31, 2024.

Effective January 1, 2023, the Plan adopted a Safe Harbor Matching Contribution provision in which the Plan Sponsor matches 100% on participant salary deferrals up to 4% of compensation.

For the profit-sharing component of the Plan, the contribution by the Plan Sponsor is discretionary, but is not to exceed the maximum amount allowable for Federal income tax purposes.

Investment Elections: Each participant may direct that salary deferrals, matching, and profit-sharing contributions be invested in one or more of the available investment options.

Participant Accounts: Each participant's account is credited or charged with the participant's contributions, Plan Sponsor discretionary contributions, an allocation of earnings or losses from the participant's self-directed investments, and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested account balance. Receivables are secured by the vested balance in the participant's account, and bear interest at the prime rate of interest plus 1%. Principal and interest are paid ratably through recurring payroll deductions. Terms must not exceed five (5) years, unless used for the purchase of a primary residence where the term cannot exceed ten (10) years.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of their account is based on years of service. Each participant's account vests as follows:

Years of Service	Vested Percentage
Less than 2 years	0%
2 but less than 3 years	20
3 but less than 4 years	40
4 but less than 5 years	60
5 but less than 6 years	80
6 or more years	100

Notwithstanding the above, if a participant (1) attains the age of 65, (2) dies, or (3) terminates employment by reason of permanent disability, the Plan Sponsor's discretionary contributions become 100% vested without regard to years of service.

Forfeitures: Upon termination of employment, participants forfeit non-vested balances. Non-vested balances are available to be used to reduce Plan Sponsor contributions or pay Plan-related expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$35,000 and \$15,000, respectively. During the year ended December 31, 2024, no forfeiture balances were used to pay Plan expenses or reduce Plan Sponsor contributions.

Payment of Benefits: Upon retirement, death, disability or other termination of employment, a participant or the beneficiary is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in his or her own account.

In-service distributions are allowed upon either attaining age 59-1/2, or experiencing financial hardship as defined by the Internal Revenue Code (IRC). Such withdrawals are subject to applicable excise and income taxes and may only be made with the approval of the Plan Administrator.

Management of Trust Fund: A member of the Club and an employee of the Club function as trustees of the Plan subject to guidelines established by the trust agreement. The trustees are responsible for the investment and administration of the retirement fund in accordance with the trust agreement. The trustees receive no compensation from the Plan.

Administrative Expenses: The Plan incurs fees and expenses in connection with its operation. These fees and expenses may include administrative charges and fees. The Plan Sponsor, at its discretion, may charge all or a portion of these fees against the Plan or may pay these fees directly.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes realized and unrealized gains and losses on investments sold or held during the year, net of fund investment expense.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Contributions: Employee contributions are recorded in the period in which they are withheld.

Benefit Payments: Benefits are recorded when paid.

Notes Receivables from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Subsequent Events: The Plan has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued and has determined that no events or transactions require recognition or disclosure in these financial statements.

NOTE 3. PLAN TERMINATION

Although the Plan Sponsor has not expressed an intention to terminate the Plan agreement, it may do so at any time. Upon termination of the Plan, participants' shares in the Plan would become fully vested and distributed to them.

NOTE 4. FEDERAL INCOME TAXES

The Plan Sponsor has adopted a Volume Submitter Plan effective on January 1, 2010. The Volume Submitter Plan received a favorable opinion letter from the Internal Revenue Service (IRS) dated November 30, 2020, which stated that it was designed in accordance with applicable sections of the IRC. The Plan has been amended since the date of the opinion letter. The Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

The Plan's policy is to recognize tax positions in the financial statements when it is more-likely-than-not the position will be sustained upon examination by the tax authorities. As of December 31, 2024, the Plan had no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. As of December 31, 2024, the Plan's annual tax filings for the prior three (3) years are open for audit by the IRS.

NOTE 5. CERTIFIED FINANCIAL INFORMATION

Information on the Plan's investment assets as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, was obtained by management and agreed to or derived from information certified by John Hancock Life Insurance Company (U.S.A.), the custodian of the Plan. The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to the investment assets is complete and accurate. Accordingly, as permitted by Section 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and ERISA-required supplemental schedule.

NOTE 6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are based on the unit values of pooled separate accounts managed by John Hancock Life Insurance Company (U.S.A.). John Hancock Life Insurance Company (U.S.A.) holds the investments of the Plan. These transactions qualify as party-in-interest transactions.

NOTE 7. TRANSFER OF ASSETS

During the year ended January 31, 2022, the Plan Sponsor terminated a qualified defined benefit plan. In connection with the termination and settlement of related obligations, remaining assets from the qualified defined benefit plan of approximately \$170,000 were transferred to the Plan. During the year ended December 31, 2024, approximately \$34,000 was used to reduce Plan Sponsor Safe Harbor Matching Contributions.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. The Plan's exposure to credit loss in the event of nonperformance of investments is limited to the carrying value of such investments. The Plan's provisions as well as those of ERISA and the participants' investment preferences dictate the Plan's concentrations of credit risk and market risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE 9. FAIR VALUE MEASUREMENTS

Fair value is determined based on assumptions that a market participant would use in pricing an asset or liability. Measurements of fair value are classified within a hierarchy based upon valuation inputs that gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The three (3) levels of the fair value hierarchy are as follows:

- *Level 1:* Valuations based on unadjusted quoted prices for identical assets or liabilities in active markets. Pooled Separate Accounts (PSA) are valued at the Net Asset Value (NAV) of shares held by the Plan at year-end. The NAV of PSA is based on the readily available market value of its underlying investments, which are principally mutual funds.
- *Level 2:* Valuations based on quoted prices in markets that are not active or quoted prices for similar assets or liabilities in active market or for which all significant inputs are observable, either directly or indirectly, or inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- *Level 3:* Valuations based on inputs that are unobservable in the market and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 9. FAIR VALUE MEASUREMENTS (Continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments are classified as level 1 for the years ended December 31, 2024 and 2023, respectively.
