INDEPENDENT AUDITOR'S REPORT

To the Trustees of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Jasper Ventures 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). NOTE 1 - DESCRIPTION OF PLAN

The following description of the Jasper Ventures 401(k) Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

GENERAL

Jasper Ventures, Inc. established the Jasper Ventures 401(k) Plan ("Plan") effective January 1, 2007, and restated effective January 1, 2023. The Plan is a defined contribution plan covering eligible employees of Jasper Ventures, Inc. and related entities: Veritas Gas Processing, LP; Vulcan Field Construction, LP; Vanguard Processing Solutions, LP; and Viking Dew Point Conditioning, LP (a controlled group herein referred to collectively as "The Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Jasper Ventures, Inc. is the Plan Sponsor.

The Plan was amended, effective January 1, 2024, to add Engineering, Procurement & Construction, Inc, a related party, as an affiliated service group member under the Plan.

ELIGIBILITY

For purposes of participant elective deferral contributions and employer contributions, participants may enter the Plan on the first day of the calendar month coincident with or next following the date the participant is hired and is eighteen years or older.

CONTRIBUTIONS

A participant may elect to defer a percentage of their eligible compensation, as defined by the Plan, on a pre-tax or after-tax basis, or a combination thereof, subject to certain maximum limitations imposed by the Internal Revenue Code. Participants that reach age 50 before the close of the Plan year are eligible to make catch-up contributions. Participants may also make eligible rollover contributions. Participants direct the investments of their contributions and employer contributions into various options offered by the Plan.

For the year ended December 31, 2024, the Company contributed matching contributions of 100% of the first 4% of eligible compensation contributed by participants, which qualifies these contributions under the current safe harbor matching provisions. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

The Company, at its sole discretion, has the option of providing additional matching contributions. In addition, the Company may make discretionary profit sharing contributions. The discretionary contribution for the Plan year, if any, is allocated to eligible participants on a pro rata share of their compensation compared to the total compensation of all eligible participants. For the year ended December 31, 2024, there were no discretionary matching or profit sharing contributions.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and an allocation of (1) safe harbor contributions, (2) the Company's additional matching and discretionary profit sharing contributions, and (3) plan earnings and expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES RECEIVABLE FROM PARTICIPANTS

New participant loans are not permitted by the Plan. As the Plan permits rollovers and/or plan-to-plan transfers, the Plan Administrator may accept rollovers and/or plan-to-plan transfers of loans into the Plan.

NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

VESTING

Participants are immediately vested in their voluntary contributions, safe harbor contributions, and rollover contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based upon years of continuous service as follows:

Full vesting also occurs at retirement, disability, death, or plan termination.

FORFEITED ACCOUNTS

Under the provisions of the Plan, a participant who terminates employment before becoming vested in the employer's contributions forfeits these amounts. The Plan has unallocated forfeitures held as non-interest-bearing cash of \$892 and \$3,210 as of December 31, 2024 and 2023, respectively. Forfeitures may be used to pay administrative fees or reduce employer contributions. During the year ended December 31, 2024, the Plan received \$16,872 in new forfeitures and earnings and used \$19,190 to reduce employer contributions and pay plan expenses.

PAYMENT OF BENEFITS

On termination of service due to death, disability, normal retirement age, and other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, or substantially equal installments. Hardship and in-service distributions are permitted to be made only from accounts that are fully vested. Participants can elect to receive their distributions either in cash or as a direct rollover to another tax-qualified plan.

PLAN ADMINISTRATION

The management board of the Plan Sponsor appoints the Plan Administrator and Plan Trustees. The Plan Administrator is an employee of the Plan Sponsor. Certain administrative duties, such as Form 5500 preparation and compliance testing, were performed by Pension Planning Consultants, Inc. as the third-party administrator.

HARDSHIP WITHDRAWALS

Hardship withdrawals are allowed under the Plan if a participant meets certain required criteria.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with U.S. GAAP.

ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

NON-INTEREST-BEARING CASH

The Plan accounts for non-interest-bearing cash separate on the statements of net assets available for benefits for funds not invested directly in pooled separate accounts or other investment offerings of the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded when paid. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net investment appreciation (depreciation) in the fair value of investments.

NOTE 3 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") *Accounting Standards Codification* ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund: Valued at the daily closing price as quoted by the financial institution.

Pooled separate accounts: The fair value of pooled separate accounts is valued at net asset value ("NAV") of shares held by the Plan at year end. Units of pooled separate accounts are valued at NAV daily using available quoted market prices as published by John Hancock Life Insurance Company on their website. The NAV serves as a practical expedient to estimate fair value. The redemption frequency and notice periods of each of these pooled separate accounts is daily, and there are no redemption restrictions on unfunded commitments.

NOTE 5 - PLAN TERMINATION

The Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

As a result of a reduction of the Plan Sponsor's workforce, the Plan experienced a partial plan termination during 2024. Under ERISA, a partial plan termination may occur if a significant percentage of the Plan participants are terminated because of an action taken by the Plan Sponsor. If a partial plan termination occurs, full vesting in the employer's contribution is required for the affected participants, but the remaining participants' vesting continues to be determined per the plan provisions. As a result, all affected employees who were participants in the Plan were fully vested in their account balances at the date of their partial plan termination.

NOTE 6 - PARTIES-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employers, participants, and certain others. Plan assets consist of cash and investments managed by John Hancock, the Custodian of the Plan, which qualify as exempt party-in-interest transactions.

NOTE 7 - TAX STATUS

The Plan has adopted a prototype plan which received a favorable tax determination letter from the IRS that qualifies under Section 401(a) of the Internal Revenue Code ("IRC") and is, therefore, not subject to tax under present income tax law. Although the Plan has been amended since receiving the determination letter, the Plan Sponsor and tax counsel believes that the Plan continues to qualify and operate in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the notes to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 11, 2025, the date the financial statements were available to be issued.
