## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of  
the Day & Zimmermann Group, Inc.

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Day & Zimmermann Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Day & Zimmermann Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Day & Zimmermann Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Day & Zimmermann Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### 1. The Plan

The following description of the Day & Zimmermann Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan available to employees, as defined by the Plan document, of Day & Zimmermann Group, Inc. (the “Company”). Generally, covered employees are immediately eligible to participate and enroll in the salary reduction portion of the Plan on the first administratively feasible pay date after the later of their date of hire or attaining 21 years for age. Employees are generally eligible to receive Company matching contributions after six months of service. Special eligibility requirements and participation commencement dates exist for participants employed by American Ordnance LLC (Staff); and SOC LLC (Sandia Union); and certain other employers. Refer to the Plan documents for details on these special eligibility requirements and participant commencement dates. The Plan is subject to the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Plan Merger** – Effective June 1, 2023, the Plan was amended to facilitate the merger of Davis, Pickering & Company, Inc. 401(k) Profit Sharing Plan (the “Davis Pickering Plan”) into the Plan. Beginning June 1, 2023, participants of the Davis Pickering Plan were eligible to make contributions into the Plan. As a result of the merger, assets totaling \$1,566,461 and notes receivable from participants totaling \$35,576 were transferred into the Plan on December 14, 2023.

Effective June 1, 2023, the Plan was amended to facilitate the merger of River Town Electric, LLC 401(k) Profit Sharing Plan (the “River Town Plan”) into the Plan. Beginning June 1, 2023, participants of the River Town Plan were eligible to make contributions into the Plan. As a result of the merger, assets totaling \$28,286 were transferred into the Plan on December 14, 2023.

**Contributions** – The Plan consists of a 401(k) pre-tax and Roth salary reduction feature that allows participants to contribute from 1 percent to 75 percent of eligible compensation, as defined by the Plan, up to the maximum annual deferral allowed by the Internal Revenue Service (“IRS”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions (rollovers) and transfers from other qualified defined benefit or contribution plans or accounts.

Company matching contributions in any Plan year are generally allocated to active participants using a formula which provides a 100 percent match on the first 2 percent of employee contributions and a 45 percent match on employee contributions from in excess of 2 percent to 8 percent of eligible compensation, except as noted below. For employees of the Lone Star and Kansas divisions, the match formula provides for a 100 percent match on the first 2 percent of employee contributions and a 50 percent match on the employee contributions in excess of 2 percent to 8 percent of eligible compensation. For participants employed by the NNSS Union hired on or after January 1, 2011 and not participating in the NNSS Union pension plan, the match formula provides for a 100 percent match on the first 6 percent of contributions. NNSS employees participating in the Staff or Union pension plan and expatriate employees are not eligible for matching contributions. The NNSS Union participants were terminated from the Plan June 19, 2023. For employees of the Hawthorne, American Ordnance, and Milan divisions, the match formula provides for a 100 percent match on the first 2 percent of employee contributions and a percentage match designated by the Company (not to exceed 50 percent) on employee contributions in excess of 2 percent to 8 percent of eligible compensation. Refer to the Plan documents for additional match schedules.

QNEC'S, QMAC's or prevailing wage contributions of \$96,375 and \$-0- were made to the Plan for the years ended December 31, 2024 and 2023, respectively, net of forfeitures applied of \$82,550 and \$-0- as of December 31, 2024 and 2023, respectively.

Participants direct the investment of their contributions into the various investment options offered by the Plan.

The employer matching contributions are subject to limitations established by the Internal Revenue Code ("IRC") and the provisions of the Plan. Participants may also contribute amounts representing distributions from other qualified defined contribution plans sponsored by the participants' previous employer and Roth rollover accounts. Matching contributions for the years ended December 31, 2024 and 2023 were \$10,267,440 and \$9,925,783, respectively, net of forfeitures applied.

Matching contributions, QNEC's and QMAC's for any plan year will be made no later than the last date on which amounts may be deducted by the Company for federal income tax purposes. Prevailing wage contributions will be made as frequently as required by law.

**Participant Accounts** – Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions, allocations of the Company's contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and Plan losses. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting and Forfeitures** – Participants are immediately vested in their salary deferral and rollover contributions and employer QNEC's, QMAC's and prevailing wage contributions, plus earnings thereon. Generally, employer matching and profit sharing contributions vest gradually over a five-year period depending on the participating employer. Participants should refer to the Plan documents for their specific employer and or collective bargaining agreement vesting schedule.

Forfeited balances of terminated participants' non-vested accounts may be used to reduce Employer contributions to the Plan and to pay any administrative expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$266,081 and \$2,756, respectively. For the years ended December 31, 2024 and 2023, forfeitures of \$637,486 and \$598,700, respectively, were used to reduce employer matching contributions. During the years ended December 31, 2024 and 2023, forfeitures of \$-0- were used to pay administrative expenses.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loans are repayable over a maximum period of five years unless the loan is used for the purchase of a principal residence, in which case a maximum ten-year repayment plan is permitted. The loans are secured by the balance in the participant's account and bear interest at a rate that is commensurate with the local prevailing rates as determined by the plan sponsor at the date the loans were issued. Principal and interest are paid ratably through bi-weekly payroll deductions.

**Payment of Benefits** – Upon termination of service, retirement, death, or total permanent disability, a participant may elect to receive a lump-sum distribution of his or her entire accumulated plan balance, subject to the terms and certain limitations of the funding vehicles. In addition, participants may elect in-service withdrawals after reaching age 59-1/2. Participants are also permitted to make hardship withdrawals in certain cases of immediate and heavy financial need. Rollover account balances may be withdrawn at any time. Minimum required distributions for participants who have reached the applicable age 72 also apply per IRS regulations. Terminated participants with a vested account balance equal to or less than \$1,000 shall be paid in a single sum as soon as administratively feasible. Terminated participants with a vested balance greater than \$1,000 and less than or equal to \$5,000 shall be paid within the calendar year following termination. As of January 1, 2024, terminated participants with a vested balance greater than \$1,000 and less than or equal to \$7,000 shall be paid within the calendar year following termination.

**Revenue Sharing** – The Plan had entered into a revenue sharing agreement with The Principal Trust Company (“Principal”) through April 2, 2024. Under the terms of the agreement, the plan will earn revenue credits based upon the Plan’s holdings that Principal shall fund to the Plan. The plan administrator may use amounts held in the revenue sharing credit account to reimburse the Employer for fees and expenses associated with services provided to the Plan, or pay vendors, including Principal or third parties. For the years ended December 31, 2024 and 2023, Principal contributed \$130,100 and \$542,759, respectively, in revenue sharing credits to the Plan. As of April 2, 2024 and December 31, 2023, the balance in the revenue sharing credit account was \$-0- and \$273,814, respectively.

The Plan has entered into a revenue sharing agreement with the Fidelity Management Trust Company (“Fidelity”), the new trustee effective April 2, 2024 (Note 3). Under the terms of the agreement, the participants will earn revenue credits based upon the Participant’s holdings that Fidelity shall fund to the Participant. At December 31, 2024, the balance in the revenue sharing credit account was \$110.

Amounts contributed for revenue sharing are included within administrative expenses on the statements of changes in net assets available for benefits.

## 2. Summary of Significant Accounting Policies

**Basis of Accounting** – The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s governing committee determines the Plan’s valuation policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent loans are reclassified as distributions based upon the terms in the Plan document.

**Payment of Benefits** – Benefits are recorded when paid.

**Administrative Expenses** – Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### 3. Information Certified by the Trustee

On April 2, 2024, assets of the plan, amounting to \$456,131,672 were transferred from Principal who held the Plan's investment assets and executed investment transactions as of December 31, 2023 and for the period January 1, 2024 to April 1, 2024, to a new trustee, Fidelity, who held the Plan's investment assets and executed transactions from April 2, 2024 to December 31, 2024.

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal and Fidelity, qualified institutions.

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the framework are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed actively traded.

*Common Collective Trust Funds:* The units of the common collective trust funds are valued using the NAV as a practical expedient to estimate fair value as determined by the issuer based on the fair value of the underlying assets within the fund and the present value of future cash flows using the current discount rate.

*Self-Directed Brokerage Account:* Valued at the quoted market prices of the underlying investments, which include mutual funds and common stock. Due to the short-term highly liquid nature of cash and cash equivalents, the carrying amount approximates fair value. Any gains and/or earnings by the underlying assets are paid out as interest.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Plan Termination

Although it has not expressed any intention to do so, the plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

### 6. Tax Status

The Plan obtained its latest determination letter on April 7, 2014, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the "Code") and, therefore, the related trust is exempt from taxation. In December 2016, the IRS began publishing a Required Amendments List for individually designed plans which specifies changes in qualification requirements. The list is published annually and requires plans to be amended for each item on the list, as applicable, to its tax-exempt status. The plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Code and Plan document and, therefore, the Plan continues to be qualified and the related trust tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 8. Related-Party and Party in Interest Transactions

Certain Plan investments are managed by trustee of the Plan, for which fees are charged by the trustee or affiliated entities for record keeping and other services. Legal, accounting, investment advisory and certain other fees are paid to other service providers. Therefore, these transactions qualify as party in interest transactions. The Plan also has revenue sharing agreement with trustee (Note 1), and holds notes receivable from participants, which qualify as related-party and party in interest transactions. These transactions qualify as related-party and party in interest transactions which are exempt from the prohibited transaction rules of ERISA.

### 9. Transfers To and From Affiliated Plans

Certain participants, who change their employee status, are permitted to transfer assets to and from other plans sponsored by the Company. During 2024 participants transferred in \$144,187 and \$(1,703) out to other plans, for a net transfer of \$142,484. During 2023 participants transferred in \$3,848,097 and \$(1,973,843) out to other plans, for a net transfer of \$1,874,254.
